RESOLUTION

Providing for consideration of the bill (H.R. 6) to reduce our Nation's dependency on foreign oil by investing in clean, renewable, and alternative energy resources, promoting new emerging energy technologies, developing greater efficiency, and creating a Strategic Energy Efficiency and Renewables Reserve to invest in alternative energy, and for other purposes.

- 1 *Resolved*, That upon the adoption of this resolution
- 2 it shall be in order to consider in the House the bill (H.R.

1 6) to reduce our Nation's dependency on foreign oil by
2 investing in clean, renewable, and alternative energy re-
3 sources, promoting new emerging energy technologies, de-
4 veloping greater efficiency, and creating a Strategic En-
5 ergy Efficiency and Renewables Reserve to invest in alter-
6 native energy, and for other purposes. All points of order
7 against the bill and against its consideration are waived
8 except those arising under clauses 9 or 10 of rule XXI.
9 The bill shall be considered as read. The previous question
10 shall be considered as ordered on the bill to final passage
11 without intervening motion except: (1) three hours of de-
12 bate, with 60 minutes equally divided and controlled by
13 the chairman and ranking minority member of the Com-
14 mittee on Ways and Means, 60 minutes equally divided
15 and controlled by the chairman and ranking minority
16 member of the Committee on Natural Resources, 30 min-
17 utes equally divided and controlled by the chairman and
18 ranking minority member of the Committee on Agri-
19 culture, and 30 minutes equally divided and controlled by
20 the chairman and ranking minority member of the Com-
21 mittee on Science and Technology; and (2) one motion to
22 recommit.

23 SEC. 2. During consideration of H.R. 6 pursuant to
24 this resolution, notwithstanding the operation of the pre-

1 vious question, the Chair may postpone further consider-
2 ation of the bill to a time designated by the Speaker.
