## A BILL

To designate the new Federal Courthouse, located in the 700 block of East Broad Street, Richmond, Virginia, as the “Spottswood W. Robinson III and Robert R. Merhige, Jr. Federal Courthouse”.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SPOTTSWOOD W. ROBINSON III AND ROBERT R.**

4 **MERHIGE, JR. FEDERAL COURTHOUSE.**

5 (a) DESIGNATION.—The new Federal Courthouse, lo-  
6 cated in the 700 block of East Broad Street, Richmond,

1 Virginia, shall be known and designated as the  
2 “Spottswood W. Robinson III and Robert R. Merhige, Jr.  
3 Federal Courthouse”.

4 (b) REFERENCES.—Any reference in a law, map, reg-  
5 ulation, document, paper, or other record of the United  
6 States to the Federal Courthouse referred to in subsection  
7 (a) shall be deemed to be a reference to the “Spottswood  
8 W. Robinson III and Robert R. Merhige, Jr. Federal  
9 Courthouse”.

10 **SECTION 1. DESIGNATION.**

11 *The United States courthouse located in the 700 block*  
12 *of East Broad Street, Richmond, Virginia, shall be known*  
13 *and designated as the “Spottswood W. Robinson III and*  
14 *Robert R. Merhige, Jr., United States Courthouse”.*

15 **SEC. 2. REFERENCES.**

16 *Any reference in a law, map, regulation, document,*  
17 *paper, or other record of the United States to the United*  
18 *States courthouse referred to in section 1 shall be deemed*  
19 *to be a reference to the “Spottswood W. Robinson III and*  
20 *Robert R. Merhige, Jr., United States Courthouse”.*

Amend the title so as to read: “A bill to designate the United States courthouse located in the 700 block of East Broad Street, Richmond, Virginia, as the ‘Spottswood W. Robinson III and Robert R. Merhige, Jr., United States Courthouse’.”.
