- 3 SEC. 101. WILD SKY WILDERNESS.
- 4 (a) Additions to the National Wilderness
- 5 Preservation System.—
- 6 (1) Additions.—The following Federal lands
- 7 in the State of Washington are hereby designated as
- 8 wilderness and, therefore, as components of the Na-
- 9 tional Wilderness Preservation System: certain lands
- which comprise approximately 106,000 acres, as
- generally depicted on a map entitled "Wild Sky Wil-

derness Proposal" and dated February 6, 2007, which shall be known as the "Wild Sky Wilderness".

as practicable after the date of enactment of this Act, the Secretary of Agriculture shall file a map and a legal description for the wilderness area designated under this section with the Committee on Energy and Natural Resources of the Senate and the Committee on Natural Resources of the House of Representatives. The map and description shall have the same force and effect as if included in this section, except that the Secretary of Agriculture may correct clerical and typographical errors in the legal description and map. The map and legal description shall be on file and available for public inspection in the office of the Chief of the Forest Service, Department of Agriculture.

(b) Administration Provisions.—

(1) In General.—

(A) Subject to valid existing rights, lands designated as wilderness by this section shall be managed by the Secretary of Agriculture in accordance with the Wilderness Act (16 U.S.C. 1131 et seq.) and this section, except that, with respect to any wilderness areas designated by

1	this section, any reference in the Wilderness
2	Act to the effective date of the Wilderness Act
3	shall be deemed to be a reference to the date
4	of enactment of this Act.
5	(B) To fulfill the purposes of this section
6	and the Wilderness Act and to achieve adminis-
7	trative efficiencies, the Secretary of Agriculture
8	may manage the area designated by this section
9	as a comprehensive part of the larger complex
10	of adjacent and nearby wilderness areas.
11	(2) New Trails.—
12	(A) The Secretary of Agriculture shall con-
13	sult with interested parties and shall establish
14	a trail plan for Forest Service lands in order to
15	develop—
16	(i) a system of hiking and equestrian
17	trails within the wilderness designated by
18	this section in a manner consistent with
19	the Wilderness Act (16 U.S.C. 1131 et
20	seq.); and
21	(ii) a system of trails adjacent to or to
22	provide access to the wilderness designated
23	by this section.
24	(B) Within 2 years after the date of enact-
25	ment of this Act, the Secretary of Agriculture

1 shall complete a report on the implementation 2 of the trail plan required under this section. 3 This report shall include the identification of

priority trails for development.

5 (3) Repeater site.—Within the Wild Sky 6 Wilderness, the Secretary of Agriculture is author-7 ized to use helicopter access to construct and main-8 tain a joint Forest Service and Snohomish County 9 telecommunications repeater site, in compliance with 10 a Forest Service approved communications site plan, 11 for the purposes of improving communications for 12

safety, health, and emergency services.

- (4) FLOAT PLANE ACCESS.—As provided by section 4(d)(1) of the Wilderness Act (16 U.S.C. 1133(d)(1)), the use of floatplanes on Lake Isabel, where such use has already become established, shall be permitted to continue subject to such reasonable restrictions as the Secretary of Agriculture determines to be desirable.
- (5) Evergreen mountain lookout.—The designation under this section shall not preclude the operation and maintenance of the existing Evergreen Mountain Lookout in the same manner and degree in which the operation and maintenance of such

 - (c) AUTHORIZATION FOR LAND ACQUISITION.—

- (1) In General.—The Secretary of Agriculture 5 is authorized to acquire lands and interests therein, 6 by purchase, donation, or exchange, and shall give 7 priority consideration to those lands identified as 8 "Priority Acquisition Lands" on the map described 9 in subsection (a)(1). The boundaries of the Mt. 10 Baker-Snoqualmie National Forest and the Wild 11 Sky Wilderness shall be adjusted to encompass any 12 lands acquired pursuant to this section.
 - (2) Access.—Consistent with section 5(a) of the Wilderness Act (16 U.S.C. 1134(a)), the Secretary of Agriculture shall ensure adequate access to private inholdings within the Wild Sky Wilderness.
 - (3) APPRAISAL.—Valuation of private lands shall be determined without reference to any restrictions on access or use which arise out of designation as a wilderness area as a result of this section.
- 21 (d) Land Exchanges.—The Secretary of Agri-22 culture shall exchange lands and interests in lands, as gen-23 erally depicted on a map entitled "Chelan County Public 24 Utility District Exchange" and dated May 22, 2002, with

- 1 the Chelan County Public Utility District in accordance2 with the following provisions:
- (1) If the Chelan County Public Utility District,
 within 90 days after the date of enactment of this
 Act, offers to the Secretary of Agriculture approximately 371.8 acres within the Mt. Baker-Snoqualmie
 National Forest in the State of Washington, the
 Secretary shall accept such lands.
 - (2) Upon acceptance of title by the Secretary of Agriculture to such lands and interests therein, the Secretary of Agriculture shall convey to the Chelan County Public Utility District a permanent easement, including helicopter access, consistent with such levels as used as of the date of enactment of this Act, to maintain an existing telemetry site to monitor snow pack on 1.82 acres on the Wenatchee National Forest in the State of Washington.
 - (3) The exchange directed by this section shall be consummated if Chelan County Public Utility District conveys title acceptable to the Secretary and provided there is no hazardous material on the site, which is objectionable to the Secretary.
 - (4) In the event Chelan County Public Utility
 District determines there is no longer a need to
 maintain a telemetry site to monitor the snow pack

- 1 for calculating expected runoff into the Lake Chelan
- 2 hydroelectric project and the hydroelectric projects
- 3 in the Columbia River Basin, the Secretary shall be
- 4 notified in writing and the easement shall be extin-
- 5 guished and all rights conveyed by this exchange
- 6 shall revert to the United States.
- 7 SEC. 102. DESIGNATION OF NATIONAL RECREATIONAL
- 8 TRAIL, WILLAMETTE NATIONAL FOREST, OR-
- 9 EGON, IN HONOR OF JIM WEAVER, A FORMER
- 10 MEMBER OF THE HOUSE OF REPRESENTA-
- 11 TIVES.
- 12 (a) Designation.—Forest Service trail number
- 13 3590 in the Willamette National Forest in Lane County,
- 14 Oregon, which is a 19.6 mile trail that begins and ends
- 15 at North Waldo Campground and circumnavigates Waldo
- 16 Lake, is hereby designated as a national recreation trail
- 17 under section 4 of the National Trails System Act (16)
- 18 U.S.C. 1243) and shall be known as the "Jim Weaver
- 19 Loop Trail".
- 20 (b) Interpretive Sign.—Using funds available for
- 21 the Forest Service, the Secretary of Agriculture shall pre-
- 22 pare, install, and maintain an appropriate sign at the
- 23 trailhead of the Jim Weaver Loop Trail to indicate the
- 24 name of the trail and to provide information regarding the
- 25 life and career of Congressman Jim Weaver.

PIEDRAS BLANCAS HISTORIC LIGHT STATION. 5 (a) Definitions.—In this section: 6 (1) Light Station.—The term "Light Sta-7 tion" means Piedras Blancas Light Station. (2) Outstanding natural area.—The term 8 "Outstanding Natural Area" means the Piedras 9 10 Blancas Historic Light Station Outstanding Natural 11 Area established pursuant to subsection (c). 12 (3) Public Lands.—The term "public lands" 13 has the meaning stated in section 103(e) of the Fed-14 eral Land Policy and Management Act of 1976 (43 15 U.S.C. 1703(e)). (4) Secretary.—The term "Secretary" means 16 17 the Secretary of the Interior. 18 (b) FINDINGS.—Congress finds as follows: 19 (1) The publicly owned Piedras Blancas Light 20 Station has nationally recognized historical struc-21 tures that should be preserved for present and fu-22 ture generations. 23 (2) The coastline adjacent to the Light Station 24 is internationally recognized as having significant

wildlife and marine habitat that provides critical in-

- formation to research institutions throughout the world.
- 3 (3) The Light Station tells an important story 4 about California's coastal prehistory and history in 5 the context of the surrounding region and commu-6 nities.
 - (4) The coastal area surrounding the Light Station was traditionally used by Indian people, including the Chumash and Salinan Indian tribes.
 - (5) The Light Station is historically associated with the nearby world-famous Hearst Castle (Hearst San Simeon State Historical Monument), now administered by the State of California.
 - (6) The Light Station represents a model partnership where future management can be successfully accomplished among the Federal Government, the State of California, San Luis Obispo County, local communities, and private groups.
 - (7) Piedras Blancas Historic Light Station Outstanding Natural Area would make a significant addition to the National Landscape Conservation System administered by the Department of the Interior's Bureau of Land Management.
- (8) Statutory protection is needed for the Light
 Station and its surrounding Federal lands to ensure

- 2 natural heritage and to be a source of inspiration for
- 3 the people of the United States.

- 4 (c) Designation of the Piedras Blancas His-
- 5 TORIC LIGHT STATION OUTSTANDING NATURAL AREA.—

(1) In General.—In order to protect, con-

- 7 serve, and enhance for the benefit and enjoyment of
- 8 present and future generations the unique and na-
- 9 tionally important historical, natural, cultural, sci-
- entific, educational, scenic, and recreational values
- of certain lands in and around the Piedras Blancas
- 12 Light Station, in San Luis Obispo County, Cali-
- fornia, while allowing certain recreational and re-
- search activities to continue, there is established,
- subject to valid existing rights, the Piedras Blancas
- 16 Historic Light Station Outstanding Natural Area.
- 17 (2) Maps and legal descriptions.—The
- boundaries of the Outstanding Natural Area as
- those shown on the map entitled "Piedras Blancas"
- 20 Historic Light Station: Outstanding Natural Area",
- dated May 5, 2004, which shall be on file and avail-
- able for public inspection in the Office of the Direc-
- tor, Bureau of Land Management, United States
- Department of the Interior, and the State office of

- the Bureau of Land Management in the State of
 California.
 - (3) Basis of Management.—The Secretary shall manage the Outstanding Natural Area as part of the National Landscape Conservation System to protect the resources of the area, and shall allow only those uses that further the purposes for the establishment of the Outstanding Natural Area, the Federal Land Policy and Management Act of 1976 (43 U.S.C. 1701 et seq.), and other applicable laws.
 - (4) WITHDRAWAL.—Subject to valid existing rights, and in accordance with the existing withdrawal as set forth in Public Land Order 7501 (Oct. 12, 2001, Vol. 66, No. 198, Federal Register 52149), the Federal lands and interests in lands included within the Outstanding Natural Area are hereby withdrawn from—
 - (A) all forms of entry, appropriation, or disposal under the public land laws;
 - (B) location, entry, and patent under the public land mining laws; and
 - (C) operation of the mineral leasing and geothermal leasing laws and the mineral materials laws.

- 1 (d) Management of the Piedras Blancas His-2 Toric Light Station Outstanding Natural Area.—
- (1) IN GENERAL.—The Secretary shall manage the Outstanding Natural Area in a manner that con-serves, protects, and enhances the unique and na-tionally important historical, natural, cultural, sci-entific, educational, scenic, and recreational values of that area, including an emphasis on preserving and restoring the Light Station facilities, consistent with the requirements of subsection (c)(3).
 - (2) USES.—Subject to valid existing rights, the Secretary shall only allow such uses of the Outstanding Natural Area as the Secretary finds are likely to further the purposes for which the Outstanding Natural Area is established as set forth in subsection (c)(1).
 - (3) Management plan.—Not later than 3 years after of the date of enactment of this Act, the Secretary shall complete a comprehensive management plan consistent with the requirements of section 202 of the Federal Land Policy and Management Act of 1976 (43 U.S.C. 1712) to provide long-term management guidance for the public lands within the Outstanding Natural Area and fulfill the purposes for which it is established, as set forth in

1	subsection $(c)(1)$. The management plan shall be de-
2	veloped in consultation with appropriate Federal,
3	State, and local government agencies, with full pub-
4	lic participation, and the contents shall include—
5	(A) provisions designed to ensure the pro-
6	tection of the resources and values described in
7	subsection (e)(1);
8	(B) objectives to restore the historic Light
9	Station and ancillary buildings;
10	(C) an implementation plan for a con-
11	tinuing program of interpretation and public
12	education about the Light Station and its im-
13	portance to the surrounding community;
14	(D) a proposal for minimal administrative
15	and public facilities to be developed or improved
16	at a level compatible with achieving the re-
17	sources objectives for the Outstanding Natural
18	Area as described in paragraph (1) and with
19	other proposed management activities to accom-
20	modate visitors and researchers to the Out-
21	standing Natural Area; and
22	(E) cultural resources management strate-
23	gies for the Outstanding Natural Area, pre-
24	pared in consultation with appropriate depart-
25	ments of the State of California, with emphasis

on the preservation of the resources of the Outstanding Natural Area and the interpretive, education, and long-term scientific uses of the resources, giving priority to the enforcement of the Archaeological Resources Protection Act of 1979 (16 U.S.C. 470aa et seq.) and the National Historic Preservation Act (16 U.S.C. 470 et seq.) within the Outstanding Natural Area.

- (4) Cooperative agreements.—In order to better implement the management plan and to continue the successful partnerships with the local communities and the Hearst San Simeon State Historical Monument, administered by the California Department of Parks and Recreation, the Secretary may enter into cooperative agreements with the appropriate Federal, State, and local agencies pursuant to section 307(b) of the Federal Land Management Policy and Management Act of 1976 (43 U.S.C. 1737(b)).
- (5) RESEARCH ACTIVITIES.—In order to continue the successful partnership with research organizations and agencies and to assist in the development and implementation of the management plan, the Secretary may authorize within the Outstanding Natural Area appropriate research activities for the

1	purposes identified in subsection $(c)(1)$ and pursuant
2	to section 307(a) of the Federal Land Policy and
3	Management Act of 1976 (43 U.S.C. 1737(a)).
4	(6) Acquisition.—State and privately held
5	lands or interests in lands adjacent to the Out-
6	standing Natural Area and identified as appropriate
7	for acquisition in the management plan may be ac-
8	quired by the Secretary as part of the Outstanding
9	Natural Area only by—
10	(A) donation;
11	(B) exchange with a willing party; or
12	(C) purchase from a willing seller.
13	(7) Additions to the outstanding nat-
14	URAL AREA.—Any lands or interest in lands adja-
15	cent to the Outstanding Natural Area acquired by
16	the United States after the date of enactment of this
17	Act shall be added to and administered as part of
18	the Outstanding Natural Area.
19	(8) Overflights.—Nothing in this section or
20	the management plan shall be construed to—
21	(A) restrict or preclude overflights, includ-
22	ing low level overflights, military, commercial
23	and general aviation overflights that can be
24	seen or heard within the Outstanding Natural
25	Area;

- 1 (B) restrict or preclude the designation or 2 creation of new units of special use airspace or 3 the establishment of military flight training 4 routes over the Outstanding Natural Area; or
 - (C) modify regulations governing low-level overflights above the adjacent Monterey Bay National Marine Sanctuary.
 - (9) Law enforcement activities.—Nothing in this section shall be construed to preclude or otherwise affect coastal border security operations or other law enforcement activities by the Coast Guard or other agencies within the Department of Homeland Security, the Department of Justice, or any other Federal, State, and local law enforcement agencies within the Outstanding Natural Area.
 - (10) Native american uses and interests.—In recognition of the past use of the Outstanding Natural Area by Indians and Indian tribes for traditional cultural and religious purposes, the Secretary shall ensure access to the Outstanding Natural Area by Indians and Indian tribes for such traditional cultural and religious purposes. In implementing this subsection, the Secretary, upon the request of an Indian tribe or Indian religious community, shall temporarily close to the general public use

- 1 of one or more specific portions of the Outstanding

 - (3) In 1923, the City of St. Louis voted to spend \$6,000,000 to purchase a memorial plaza and building dedicated to citizens of St. Louis who lost their lives in World War I.
 - (4) The purchase of the 7 block site exhausted the funds and no money remained to construct a monument.
- 14 (5) In 1933, Mayor Bernard F. Dickmann appealed to citizens and the city government to raise \$1,000,000 to construct a memorial building and general improvement of the plaza area and the construction of Soldiers' Memorial began on October 21, 1935.
- 20 (6) On October 14, 1936, President Franklin
 21 D. Roosevelt officially dedicated the site.
- 22 (7) On Memorial Day in 1938, Mayor 23 Dickmann opened the building to the public.
- 24 (b) STUDY.—The Secretary of the Interior shall carry 25 out a study to determine the suitability and feasibility of

21	SEC. 331. COMMEMORATIVE WORK TO HONOR BRIGADIER
22	GENERAL FRANCIS MARION AND HIS FAMILY.
23	(a) FINDINGS.—The Congress finds the following:
24	(1) Francis Marion was born in 1732 in St.
25	John's Parish, Berkeley County, South Carolina, He

- 1 married Mary Esther Videau on April 20th, 1786.
- 2 Francis and Mary Esther Marion had no children,
- 3 but raised a son of a relative as their own, and gave
- 4 the child Francis Marion's name.

- (2) Brigadier General Marion commanded the Williamsburg Militia Revolutionary force in South Carolina and was instrumental in delaying the advance of British forces by leading his troops in disrupting supply lines.
 - (3) Brigadier General Marion's tactics, which were unheard of in rules of warfare at the time, included lightning raids on British convoys, after which he and his forces would retreat into the swamps to avoid capture. British Lieutenant Colonel Tarleton stated that "as for this damned old swamp fox, the devil himself could not catch him". Thus, the legend of the "Swamp Fox" was born.
 - (4) His victory at the Battle of Eutaw Springs in September of 1781 was officially recognized by Congress.
 - (5) Brigadier General Marion's troops are believed to be the first racially integrated force fighting for the United States, as his band was a mix of Whites, Blacks, both free and slave, and Native Americans
- 25 Americans.

- 1 (6) As a statesman, he represented his parish 2 in the South Carolina senate as well as his State at 3 the Constitutional Convention.
 - (7) Although the Congress has authorized the establishment of commemorative works on Federal lands in the District of Columbia honoring such celebrated Americans as George Washington, Thomas Jefferson, and Abraham Lincoln, the National Capital has no comparable memorial to Brigadier General Francis Marion for his bravery and leadership during the Revolutionary War, without which the United States would not exist.
 - (8) Brigadier General Marion's legacy must live on. Since 1878, United States Reservation 18 has been officially referred to as Marion Park. Located between 4th and 6th Streets, S.E., at the intersection of E Street and South Carolina Avenue, S.E., in Washington, DC, the park lacks a formal commemoration to this South Carolina hero who was important to the initiation of the Nation's heritage.
 - (9) The time has come to correct this oversight so that future generations of Americans will know and understand the preeminent historical and lasting significance to the Nation of Brigadier General

- 1 Marion's contributions. Such a South Carolina hero
- 2 deserves to be given the proper recognition.
- 3 (b) Authority To Establish Commemorative
- 4 Work.—The Marion Park Project, a committee of the
- 5 Palmetto Conservation Foundation, may establish a com-
- 6 memorative work on Federal land in the District of Co-
- 7 lumbia and its environs to honor Brigadier General
- 8 Francis Marion and his service.
- 9 (c) Compliance With Standards for Commemo-
- 10 RATIVE WORKS.—The commemorative work authorized by
- 11 subsection (b) shall be established in accordance with
- 12 chapter 89 of title 40, United States Code (commonly
- 13 known as the "Commemorative Works Act").
- 14 (d) Use of Federal Funds Prohibited.—Fed-
- 15 eral funds may not be used to pay any expense of the es-
- 16 tablishment of the commemorative work authorized by
- 17 subsection (b). The Marion Park Project, a committee of
- 18 the Palmetto Conservation Foundation, shall be solely re-
- 19 sponsible for acceptance of contributions for, and payment
- 20 of the expenses of, the establishment of that commemora-
- 21 tive work.
- 22 (e) Deposit of Excess Funds.—If, upon payment
- 23 of all expenses of the establishment of the commemorative
- 24 work authorized by subsection (b) (including the mainte-

- (2) Fundraising plan.—The Commission shall develop a fundraising plan for supporting the creation and maintenance of the Museum through contributions by the American people, and a separate plan on fundraising by the American Latino community.
- (3) Report on issues.—The Commission shall examine (in consultation with the Secretary of the Smithsonian Institution), and submit a report to the President and the Congress on, the following issues:

1	(A) The availability and cost of collections
2	to be acquired and housed in the Museum.
3	(B) The impact of the Museum on regional
4	Hispanic- and Latino-related museums.
5	(C) Possible locations for the Museum in
6	Washington, DC and its environs, to be consid-

9	Fine Arts, the Department of the Interior and
10	Smithsonian Institution.
11	(D) Whether the Museum should be lo-

(c) Administrative Provisions.—

(1) Facilities and support of department of the Interior shall provide from funds appropriated for this purpose administrative services, facilities, and funds necessary for the performance of the Commission's

- functions. These funds shall be made available prior
 to any meetings of the Commission.
- 2 (2) Compensation.—Each member of the Commission who is not an officer or employee of the Federal Government may receive compensation for each day on which the member is engaged in the work of the Commission, at a daily rate to be determined by the Secretary of the Interior.
 - (3) Travel expenses.—Each member shall be entitled to travel expenses, including per diem in lieu of subsistence, in accordance with applicable provisions under subchapter I of chapter 57 of title 5, United States Code.

24	ments in American history and culture, including

1	Native American, Colonial American, European
2	American, and African American heritage;
3	(5) to enhance a cooperative management
4	framework to assist State, local, and Tribal govern-
5	ments, the private sector, and citizens residing in
6	the National Heritage Area in conserving, sup-
7	porting, enhancing, and interpreting the significant
8	historic, cultural, and recreational sites in the Na-
9	tional Heritage Area;
10	(6) to conserve and interpret the history of the
11	development of hydroelectric power in the United
12	States and its role in developing the American econ-
13	omy; and
14	(7) to provide appropriate linkages among units
15	of the National Park System within and surrounding
16	the National Heritage Area, to protect, enhance, and
17	interpret resources outside of park boundaries.
18	SEC. 422. DEFINITIONS.
19	In this subtitle:
20	(1) Commission.—The term "Commission"
21	means the Niagara Falls National Heritage Area
22	Commission established under this subtitle.
23	(2) GOVERNOR.—The term "Governor" means
24	the Governor of the State of New York.

1	(3) Local coordinating entity.—The term

17	SEC. 423. DESIGNATION OF THE NIAGARA FALLS NATIONAL
18	HERITAGE AREA.
19	(a) Establishment.—There is hereby established
20	the Niagara Falls National Heritage Area.
21	(b) Boundaries.—
22	(1) In General.—The National Heritage Area
23	shall consist of the area from the western boundary

 - (5) recommend policies and strategies for resource management, including the development of intergovernmental and interagency agreements to protect, enhance, interpret, fund, manage, and develop the natural, historical, cultural, educational, scenic, and recreational resources of the National Heritage Area;

1	(6) describe a program for implementation for
2	the management plan, including—
3	(A) performance goals;
4	(B) plans for resource protection, enhance-
5	ment, interpretation, funding, management, and
6	development; and
7	(C) specific commitments for implementa-
8	tion that have been made by the local coordi-

- velopment strategies described in the management plan, if implemented, would adequately protect, enhance, interpret, fund, manage, and develop the natural, historic, cultural, educational, scenic, and recreational resources of the National Heritage Area;
 - (D) the management plan would not adversely affect any activities authorized on Federal land under public land laws or land use plans;
 - (E) the local coordinating entity has demonstrated the financial capability, in partnership with others, to carry out the plan;
 - (F) the Secretary has received adequate assurances from the appropriate State, Tribal, and local officials whose support is needed to ensure the effective implementation of the State, Tribal, and local elements of the management plan; and
 - (G) the management plan demonstrates partnerships among the local coordinating entity, Federal, State, Tribal, and local governments, regional planning organizations, non-profit organizations, or private sector parties for implementation of the management plan.

1	(4) Disapproval.—
2	(A) In General.—If the Secretary dis-
3	approves the management plan, the Secretary—

20	(6) 1 member shall be appointed by the Sec-
21	retary, after consideration of the recommendation of
22	the Tuscarora Nation;
23	(7) 1 member shall be appointed by the Sec-
24	retary, after consideration of the recommendation of
25	the Seneca Nation of Indians: and

1	(8) 6 members shall be individuals who have an
2	interest in, support for, and expertise appropriate to
3	tourism, regional planning, history and historic pres-
4	ervation, cultural or natural resource management,
5	conservation, recreation, and education, or museum
6	services, of whom—
7	(A) 4 members shall be appointed by the
8	Secretary, after consideration of the rec-
9	ommendation of the 2 members of the Senate
10	from the State; and
11	(B) 2 members shall be appointed by the
12	Secretary, after consideration of the rec-
13	ommendation of the Member of the House of
14	Representatives whose district encompasses the
15	National Heritage Area.
16	(c) Terms; Vacancies.—
17	(1) Term.—A member of the Commission shall
18	be appointed for a term not to exceed 5 years.
19	(2) Vacancies.—
20	(A) Partial Term.—A member appointed
21	to fill a vacancy on the Commission shall serve
22	for the remainder of the term for which the
23	predecessor of the member was appointed

1	(B) IN GENERAL.—A vacancy on the Com-
2	mission shall be filled in the same manner as
3	the original appointment was made.
4	(d) Chairperson and Vice Chairperson.—
5	(1) Selection.—The Commission shall select
6	a Chairperson and Vice Chairperson from among the
7	members of the Commission.
8	(2) VICE CHAIRPERSON.—The Vice Chairperson
9	shall serve as the Chairperson in the absence of the
10	Chairperson.
11	(e) Quorum.—
12	(1) In general.—A majority of the members
13	of the Commission shall constitute a quorum.
14	(2) Transaction.—For the transaction of any
15	business or the exercise of any power of the Com-
16	mission, the Commission shall have the power to act
17	by a majority vote of the members present at any
18	meeting at which a quorum is in attendance.
19	(f) Meetings.—
20	(1) In General.—The Commission shall meet
21	at least quarterly at the call of—
22	(A) the Chairperson; or
23	(B) a majority of the members of the Com-

1	(2) Notice—Notice of Commission meetings
2	and agendas for the meetings shall be published in
3	local newspapers that are distributed throughout the

5	(3) Applicable law.—Meetings of the Com-

8	(g) Authorities of the Commission.—In addition
9	to the authorities otherwise granted in this subtitle, the

14	the Commission to assist in carrying out the duties

18	of the State, on a reimbursable or nonreimbursable

22	(3) seek, accept, and dispose of gifts, bequests,

3	(4) to recognize and interpret the distinctive
4	role the region played in shaping the man who would
5	become the 16th President of the United States, and
6	how Abraham Lincoln's life left its traces in the sto-
7	ries, folklore, buildings, streetscapes, and landscapes
8	of the region;
9	(5) to provide a cooperative management frame-
10	work to foster a close working relationship with all
11	levels of government, the private sector, and the
12	local communities in the region in identifying, pre-
13	serving, interpreting, and developing the historical,
14	cultural, scenic, and natural resources of the region
15	for the educational and inspirational benefit of cur-
16	rent and future generations; and
17	(6) to provide appropriate linkages between
18	units of the National Park System and communities,
19	governments, and organizations within the Heritage
20	Area.
21	SEC. 442. DEFINITIONS.
22	In this subtitle:
23	(1) Local coordinating entity.—The term
24	"local coordinating entity" means the Looking for

1	Lincoln Heritage Coalition, which is hereby des-
2	ignated by Congress—
3	(A) to develop, in partnership with others,

 - (4) include an inventory of the natural, historical, cultural, educational, scenic, and recreational resources of the National Heritage Area related to the national importance and themes of the National Heritage Area that should be protected, enhanced, interpreted, managed, funded, and developed;
 - (5) recommend policies and strategies for resource management, including the development of intergovernmental and interagency agreements to

"(2) Transition period beginning on the transition program effective date and ending on December 31, 2013, except as provided in subsections (b) and (d), during which the Secretary of Homeland Security, in consultation with the Secretary of State, the Attorney General, the Secretary of Labor, and the Secretary of the Interior, shall establish, administer, and enforce a transition program to regulate immigration to the Commonwealth, as provided in this section (hereafter referred to as the 'transition program').

1	"(3) Delay of commencement of transi-
2	TION PERIOD.—
3	"(A) IN GENERAL.—The Secretary of
4	Homeland Security, in the Secretary's sole dis-
5	cretion, in consultation with the Secretary of

retary of Homeland Security, the Secretary of State, the Secretary of Labor, and the Secretary of the Interior shall negotiate and implement agreements among their agencies to identify and assign their respective duties so as to ensure timely and proper implementation of the provisions of this section. The agreements should address, at a minimum, procedures to ensure that Commonwealth employers have access to adequate labor, and that tourists, students, retirees, and other visitors have access to the Commonwealth without unnecessary delay or impediment. The agreements may also allocate funding between the respective agencies tasked with various responsibilities under this section.

"(6) CERTAIN EDUCATION FUNDING.—In addition to fees charged pursuant to section 286(m) of the Immigration and Nationality Act (8 U.S.C. 1356(m)) to recover the full costs of providing adjudication services, the Secretary of Homeland Security shall charge an annual supplemental fee of \$150 per nonimmigrant worker to each prospective employer who is issued a permit under subsection (d)

"(7) ASYLUM.—Section 208 of the Immigration and Nationality Act (8 U.S.C. 1158) shall not apply during the transition period to persons physically present in the Commonwealth or arriving in the Commonwealth (whether or not at a designated port of arrival), including persons brought to the Commonwealth after having been interdicted in international or United States waters

14 national or United States waters. 15 "(b) Numerical Limitations for Nonimmigrant Workers.—An alien, if otherwise qualified, may seek ad-16 mission to Guam or to the Commonwealth during the 18 transition program as a nonimmigrant worker under section 101(a)(15)(H) of the Immigration and Nationality 19 Act (8 U.S.C. 1101(a)(15)(H)) without counting against 21 the numerical limitations set forth in section 214(g) of 22 such Act (8 U.S.C. 1184(g)). In adopting and enforcing this system, the Secretary shall also consider, in good faith and not later than 30 days after receipt by the Secretary, any comments and advice submitted by the Governor of the Commonwealth. This system shall provide for a reduction in the allocation of permits for such workers on an annual basis, to zero, during a period not to extend beyond December 31, 2013, unless extended pursuant to paragraph 5 of this subsection, and shall take into account the number of petitions granted under subsection (i). In no event shall a permit be valid beyond the expiration of the transition period. This system may be based on any reasonable method and criteria determined by the Secretary of Homeland Security to promote the maximum use of, and to

prevent adverse effects on wages and working conditions of, workers authorized to be employed in the United States, including lawfully admissible freely associated state citizen labor. No alien shall be granted nonimmigrant classification or a visa under this subsection unless the permit requirements established under this paragraph have been met.

"(3) The Secretary of Homeland Security shall set the conditions for admission of such an alien under the transition program, and the Secretary of State shall authorize the issuance of nonimmigrant visas for such an alien. Such a visa shall not be valid for admission to the United States, as defined in section 101(a)(38) of the Immigration and Nationality Act (8 U.S.C. 1101(a)(38)), except admission to the Commonwealth. An alien admitted to the Commonwealth on the basis of such a visa shall be permitted to engage in employment only as authorized pursuant to the transition program.

"(4) Such an alien shall be permitted to transfer between employers in the Commonwealth during the period of such alien's authorized stay therein, without permission of the employee's current or prior employer, within the alien's occupational category or another occupational category the Secretary

of Homeland Security has found requires alien workers to supplement the resident workforce.

> "(5)(A) Not later than 180 days prior to the expiration of the transition period, or any extension thereof, the Secretary of Labor, in consultation with the Secretary of Homeland Security, the Secretary of the Interior, and the Governor of the Commonwealth, shall ascertain the current and anticipated labor needs of the Commonwealth and determine whether an extension of up to 5 years of the provisions of this subsection is necessary to ensure an adequate number of workers will be available for legitimate businesses in the Commonwealth. For the purpose of this subparagraph, a business shall not be considered legitimate if it engages directly or indirectly in prostitution, trafficking in minors, or any other activity that is illegal under Federal or local law. The determinations of whether a business is legitimate and to what extent, if any, it may require alien workers to supplement the resident workforce, shall be made by the Secretary of Homeland Security, in the Secretary's sole discretion.

> "(B) If the Secretary of Labor determines that such an extension is necessary to ensure an adequate number of workers for legitimate businesses in

10	efits, and living standards of existing workers
11	within those industries and other industries au-
12	thorized to employ alien workers; and
13	"(viii) the prior use, if any, of alien work-
14	ers to fill those industry jobs, and whether the
15	industry requires alien workers to fill those
16	jobs.
17	"(6) The Secretary of Homeland Security may
18	authorize the admission of a spouse or minor child
19	accompanying or following to join a worker admitted
20	pursuant to this subsection.
21	"(e) Persons Lawfully Admitted Under the
22	COMMONWEALTH IMMIGRATION LAW.—
23	"(1) Prohibition on Removal.—
24	"(A) In general.—Subject to subpara-
25	graph (B), no alien who is lawfully present in

1	the Commonwealth pursuant to the immigration

 - "(A) of expiration of the alien's employment authorization under the immigration laws of the Commonwealth; or
 - "(B) that is 2 years after the transition program effective date.

 - "(5) Prior orders of removal.—The Secretary of Homeland Security may execute any administratively final order of exclusion, deportation or removal issued under authority of the immigration laws of the United States before, on, or after the transition period effective date, or under authority of the immigration laws of the Commonwealth before the transition period effective date, upon any subject of such order found in the Commonwealth on or after the transition period effective date, regardless

- 1 whether the alien has previously been removed from
- 2 the United States or the Commonwealth pursuant to
- 3 such order.
- 4 "(f) Effect on Other Laws.—The provisions of
- 5 this section and of the immigration laws, as defined in
- 6 section 101(a)(17) of the Immigration and Nationality Act

- 8 effective date, supersede and replace all laws, provisions,

- 13 212(a)(9)(B) of the Immigration and Nationality
- 14 Act.—No time that an alien is present in the Common-

- 16 monwealth shall be counted for purposes of inadmissibility
- 17 under section 212(a)(9)(B) of the Immigration and Na-
- 18 tionality Act (8 U.S.C. 1182(a)(9)(B)).
- 19 "(h) Report on Nonresident Guestworker
- 20 Population.—The Secretary of the Interior, in consulta-
- 21 tion with the Secretary of Homeland Security, and the
- 22 Governor of the Commonwealth, shall report to the Con-
- 23 gress not later than 2 years after the date of enactment
- 24 of the National Forests, Parks, Public Land, and Rec-

"(5) Suspension.—The Secretary of Homeland Security shall monitor the admission of non-immigrant visitors to Guam and the Commonwealth of the Northern Mariana Islands under this sub-

- 18 (1) IN GENERAL.—The Secretary of the Inte-

- agency Agreements required to be negotiated under
- section 6(a)(4) of the Joint Resolution entitled "A

The report by the President shall include an estimate for the numbers of nonimmigrant workers described under section 101(a)(15)(H) of the Immigration and Nationality Act (8 U.S.C. 1101(a)(15)(H)) necessary to avoid adverse economic effects in Guam and the Commonwealth.
 - (3) GAO REPORT.—The Government Accountability Office shall submit a report to the Congress

- not later than 2 years after the date of enactment of this Act, to include, at a minimum, the following items:
 - (A) An assessment of the implementation of this subtitle and the amendments made by this subtitle, including an assessment of the performance of Federal agencies and the Government of the Commonwealth in meeting congressional intent.
 - (B) An assessment of the short-term and long-term impacts of implementation of this subtitle and the amendments made by this subtitle on the economy of the Commonwealth, including its ability to obtain workers to supplement its resident workforce and to maintain access to its tourists and customers, and any effect on compliance with United States treaty obligations mandating non-refoulement for refugees.
 - (C) An assessment of the economic benefit of the investors "grandfathered" under subsection (c) of section 6 of the Joint Resolution entitled "A Joint Resolution to approve the 'Covenant To Establish a Commonwealth of the Northern Mariana Islands in Political Union

- with the United States of America', and for other purposes', approved March 24, 1976

 (Public Law 94–241), as added by subsection (a), and the Commonwealth's ability to attract new investors after the date of enactment of this Act.
 - (D) An assessment of the number of illegal aliens in the Commonwealth, including any Federal and Commonwealth efforts to locate and repatriate them.
 - (4) Reports by the Local Government.—
 The Governor of the Commonwealth may submit an annual report to the President on the implementation of this subtitle, and the amendments made by this subtitle, with recommendations for future changes. The President shall forward the Governor's report to the Congress with any Administration comment after an appropriate period of time for internal review, provided that nothing in this paragraph shall be construed to require the President to provide any legislative recommendation to the Congress.
 - (5) REPORT ON FEDERAL PERSONNEL AND RE-SOURCE REQUIREMENTS.—Not later than 180 days after the date of enactment of this Act, the Secretary of Homeland Security, after consulting with

- 14 furbishment of the vessel as is needed before the vessel
- 15 joins the naval forces of the recipient performed at a ship-
- 16 yard located in the United States, including a United
- 17 States Navy shipyard.
- 18 (f) Expiration of Authority.—The authority to
- 19 transfer a vessel under this section shall expire at the end
- 20 of the 2-year period beginning on the date of enactment
- 21 of this Act.
