A BILL

To designate the Federal building and United States courthouse located at McKinley Avenue and Third Street, SW., Canton, Ohio, as the “Ralph Regula Federal Office Building and Courthouse”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. RALPH REGULA FEDERAL OFFICE BUILDING**
 2 **AND COURTHOUSE.**

3 (a) **DESIGNATION.**—The Administrator of General
 4 Services shall ensure that the federally occupied building
 5 located at McKinley Avenue and Third Street, SW., Can-
 6 ton, Ohio, is known and designated as the “Ralph Regula
 7 Federal Office Building and Courthouse”.

8 (b) **REFERENCES.**—During the period in which the
 9 building referred to in subsection (a) is federally occupied,
 10 any reference in a law, map, regulation, document, paper,
 11 or other record of the United States to that building shall
 12 be deemed to be a reference to the “Ralph Regula Federal
 13 Office Building and Courthouse”.

14 **SECTION 1. RALPH REGULA FEDERAL BUILDING AND**
 15 **UNITED STATES COURTHOUSE.**

16 (a) *DESIGNATION.*—The Administrator of General
 17 Services shall ensure that the federally occupied building
 18 located at McKinley Avenue and Third Street, SW., Can-
 19 ton, Ohio, is known and designated as the “Ralph Regula
 20 Federal Building and United States Courthouse”.

21 (b) *REFERENCES.*—With respect to the period in which
 22 the building referred to in subsection (a) is federally occu-
 23 pied, any reference in a law, map, regulation, document,
 24 paper, or other record of the United States to that building
 25 shall be deemed to be a reference to the “Ralph Regula Fed-
 26 eral Building and United States Courthouse”.

Amend the title so as to read: “A bill to designate the federally occupied building located at McKinley Avenue and Third Street, SW., Canton, Ohio, as the ‘Ralph Regula Federal Building and United States Courthouse’.”.
