AN ACT

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2010, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 ~~That the following sums are appropriated, out of any~~
4 ~~money in the Treasury not otherwise appropriated, for the~~
5 ~~Legislative Branch for the fiscal year ending September~~
6 ~~30, 2010, and for other purposes, namely:~~

7 TITLE I—LEGISLATIVE BRANCH

8 HOUSE OF REPRESENTATIVES

9 SALARIES AND EXPENSES

10 For salaries and expenses of the House of Represent-
11 atives, \$1,375,200,000, as follows:

1 HOUSE LEADERSHIP OFFICES

2 For salaries and expenses, as authorized by law,
3 \$25,881,000, including: Office of the Speaker,
4 \$5,077,000, including \$25,000 for official expenses of the
5 Speaker; Office of the Majority Floor Leader, \$2,530,000,
6 including \$10,000 for official expenses of the Majority
7 Leader; Office of the Minority Floor Leader, \$4,565,000,
8 including \$10,000 for official expenses of the Minority
9 Leader; Office of the Majority Whip, including the Chief
10 Deputy Majority Whip, \$2,194,000, including \$5,000 for
11 official expenses of the Majority Whip; Office of the Mi-
12 nority Whip, including the Chief Deputy Minority Whip,
13 \$1,690,000, including \$5,000 for official expenses of the
14 Minority Whip; Speaker's Office for Legislative Floor Ac-
15 tivities, \$517,000; Republican Steering Committee,
16 \$981,000; Republican Conference, \$1,748,000; Repub-
17 lican Policy Committee, \$362,000; Democratic Steering
18 and Policy Committee, \$1,366,000; Democratic Caucus,
19 \$1,725,000; nine minority employees, \$1,552,000; train-
20 ing and program development—majority, \$290,000; train-
21 ing and program development—minority, \$290,000;
22 Cloakroom Personnel—majority, \$497,000; and Cloak-
23 room Personnel—minority, \$497,000.

1 MEMBERS' REPRESENTATIONAL ALLOWANCES
2 INCLUDING MEMBERS' CLERK HIRE, OFFICIAL
3 EXPENSES OF MEMBERS, AND OFFICIAL MAIL

4 For Members' representational allowances, including
5 Members' clerk hire, official expenses, and official mail,
6 \$660,000,000.

7 COMMITTEE EMPLOYEES

8 STANDING COMMITTEES, SPECIAL AND SELECT

9 For salaries and expenses of standing committees,
10 special and select, authorized by House resolutions,
11 \$139,878,000: *Provided*, That such amount shall remain
12 available for such salaries and expenses until December
13 31, 2010, except that \$1,000,000 of such amount shall
14 remain available until expended for committee room up-
15 grading.

16 COMMITTEE ON APPROPRIATIONS

17 For salaries and expenses of the Committee on Ap-
18 propriations, \$31,300,000, including studies and examina-
19 tions of executive agencies and temporary personal serv-
20 ices for such committee, to be expended in accordance with
21 section 202(b) of the Legislative Reorganization Act of
22 1946 and to be available for reimbursement to agencies
23 for services performed: *Provided*, That such amount shall
24 remain available for such salaries and expenses until De-
25 cember 31, 2010.

1 SALARIES, OFFICERS AND EMPLOYEES

2 For compensation and expenses of officers and em-
3 ployees, as authorized by law, \$200,301,000, including:
4 for salaries and expenses of the Office of the Clerk, includ-
5 ing not more than \$23,000, of which not more than
6 \$20,000 is for the Family Room, for official representa-
7 tion and reception expenses, \$32,089,000 of which
8 \$4,600,000 shall remain available until expended; for sala-
9 ries and expenses of the Office of the Sergeant at Arms,
10 including the position of Superintendent of Garages, and
11 including not more than \$3,000 for official representation
12 and reception expenses, \$9,509,000; for salaries and ex-
13 penses of the Office of the Chief Administrative Officer
14 including not more than \$3,000 for official representation
15 and reception expenses, \$130,782,000, of which
16 \$3,937,000 shall remain available until expended; for sala-
17 ries and expenses of the Office of the Inspector General,
18 \$5,045,000; for salaries and expenses of the Office of
19 Emergency Planning, Preparedness and Operations,
20 \$4,445,000, to remain available until expended; for sala-
21 ries and expenses of the Office of General Counsel,
22 \$1,415,000; for the Office of the Chaplain, \$179,000; for
23 salaries and expenses of the Office of the Parliamentarian,
24 including the Parliamentarian, \$2,000 for preparing the
25 Digest of Rules, and not more than \$1,000 for official rep-

1 representation and reception expenses, \$2,060,000; for sala-
2 ries and expenses of the Office of the Law Revision Coun-
3 sel of the House, \$3,258,000; for salaries and expenses
4 of the Office of the Legislative Counsel of the House,
5 \$8,814,000; for salaries and expenses of the Office of
6 Interparliamentary Affairs, \$859,000; for other author-
7 ized employees, \$1,249,000; and for salaries and expenses
8 of the Office of the Historian, including the cost of the
9 House Fellows Program (including lodging and related ex-
10 penses for visiting Program participants), \$597,000.

11 ALLOWANCES AND EXPENSES

12 For allowances and expenses as authorized by House
13 resolution or law, \$317,840,000, including: supplies, mate-
14 rials, administrative costs and Federal tort claims,
15 \$3,948,000; official mail for committees, leadership of-
16 fices, and administrative offices of the House, \$201,000;
17 Government contributions for health, retirement, Social
18 Security, and other applicable employee benefits,
19 \$278,278,000, including employee tuition assistance ben-
20 efit payments, \$3,500,000, if authorized, and employee
21 child care benefit payments, \$1,000,000, if authorized;
22 Business Continuity and Disaster Recovery, \$27,698,000,
23 of which \$9,000,000 shall remain available until expended;
24 transition activities for new members and staff,
25 \$2,907,000; Wounded Warrior Program, \$2,500,000, to

1 be derived from funding provided for this purpose in Divi-
2 sion G of Public Law 111–8; Office of Congressional Eth-
3 ics, \$1,548,000; Energy Demonstration Projects,
4 \$2,500,000, if authorized, to remain available until ex-
5 pended; and miscellaneous items including purchase, ex-
6 change, maintenance, repair and operation of House
7 motor vehicles, interparliamentary receptions, and gratu-
8 ities to heirs of deceased employees of the House,
9 \$760,000.

10 CHILD CARE CENTER

11 For salaries and expenses of the House of Represent-
12 atives Child Care Center, such amounts as are deposited
13 in the account established by section 312(d)(1) of the Leg-
14 islative Branch Appropriations Act, 1992 (2 U.S.C. 2062),
15 subject to the level specified in the budget of the Center,
16 as submitted to the Committee on Appropriations of the
17 House of Representatives.

18 ADMINISTRATIVE PROVISIONS

19 SEC. 101. (a) REQUIRING AMOUNTS REMAINING IN
20 MEMBERS' REPRESENTATIONAL ALLOWANCES TO BE
21 USED FOR DEFICIT REDUCTION OR TO REDUCE THE
22 FEDERAL DEBT.—Notwithstanding any other provision of
23 law, any amounts appropriated under this Act for
24 “HOUSE OF REPRESENTATIVES—SALARIES AND
25 EXPENSES—MEMBERS' REPRESENTATIONAL ALLOW-

1 ANCES” shall be available only for fiscal year 2010. Any
2 amount remaining after all payments are made under such
3 allowances for fiscal year 2010 shall be deposited in the
4 Treasury and used for deficit reduction (or, if there is no
5 Federal budget deficit after all such payments have been
6 made, for reducing the Federal debt, in such manner as
7 the Secretary of the Treasury considers appropriate).

8 (b) REGULATIONS.—The Committee on House Ad-
9 ministration of the House of Representatives shall have
10 authority to prescribe regulations to carry out this section.

11 (c) DEFINITION.—As used in this section, the term
12 “Member of the House of Representatives” means a Rep-
13 resentative in, or a Delegate or Resident Commissioner
14 to, the Congress.

15 SEC. 102. Effective with respect to fiscal year 2010
16 and each succeeding fiscal year, the aggregate amount
17 otherwise authorized to be appropriated for a fiscal year
18 for the lump-sum allowance for each of the following of-
19 fices is increased as follows:

20 (1) The allowance for the office of the Majority
21 Whip is increased by \$96,000.

22 (2) The allowance for the office of the Minority
23 Whip is increased by \$96,000.

24 JOINT ITEMS

25 For Joint Committees, as follows:

1 JOINT ECONOMIC COMMITTEE

2 For salaries and expenses of the Joint Economic
3 Committee, \$4,814,000, to be disbursed by the Secretary
4 of the Senate.

5 JOINT COMMITTEE ON TAXATION

6 For salaries and expenses of the Joint Committee on
7 Taxation, \$11,451,000, to be disbursed by the Chief Ad-
8 ministrative Officer of the House of Representatives.

9 For other joint items, as follows:

10 OFFICE OF THE ATTENDING PHYSICIAN

11 For medical supplies, equipment, and contingent ex-
12 penses of the emergency rooms, and for the Attending
13 Physician and his assistants, including: (1) an allowance
14 of \$2,175 per month to the Attending Physician; (2) an
15 allowance of \$1,300 per month to the Senior Medical Offi-
16 cer; (3) an allowance of \$725 per month each to three
17 medical officers while on duty in the Office of the Attend-
18 ing Physician; (4) an allowance of \$725 per month to two
19 assistants and \$580 per month each not to exceed 11 as-
20 sistants on the basis heretofore provided for such assist-
21 ants; and (5) \$2,366,000 for reimbursement to the De-
22 partment of the Navy for expenses incurred for staff and
23 equipment assigned to the Office of the Attending Physi-
24 cian, which shall be advanced and credited to the applica-
25 ble appropriation or appropriations from which such sala-

1 ries, allowances, and other expenses are payable and shall
2 be available for all the purposes thereof, \$3,805,000, to
3 be disbursed by the Chief Administrative Officer of the
4 House of Representatives.

5 OFFICE OF CONGRESSIONAL ACCESSIBILITY SERVICES
6 SALARIES AND EXPENSES

7 For salaries and expenses of the Office of Congres-
8 sional Accessibility Services, \$1,314,000, to be disbursed
9 by the Secretary of the Senate.

10 STATEMENTS OF APPROPRIATIONS

11 For the preparation, under the direction of the Com-
12 mittees on Appropriations of the Senate and the House
13 of Representatives, of the statements for the first session
14 of the 111th Congress, showing appropriations made, in-
15 definite appropriations, and contracts authorized, together
16 with a chronological history of the regular appropriations
17 bills as required by law, \$30,000, to be paid to the persons
18 designated by the chairmen of such committees to super-
19 vise the work.

20 CAPITOL POLICE

21 SALARIES

22 For salaries of employees of the Capitol Police, in-
23 cluding overtime, hazardous duty pay differential, and
24 Government contributions for health, retirement, social se-
25 curity, professional liability insurance, and other applica-

1 ble employee benefits, \$263,198,000, to be disbursed by
 2 the Chief of the Capitol Police or his designee.

3 GENERAL EXPENSES

4 For necessary expenses of the Capitol Police, includ-
 5 ing motor vehicles, communications and other equipment,
 6 security equipment and installation, uniforms, weapons,
 7 supplies, materials, training, medical services, forensic
 8 services, stenographic services, personal and professional
 9 services, the employee assistance program, the awards pro-
 10 gram, postage, communication services, travel advances,
 11 relocation of instructor and liaison personnel for the Fed-
 12 eral Law Enforcement Training Center, and not more
 13 than \$5,000 to be expended on the certification of the
 14 Chief of the Capitol Police in connection with official rep-
 15 resentation and reception expenses, \$61,914,000, to be
 16 disbursed by the Chief of the Capitol Police or his des-
 17 ignee: *Provided*, That, notwithstanding any other provi-
 18 sion of law, the cost of basic training for the Capitol Police
 19 at the Federal Law Enforcement Training Center for fis-
 20 cal year 2010 shall be paid by the Secretary of Homeland
 21 Security from funds available to the Department of Home-
 22 land Security.

23 ADMINISTRATIVE PROVISIONS

24 (INCLUDING TRANSFER OF FUNDS)

25 SEC. 1001. TRANSFER AUTHORITY.—Amounts ap-
 26 propriated for fiscal year 2010 for the Capitol Police may

1 be transferred between the headings “SALARIES” and
2 “GENERAL EXPENSES” upon the approval of the Commit-
3 tees on Appropriations of the House of Representatives
4 and the Senate.

5 OFFICE OF COMPLIANCE

6 SALARIES AND EXPENSES

7 For salaries and expenses of the Office of Compli-
8 ance, as authorized by section 305 of the Congressional
9 Accountability Act of 1995 (2 U.S.C. 1385), \$4,335,000,
10 of which \$884,000 shall remain available until September
11 30, 2011: *Provided*, That the Executive Director of the
12 Office of Compliance may, within the limits of available
13 appropriations, dispose of surplus or obsolete personal
14 property by interagency transfer, donation, or discarding:
15 *Provided further*, That not more than \$500 may be ex-
16 pended on the certification of the Executive Director of
17 the Office of Compliance in connection with official rep-
18 resentation and reception expenses.

19 CONGRESSIONAL BUDGET OFFICE

20 SALARIES AND EXPENSES

21 For salaries and expenses necessary for operation of
22 the Congressional Budget Office, including not more than
23 \$6,000 to be expended on the certification of the Director
24 of the Congressional Budget Office in connection with offi-
25 cial representation and reception expenses, \$45,165,000.

1 ADMINISTRATIVE PROVISIONS

2 SEC. 1101.—MODIFICATIONS TO EXECUTIVE EX-
3 CHANGE PROGRAM.—(a) EXPANSION OF NUMBER OF
4 PARTICIPANTS.—Section 1201(b) of the Legislative
5 Branch Appropriations Act, 2008 (2 U.S.C. 611 note) is
6 amended by striking “3” each place it appears and insert-
7 ing “5”.

8 (b) PERMANENT EXTENSION OF PROGRAM.—Section
9 1201 of such Act (2 U.S.C. 611 note) is amended—

10 (1) by striking subsection (d) and redesignating
11 subsection (e) as subsection (d); and

12 (2) in subsection (d), as so redesignated, by
13 striking “Subject to subsection (d), this section” and
14 inserting “This section”.

15 (c) EFFECTIVE DATE.—The amendments made by
16 this section shall take effect as if included in the enact-
17 ment of the Legislative Branch Appropriations Act, 2008.

18 ARCHITECT OF THE CAPITOL

19 GENERAL ADMINISTRATION

20 For salaries for the Architect of the Capitol, and
21 other personal services, at rates of pay provided by law;
22 for surveys and studies in connection with activities under
23 the care of the Architect of the Capitol; for all necessary
24 expenses for the general and administrative support of the
25 operations under the Architect of the Capitol including the

1 Botanic Garden; electrical substations of the Capitol, Sen-
2 ate and House office buildings, and other facilities under
3 the jurisdiction of the Architect of the Capitol; including
4 furnishings and office equipment; including not more than
5 \$5,000 for official reception and representation expenses;
6 to be expended as the Architect of the Capitol may ap-
7 prove; for purchase or exchange, maintenance, and oper-
8 ation of a passenger motor vehicle, \$109,392,000, of
9 which \$8,950,000 shall remain available until September
10 30, 2014.

11 HISTORIC BUILDINGS REVITALIZATION TRUST FUND

12 For a payment to the Historic Buildings Revitaliza-
13 tion Trust Fund established under section 1201,
14 \$60,000,000, to remain available until expended.

15 CAPITOL BUILDING

16 For necessary expenses for the maintenance, care and
17 operation of the Capitol, \$32,800,000, of which
18 \$6,241,000 shall remain available until September 30,
19 2014.

20 CAPITOL GROUNDS

21 For all necessary expenses for care and improvement
22 of grounds surrounding the Capitol, the Senate and House
23 office buildings, and the Capitol Power Plant,
24 \$10,920,000, of which \$1,410,000 shall remain available
25 until September 30, 2014.

1 HOUSE OFFICE BUILDINGS

2 For all necessary expenses for the maintenance, care
3 and operation of the House office buildings,
4 \$100,466,000, of which \$53,360,000 shall remain avail-
5 able until September 30, 2014.

6 CAPITOL POWER PLANT

7 For all necessary expenses for the maintenance, care
8 and operation of the Capitol Power Plant; lighting; heat-
9 ing; power (including the purchase of electrical energy)
10 and water and sewer services for the Capitol, Senate and
11 House office buildings, Library of Congress buildings, and
12 the grounds about the same; Botanic Garden, Senate ga-
13 rage, and air conditioning refrigeration not supplied from
14 plants in any of such buildings; heating the Government
15 Printing Office and Washington City Post Office, and
16 heating and chilled water for air conditioning for the Su-
17 preme Court Building; the Union Station complex, the
18 Thurgood Marshall Federal Judiciary Building and the
19 Folger Shakespeare Library; expenses for which shall be
20 advanced or reimbursed upon request of the Architect of
21 the Capitol and amounts so received shall be deposited
22 into the Treasury to the credit of this appropriation;
23 \$125,083,000, of which \$31,560,000 shall remain avail-
24 able until September 30, 2014: *Provided*, That not more
25 than \$8,000,000 of the funds credited or to be reimbursed

1 to this appropriation as herein provided shall be available
2 for obligation during fiscal year 2010.

3 LIBRARY BUILDINGS AND GROUNDS

4 For all necessary expenses for the mechanical and
5 structural maintenance, care and operation of the Library
6 buildings and grounds, \$41,937,000, of which
7 \$15,750,000 shall remain available until September 30,
8 2014.

9 CAPITOL POLICE BUILDINGS, GROUNDS AND SECURITY

10 For all necessary expenses for the maintenance, care
11 and operation of buildings, grounds and security enhance-
12 ments of the United States Capitol Police, wherever lo-
13 cated, the Alternate Computer Facility, and AOC security
14 operations, \$26,364,000, of which \$7,750,000 shall re-
15 main available until September 30, 2014.

16 BOTANIC GARDEN

17 For all necessary expenses for the maintenance, care
18 and operation of the Botanic Garden and the nurseries,
19 buildings, grounds, and collections; and purchase and ex-
20 change, maintenance, repair, and operation of a passenger
21 motor vehicle; all under the direction of the Joint Com-
22 mittee on the Library, \$11,263,000, of which \$900,000
23 shall remain available until September 30, 2014: *Provided,*
24 That of the amount made available under this heading,
25 the Architect may obligate and expend such sums as may

1 be necessary for the maintenance, care and operation of
2 the National Garden established under section 307E of
3 the Legislative Branch Appropriations Act, 1989 (2
4 U.S.C. 2146), upon vouchers approved by the Architect
5 or a duly authorized designee.

6 CAPITOL VISITOR CENTER

7 For necessary expenses for Capitol Visitor Center op-
8 erations costs, \$23,166,000.

9 ADMINISTRATIVE PROVISIONS

10 SEC. 1201. HISTORIC BUILDINGS REVITALIZATION
11 TRUST FUND.—(a) ESTABLISHMENT.—There is hereby
12 established in the Treasury of the United States, as an
13 account for the Architect of the Capitol, the Historic
14 Buildings Revitalization Trust Fund (hereafter in this sec-
15 tion referred to as the “Fund”).

16 (b) USE OF AMOUNTS.—Amounts in the Fund shall
17 be used by the Architect of the Capitol for the revitaliza-
18 tion of the major historical buildings and assets which the
19 Architect is responsible for maintaining and preserving,
20 except that the Architect may not obligate any amounts
21 in the Fund without the approval of the Committees on
22 Appropriations of the House of Representatives and Sen-
23 ate.

24 (c) EFFECTIVE DATE.—This section shall apply with
25 respect to fiscal year 2010 and each succeeding fiscal year.

1 ~~SEC. 1202.~~ Any individual who is appointed as the
2 Architect of the Capitol after the date of the enactment
3 of this Act shall be appointed in accordance with the appli-
4 cable laws in effect at the time of appointment, taking into
5 account any amendments which may be made to such ap-
6 plicable laws during the One Hundred Eleventh Congress.

7 ~~SEC. 1203. SUPPORT AND MAINTENANCE DURING~~
8 ~~EMERGENCIES.—(a) During an emergency involving the~~
9 ~~safety of human life or the protection of property, as de-~~
10 ~~termined or declared by the Capitol Police Board, the Ar-~~
11 ~~chitect of the Capitol—~~

12 ~~(1) may accept contributions of comfort and~~
13 ~~other incidental items and services to support em-~~
14 ~~ployees of the Office of the Architect of the Capitol~~
15 ~~while such employees are on duty in response to the~~
16 ~~emergency; and~~

17 ~~(2) may incur obligations and make expendi-~~
18 ~~tures out of available appropriations for meals, re-~~
19 ~~freshments, and other support and maintenance for~~
20 ~~the Office of the Architect of the Capitol if, in the~~
21 ~~judgment of the Architect, such obligations and ex-~~
22 ~~penditures are necessary to respond to the emer-~~
23 ~~gency.~~

24 ~~(b) This section shall apply with respect to fiscal year~~
25 ~~2010 and each succeeding fiscal year.~~

1 SEC. 1204. FLEXIBLE AND COMPRESSED WORK
2 SCHEDULES.—(a) Section 6121(1) of title 5, United
3 States Code is amended by inserting after “military de-
4 partment,” the following: “the Architect of the Capitol.”

5 (b) Section 6133(e) of such title is amended by add-
6 ing at the end the following new paragraph:

7 “(3) With respect to employees of the Architect of
8 the Capitol (including employees of the Botanic Garden),
9 the authority granted to the Office of Personnel Manage-
10 ment under this subchapter shall be exercised by the Ar-
11 chitect of the Capitol.”

12 (c) The amendments made by this section shall apply
13 with respect to pay periods beginning or after the later
14 of October 1, 2009, or the date of the enactment of this
15 Act.

16 SEC. 1205. ACCEPTANCE OF VOLUNTARY STUDENT
17 SERVICES.—Section 3111 of title 5, United States Code,
18 is amended by adding the following new subsection:

19 “(e) In this section, the term ‘agency’ includes the
20 Architect of the Capitol, except that in the case of the
21 Architect of the Capitol, the authority granted to the Of-
22 fice of Personnel Management under this section shall be
23 exercised by the Architect of the Capitol.”

1 (b) The amendment made by subsection (a) shall
2 apply with respect to fiscal year 2010 and each such suc-
3 ceeding fiscal year.

4 LIBRARY OF CONGRESS

5 SALARIES AND EXPENSES

6 For necessary expenses of the Library of Congress
7 not otherwise provided for, including development and
8 maintenance of the Library's catalogs; custody and custo-
9 dial care of the Library buildings; special clothing; clean-
10 ing; laundering and repair of uniforms; preservation of
11 motion pictures in the custody of the Library; operation
12 and maintenance of the American Folklife Center in the
13 Library; activities under the Civil Rights History Project
14 Act of 2009; preparation and distribution of catalog
15 records and other publications of the Library; hire or pur-
16 chase of one passenger motor vehicle; and expenses of the
17 Library of Congress Trust Fund Board not properly
18 chargeable to the income of any trust fund held by the
19 Board, \$450,211,000, of which not more than \$6,000,000
20 shall be derived from collections credited to this appropria-
21 tion during fiscal year 2010; and shall remain available
22 until expended, under the Act of June 28, 1902 (chapter
23 1301; 32 Stat. 480; 2 U.S.C. 150) and not more than
24 \$350,000 shall be derived from collections during fiscal
25 year 2010 and shall remain available until expended for

1 the development and maintenance of an international legal
2 information database and activities related thereto: *Pro-*
3 *vided*, That the Library of Congress may not obligate or
4 expend any funds derived from collections under the Act
5 of June 28, 1902, in excess of the amount authorized for
6 obligation or expenditure in appropriations Acts: *Provided*
7 *further*, That the total amount available for obligation
8 shall be reduced by the amount by which collections are
9 less than \$6,350,000: *Provided further*, That of the total
10 amount appropriated, not more than \$12,000 may be ex-
11 pended, on the certification of the Librarian of Congress,
12 in connection with official representation and reception ex-
13 penses for the Overseas Field Offices: *Provided further*,
14 That of the total amount appropriated, \$7,315,000 shall
15 remain available until expended for the digital collections
16 and educational curricula program: *Provided further*, That
17 of the total amount appropriated, \$750,000 shall be trans-
18 ferred to the Abraham Lincoln Bicentennial Commission
