Making appropriations for the Departments of Transportation, and Housing and Urban Development, and related agencies for the fiscal year ending September 30, 2010, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 Departments of Transportation, and Housing and Urban
6 Development, and related agencies for the fiscal year end-
7 ing September 30, 2010, and for other purposes, namely:

2 DEPARTMENT OF TRANSPORTATION
3 OFFICE OF THE SECRETARY
4 SALARIES AND EXPENSES
5 For necessary expenses of the Office of the Secretary,
6 ~~\$102,556,000 (reduced by \$250,000)~~, of which not to ex-
7 ceed ~~\$2,631,000~~, shall be available for the immediate Of-
8 fice of the Secretary; not to exceed \$986,000, shall be
9 available for the immediate Office of the Deputy Sec-
10 retary; not to exceed \$20,359,000, shall be available for
11 the Office of the General Counsel; not to exceed
12 ~~\$11,100,000~~, shall be available for the Office of the Under
13 Secretary of Transportation for Policy; not to exceed
14 ~~\$10,559,000~~, shall be available for the Office of the Assist-
15 ant Secretary for Budget and Programs; not to exceed
16 ~~\$2,440,000~~, shall be available for the Office of the Assist-
17 ant Secretary for Governmental Affairs; not to exceed
18 ~~\$25,520,000~~, shall be available for the Office of the Assist-
19 ant Secretary for Administration; not to exceed
20 ~~\$2,055,000~~, shall be available for the Office of Public Af-
21 fairs; not to exceed \$1,658,000, shall be available for the
22 Office of the Executive Secretariat; not to exceed
23 ~~\$1,433,000~~, shall be available for the Office of Small and
24 Disadvantaged Business Utilization; not to exceed
25 ~~\$10,600,000~~, shall be available for the Office of Intel-

1 ligence, Security, and Emergency Response; and not to ex-
 2 ceed \$13,215,000 shall be available for the Office of the
 3 Chief Information Officer: *Provided*, That the Secretary
 4 of Transportation is authorized to transfer funds appro-
 5 priated for any office of the Office of the Secretary to any
 6 other office of the Office of the Secretary: *Provided fur-*
 7 *ther*, That no appropriation for any office shall be in-
 8 creased or decreased by more than 5 percent by all such
 9 transfers: *Provided further*, That notice of any change in
 10 funding greater than 5 percent shall be submitted for ap-
 11 proval to the House and Senate Committees on Appropria-
 12 tions: *Provided further*, That not to exceed \$60,000, shall
 13 be for allocation within the Department for official recep-
 14 tion and representation expenses as the Secretary may de-
 15 termine: *Provided further*, That notwithstanding any other
 16 provision of law, excluding fees authorized in Public Law
 17 107–71, there may be credited to this appropriation up
 18 to \$2,500,000, in funds received in user fees: *Provided fur-*
 19 *ther*, That none of the funds provided in this Act shall
 20 be available for the position of Assistant Secretary for
 21 Public Affairs.

22 FINANCIAL MANAGEMENT CAPITAL

23 For necessary expenses for upgrading and enhancing
 24 the Department of Transportation's financial systems;

1 and reengineering business processes, \$5,000,000 (re-
 2 duced by \$3,000,000), to remain available until expended.

3 OFFICE OF CIVIL RIGHTS

4 For necessary expenses of the Office of Civil Rights,
 5 \$9,667,000.

6 TRANSPORTATION PLANNING, RESEARCH, AND

7 DEVELOPMENT

8 For necessary expenses for conducting transportation
 9 planning, research, systems development, development ac-
 10 tivities, and making grants, to remain available until ex-
 11 pended, \$14,733,000.

12 WORKING CAPITAL FUND

13 For necessary expenses for operating costs and cap-
 14 ital outlays of the Working Capital Fund, not to exceed
 15 \$147,569,000, shall be paid from appropriations made
 16 available to the Department of Transportation: *Provided*,
 17 That such services shall be provided on a competitive basis
 18 to entities within the Department of Transportation: *Pro-*
 19 *vided further*, That the above limitation on operating ex-
 20 penses shall not apply to non-DOT entities: *Provided fur-*
 21 *ther*, That no funds appropriated in this Act to an agency
 22 of the Department shall be transferred to the Working
 23 Capital Fund without the approval of the agency modal
 24 administrator: *Provided further*, That no assessments may
 25 be levied against any program, budget activity, subactivity

1 or project funded by this Act unless notice of such assess-
2 ments and the basis therefor are presented to the House
3 and Senate Committees on Appropriations and are ap-
4 proved by such Committees.

5 MINORITY BUSINESS RESOURCE CENTER PROGRAM

6 For the cost of guaranteed loans for short-term work-
7 ing capital, \$342,000, as authorized by 49 U.S.C. 332:
8 *Provided*, That such costs, including the cost of modifying
9 such loans, shall be as defined in section 502 of the Con-
10 gressional Budget Act of 1974: *Provided further*, That
11 these funds are available to subsidize total loan principal,
12 any part of which is to be guaranteed, not to exceed
13 \$18,367,000. In addition, for administrative expenses to
14 carry out the guaranteed loan program, \$570,000.

15 MINORITY BUSINESS OUTREACH

16 For necessary expenses of Minority Business Re-
17 source Center outreach activities, \$3,074,000, to remain
18 available until September 30, 2011: *Provided*, That not-
19 withstanding 49 U.S.C. 332, these funds may be used for
20 business opportunities related to any mode of transpor-
21 tation.

1 PAYMENTS TO AIR CARRIERS

2 (AIRPORT AND AIRWAY TRUST FUND)

3 (INCLUDING TRANSFER OF FUNDS)

4 In addition to funds made available from any other
5 source to carry out the Essential Air Service Program pur-
6 suant to 49 U.S.C. 41731 through 41742, \$125,000,000,
7 to be derived from the Airport and Airway Trust Fund,
8 to remain available until expended: *Provided*, That, in de-
9 termining between or among carriers competing to provide
10 service to a community, the Secretary may consider the
11 relative subsidy requirements of the carriers: *Provided fur-*
12 *ther*, That, if the funds under this heading are insufficient
13 to meet the costs of the Essential Air Service Program
14 in the current fiscal year, the Secretary shall transfer such
15 sums as may be necessary to carry out the Essential Air
16 Service Program from any available amounts appropriated
17 to or directly administered by the Office of the Secretary
18 for such fiscal year.

19 ADMINISTRATIVE PROVISIONS—OFFICE OF THE
20 SECRETARY OF TRANSPORTATION

21 SEC. 101. None of the funds made available in this
22 Act to the Department of Transportation may be obligated
23 for the Office of the Secretary of Transportation to ap-
24 prove assessments or reimbursable agreements pertaining
25 to funds appropriated to the modal administrations in this

1 Act, except for activities underway on the date of enact-
2 ment of this Act, unless such assessments or agreements
3 have completed the normal reprogramming process for
4 Congressional notification.

5 SEC. 102. None of the funds made available under
6 this Act may be obligated or expended to establish or im-
7 plement a program under which essential air service com-
8 munities are required to assume subsidy costs commonly
9 referred to as the EAS local participation program.

10 SEC. 103. The Secretary or his or her designee may
11 engage in activities with States and State legislators to
12 consider proposals related to the reduction of motorcycle
13 fatalities.

14 FEDERAL AVIATION ADMINISTRATION

15 OPERATIONS

16 (AIRPORT AND AIRWAY TRUST FUND)

17 For necessary expenses of the Federal Aviation Ad-
18 ministration, not otherwise provided for, including oper-
19 ations and research activities related to commercial space
20 transportation, administrative expenses for research and
21 development, establishment of air navigation facilities, the
22 operation (including leasing) and maintenance of aircraft,
23 subsidizing the cost of aeronautical charts and maps sold
24 to the public, lease or purchase of passenger motor vehi-
25 cles for replacement only, in addition to amounts made

1 available by Public Law 108-176, \$9,347,168,000, of
 2 which \$5,190,798,000 shall be derived from the Airport
 3 and Airway Trust Fund, of which not to exceed
 4 \$7,300,739,000 shall be available for air traffic organiza-
 5 tion activities; not to exceed \$1,231,765,000 shall be avail-
 6 able for aviation safety activities; not to exceed
 7 \$14,737,000 (increased by \$1,000,000) shall be available
 8 for commercial space transportation activities; not to ex-
 9 ceed \$113,681,000 shall be available for financial services
 10 activities; not to exceed \$100,428,000 shall be available
 11 for human resources program activities; not to exceed
 12 \$341,977,000 shall be available for region and center op-
 13 erations and regional coordination activities; not to exceed
 14 \$190,063,000 shall be available for staff offices; and not
 15 to exceed \$49,778,000 (reduced by \$1,000,000) shall be
 16 available for information services: *Provided*, That not to
 17 exceed 2 percent of any budget activity, except for aviation
 18 safety budget activity, may be transferred to any budget
 19 activity under this heading: *Provided further*, That no
 20 transfer may increase or decrease any appropriation by
 21 more than 2 percent: *Provided further*, That any transfer
 22 in excess of 2 percent shall be treated as a reprogramming
 23 of funds under section 405 of this Act and shall not be
 24 available for obligation or expenditure except in compli-
 25 ance with the procedures set forth in that section: *Pro-*

1 *vided further*, That the Secretary utilize not less than
2 \$17,084,000 of the funds provided for aviation safety ac-
3 tivities to pay for staff increases in the Office of Aviation
4 Flight Standards and the Office of Aircraft Certification:
5 *Provided further*, That not later than March 31 of each
6 fiscal year hereafter, the Administrator of the Federal
7 Aviation Administration shall transmit to Congress an an-
8 nual update to the report submitted to Congress in De-
9 cember 2004 pursuant to section 221 of Public Law 108–
10 176: *Provided further*, That funds may be used to enter
11 into a grant agreement with a nonprofit standard-setting
12 organization to assist in the development of aviation safety
13 standards: *Provided further*, That none of the funds in this
14 Act shall be available for new applicants for the second
15 career training program: *Provided further*, That none of
16 the funds in this Act shall be available for the Federal
17 Aviation Administration to finalize or implement any regu-
18 lation that would promulgate new aviation user fees not
19 specifically authorized by law after the date of the enact-
20 ment of this Act: *Provided further*, That there may be
21 credited to this appropriation as offsetting collections
22 funds received from States, counties, municipalities, for-
23 eign authorities, other public authorities, and private
24 sources, including funds from fees authorized under Chap-
25 ter 453 of title 49, United States Code, other than those

1 authorized by Section 45301(a)(1) of that title, which
2 shall be available for expenses incurred in the provision
3 of agency services, including receipts for the maintenance
4 and operation of air navigation facilities, and for issuance,
5 renewal or modification of certificates, including airman,
6 aircraft, and repair station certificates, or for tests related
7 thereto, or for processing major repair or alteration forms:
8 *Provided further,* That of the funds appropriated under
9 this heading, not less than \$9,500,000 shall be for the
10 contract tower cost-sharing program: *Provided further,*
11 That of the funds available under this heading not to ex-
12 ceed \$500,000 shall be provided to the Department of
13 Transportation's Office of Inspector General through re-
14 imbursement to conduct the annual audits of financial
15 statements in accordance with section 3521 of title 31,
16 United States Code, and not to exceed \$120,000 shall be
17 provided to that office through reimbursement to conduct
18 the annual Enterprise Services Center Statement on Au-
19 diting Standards 70 audit: *Provided further,* That none of
20 the funds in this Act for aeronautical charting and cartog-
21 raphy are available for activities conducted by, or coordi-
22 nated through, the Working Capital Fund.

1 FACILITIES AND EQUIPMENT

2 (AIRPORT AND AIRWAY TRUST FUND)

3 For necessary expenses, not otherwise provided for,
4 for acquisition, establishment, technical support services,
5 improvement by contract or purchase, and hire of National
6 Airspace Systems and experimental facilities and equip-
7 ment, as authorized under part A of subtitle VII of title
8 49, United States Code, including initial acquisition of
9 necessary sites by lease or grant; engineering and service
10 testing, including construction of test facilities and acqui-
11 sition of necessary sites by lease or grant; construction
12 and furnishing of quarters and related accommodations
13 for officers and employees of the Federal Aviation Admin-
14 istration stationed at remote localities where such accom-
15 modations are not available; and the purchase, lease, or
16 transfer of aircraft from funds available under this head-
17 ing, including aircraft for aviation regulation and certifi-
18 cation; to be derived from the Airport and Airway Trust
19 Fund, \$2,925,202,000, of which \$2,455,202,000 shall re-
20 main available until September 30, 2012, and of which
21 \$470,000,000 shall remain available until September 30,
22 2010: *Provided*, That there may be credited to this appro-
23 priation as offsetting collections funds received from
24 States, counties, municipalities, other public authorities,
25 and private sources, which shall be available for expenses

1 incurred in the establishment and modernization of air
 2 navigation facilities: *Provided further*, That upon initial
 3 submission to the Congress of the fiscal year 2011 Presi-
 4 dent's budget, the Secretary of Transportation shall trans-
 5 mit to the Congress a comprehensive capital investment
 6 plan for the Federal Aviation Administration which in-
 7 cludes funding for each budget line item for fiscal years
 8 2011 through 2015, with total funding for each year of
 9 the plan constrained to the funding targets for those years
 10 as estimated and approved by the Office of Management
 11 and Budget.

12 RESEARCH, ENGINEERING, AND DEVELOPMENT

13 (AIRPORT AND AIRWAY TRUST FUND)

14 For necessary expenses, not otherwise provided for,
 15 for research, engineering, and development, as authorized
 16 under part A of subtitle VII of title 49, United States
 17 Code, including construction of experimental facilities and
 18 acquisition of necessary sites by lease or grant,
 19 \$195,000,000, to be derived from the Airport and Airway
 20 Trust Fund and to remain available until September 30,
 21 2012: *Provided*, That there may be credited to this appro-
 22 priation as offsetting collections, funds received from
 23 States, counties, municipalities, other public authorities,
 24 and private sources, which shall be available for expenses
 25 incurred for research, engineering, and development.

1 GRANTS-IN-AID FOR AIRPORTS
 2 (LIQUIDATION OF CONTRACT AUTHORIZATION)
 3 (LIMITATION ON OBLIGATIONS)
 4 (AIRPORT AND AIRWAY TRUST FUND)

5 For liquidation of obligations incurred for grants-in-
 6 aid for airport planning and development, and noise com-
 7 patibility planning and programs as authorized under sub-
 8 chapter I of chapter 471 and subchapter I of chapter 475
 9 of title 49, United States Code, and under other law au-
 10 thorizing such obligations; for procurement, installation,
 11 and commissioning of runway incursion prevention devices
 12 and systems at airports of such title; for grants authorized
 13 under section 41743 of title 49, United States Code; and
 14 for inspection activities and administration of airport safe-
 15 ty programs, including those related to airport operating
 16 certificates under section 44706 of title 49, United States
 17 Code, \$3,000,000,000 to be derived from the Airport and
 18 Airway Trust Fund and to remain available until ex-
 19 pended: *Provided*, That none of the funds under this head-
 20 ing shall be available for the planning or execution of pro-
 21 grams the obligations for which are in excess of
 22 \$3,515,000,000 in fiscal year 2010, notwithstanding sec-
 23 tion 47117(g) of title 49, United States Code: *Provided*
 24 *further*, That none of the funds under this heading shall
 25 be available for the replacement of baggage conveyor sys-

1 tems; reconfiguration of terminal baggage areas; or other
 2 airport improvements that are necessary to install bulk ex-
 3 plosive detection systems: *Provided further*, That notwith-
 4 standing any other provision of law, of funds limited under
 5 this heading, not more than \$93,422,000 shall be obli-
 6 gated for administration; not less than \$15,000,000 shall
 7 be available for the airport cooperative research program;
 8 not less than \$22,472,000 shall be for Airport Technology
 9 Research.

10 ADMINISTRATIVE PROVISIONS—FEDERAL AVIATION

11 ADMINISTRATION

12 SEC. 110. None of the funds in this Act may be used
 13 to compensate in excess of 600 technical staff-years under
 14 the federally funded research and development center con-
 15 tract between the Federal Aviation Administration and the
 16 Center for Advanced Aviation Systems Development dur-
 17 ing fiscal year 2010.

18 SEC. 111. None of the funds in this Act shall be used
 19 to pursue or adopt guidelines or regulations requiring air-
 20 port sponsors to provide to the Federal Aviation Adminis-
 21 tration without cost building construction, maintenance,
 22 utilities and expenses, or space in airport sponsor-owned
 23 buildings for services relating to air traffic control, air
 24 navigation, or weather reporting: *Provided*, That the pro-
 25 hibition of funds in this section does not apply to negotia-

1 tions between the agency and airport sponsors to achieve
 2 agreement on “below-market” rates for these items or to
 3 grant assurances that require airport sponsors to provide
 4 land without cost to the FAA for air traffic control facili-
 5 ties.

6 ~~SEC. 112.~~ The Administrator of the Federal Aviation
 7 Administration may reimburse amounts made available to
 8 satisfy ~~49 U.S.C. 41742(a)(1)~~ from fees credited under
 9 ~~49 U.S.C. 45303~~; *Provided*, That during fiscal year 2010,
 10 ~~49 U.S.C. 41742(b)~~ shall not apply, and any amount re-
 11 maining in such account at the close of that fiscal year
 12 may be made available to satisfy section 41742(a)(1) for
 13 the subsequent fiscal year.

14 ~~SEC. 113.~~ Amounts collected under section ~~40113(e)~~
 15 of title 49, United States Code, shall be credited to the
 16 appropriation current at the time of collection, to be
 17 merged with and available for the same purposes of such
 18 appropriation.

19 ~~SEC. 114.~~ (a) Section ~~44302(f)(1)~~ of title 49, United
 20 States Code, is amended—

21 (1) by striking “September 30, 2009,” and in-
 22 serting “September 30, 2010,”; and

23 (2) by striking “December 31, 2009,” and in-
 24 serting “December 31, 2010,”.

1 (b) Section 44303(b) of such title is amended by
2 striking “December 31, 2009,” and inserting “December
3 31, 2010,”.

4 SEC. 115. None of the funds appropriated or limited
5 by this Act may be used to change weight restrictions or
6 prior permission rules at Teterboro airport in Teterboro,
7 New Jersey.

8 SEC. 116. None of the funds limited by this Act for
9 grants under the Airport Improvement Program shall be
10 made available to the sponsor of a commercial service air-
11 port if such sponsor fails to agree to a request from the
12 Secretary of Transportation for cost-free space in a non-
13 revenue producing, public use area of the airport terminal
14 or other airport facilities for the purpose of carrying out
15 a public service air passenger rights and consumer out-
16 reach campaign.

17 SEC. 117. None of the funds in this Act shall be avail-
18 able for paying premium pay under 5 U.S.C. 5546(a) to
19 any Federal Aviation Administration employee unless such
20 employee actually performed work during the time cor-
21 responding to such premium pay.

22 SEC. 118. None of the funds in this Act may be obli-
23 gated or expended for an employee of the Federal Aviation
24 Administration to purchase a store gift card or gift certifi-
25 cate through use of a Government-issued credit card.

1 FEDERAL HIGHWAY ADMINISTRATION

2 LIMITATION ON ADMINISTRATIVE EXPENSES

3 (INCLUDING TRANSFER OF FUNDS)

4 Not to exceed \$413,533,000, together with advances
5 and reimbursements received by the Federal Highway Ad-
6 ministration, shall be paid in accordance with law from
7 appropriations made available by this Act to the Federal
8 Highway Administration for necessary expenses for ad-
9 ministration and operation. In addition, not to exceed
10 \$3,524,000 shall be paid from appropriations made avail-
11 able by this Act and transferred to the Department of
12 Transportation's Office of Inspector General for costs as-
13 sociated with audits and investigations of projects and
14 programs of the Federal Highway Administration, and not
15 to exceed \$285,000 shall be paid from appropriations
16 made available by this Act and provided to that office
17 through reimbursement to conduct the annual audits of
18 financial statements in accordance with section 3521 of
19 title 31, United States Code. In addition, not to exceed
20 \$3,220,000 shall be paid from appropriations made avail-
21 able by this Act and transferred to the Appalachian Re-
22 gional Commission in accordance with section 104 of title
23 23, United States Code.

1 FEDERAL-AID HIGHWAYS

2 (LIMITATION ON OBLIGATIONS)

3 (HIGHWAY TRUST FUND)

4 None of the funds in this Act shall be available for
5 the implementation or execution of programs, the obliga-
6 tions for which are in excess of \$41,107,000,000 for Fed-
7 eral-aid highways and highway safety construction pro-
8 grams for fiscal year 2010: *Provided*, That within the
9 \$41,107,000,000 obligation limitation on Federal-aid
10 highways and highway safety construction programs, not
11 more than \$429,800,000 shall be available for the imple-
12 mentation or execution of programs for transportation re-
13 search (chapter 5 of title 23, United States Code; sections
14 111, 5505, and 5506 of title 49, United States Code; and
15 title 5 of Public Law 109-59) for fiscal year 2010: *Pro-*
16 *vided further*, That this limitation on transportation re-
17 search programs shall not apply to any authority pre-
18 viously made available for obligation: *Provided further*,
19 That the Secretary may, as authorized by section 605(b)
20 of title 23, United States Code, collect and spend fees to
21 cover the costs of services of expert firms, including coun-
22 sel, in the field of municipal and project finance to assist
23 in the underwriting and servicing of Federal credit instru-
24 ments and all or a portion of the costs to the Federal Gov-
25 ernment of servicing such credit instruments: *Provided*

1 ~~further~~, That such fees are available until expended to pay
 2 for such costs: *Provided further*, That such amounts are
 3 in addition to administrative expenses that are also avail-
 4 able for such purpose, and are not subject to any obliga-
 5 tion limitation or the limitation on administrative expenses
 6 under section 608 of title 23, United States Code.

7 (LIQUIDATION OF CONTRACT AUTHORIZATION)

8 (HIGHWAY TRUST FUND)

9 For carrying out the provisions of title 23, United
 10 States Code, that are attributable to Federal-aid high-
 11 ways, not otherwise provided, including reimbursement for
 12 sums expended pursuant to the provisions of 23 U.S.C.
 13 308, \$41,846,000,000 or so much thereof as may be avail-
 14 able in and derived from the Highway Trust Fund (other
 15 than the Mass Transit Account), to remain available until
 16 expended.

17 SURFACE TRANSPORTATION PRIORITIES

18 For the necessary expenses of certain highway and
 19 surface transportation projects, \$125,700,000, to remain
 20 available until expended: *Provided*, That the amount pro-
 21 vided under this heading shall be made available for the
 22 eligible programs, projects, and activities identified under
 23 this heading in the report accompanying this Act: *Pro-*
 24 *vided further*, That a project is an eligible project under
 25 this heading if the project is eligible for assistance under

1 title 23 or chapter 53 of title 49, United States Code: *Pro-*
 2 *vided further*, That funds provided under this heading
 3 shall be administered in the same manner as if such funds
 4 were apportioned under chapter 1 of title 23, United
 5 States Code, and the Federal share payable on account
 6 of any program, project, or activity carried out with funds
 7 made available under this heading shall be determined in
 8 accordance with section 120(b) of title 23, United States
 9 Code: *Provided further*, That notwithstanding any other
 10 provision of law and the preceding clauses of this provi-
 11 sion, the Secretary of Transportation may use amounts
 12 made available under this heading to make grants for any
 13 surface transportation project otherwise eligible for fund-
 14 ing under title 23 or title 49, United States Code.

15 ADMINISTRATIVE PROVISIONS—FEDERAL HIGHWAY

16 ADMINISTRATION

17 SEC. 120. (a) For fiscal year 2010, the Secretary of
 18 Transportation shall—

19 (1) not distribute from the obligation limitation
 20 for Federal-aid highways amounts authorized for ad-
 21 ministrative expenses and programs by section
 22 104(a) of title 23, United States Code; programs
 23 funded from the administrative takedown authorized
 24 by section 104(a)(1) of title 23, United States Code
 25 (as in effect on the day before the date of enactment

1 of the Safe, Accountable, Flexible, Efficient Trans-
2 portation Equity Act: A Legacy for Users); the high-
3 way use tax evasion program; and the Bureau of
4 Transportation Statistics;

4 sociated with project-based activities and assistance
5 funded under this paragraph.

6 (2) Not less than \$232,000,000 but not to ex-
7 ceed \$258,000,000 shall be available for perform-
8 ance-based contract administrators for section 8
9 project-based assistance: *Provided*, That the Sec-
10 retary of Housing and Urban Development may also
11 use such amounts for performance-based contract
12 administrators for the administration of: interest re-
13 duction payments pursuant to section 236(a) of the
14 National Housing Act (12 U.S.C. 1715z-1(a)); rent
15 supplement payments pursuant to section 101 of the

5 (3) Amounts recaptured under this heading, the
 6 heading “Annual Contributions for Assisted Hous-

 10 based contract administrators, notwithstanding the

2 existing congregate service grants for residents of assisted
3 housing projects, and of which up to \$25,000,000 shall
4 be for grants under section 202b of the Housing Act of
5 1959 (12 U.S.C. 1701q-2) for conversion of eligible

 3 year 2005 (only one amendment authorized for any such
 4 contract): *Provided further*, That all tenant-based assist-
 5 ance made available under this heading shall continue to
 6 remain available only to persons with disabilities: *Provided*
 7 *further*, That the Secretary may waive the provisions of
 8 section 811 governing the terms and conditions of project
 9 rental assistance and tenant-based assistance, except that
 10 the initial contract term for such assistance shall not ex-
 11 ceed 5 years in duration: *Provided further*, That amounts
 12 made available under this heading shall be available for
 13 Real Estate Assessment Center inspections and inspec-
 14 tion-related activities associated with section 811 Capital
 15 Advance Projects.

16 HOUSING COUNSELING ASSISTANCE

17 For contracts, grants, and other assistance excluding
 18 loans, as authorized under section 106 of the Housing and
 19 Urban Development Act of 1968, as amended(12 U.S.C.
 20 1701(x)), \$70,000,000 (increased by \$5,000,000), includ-
 21 ing up to \$2,500,000 for administrative contract services,
 22 to remain available until September 30, 2011: *Provided*,
 23 That funds shall be used for providing counseling and ad-
 24 vice to tenants and homeowners, both current and pro-
 25 spective, with respect to property maintenance, financial

1 management/literacy, and such other matters as may be
 2 appropriate to assist them in improving their housing con-
 3 ditions; meeting their financial needs; and fulfilling the re-

 5 administration; and for housing counselor training.

6 ENERGY INNOVATION FUND

1 RENT SUPPLEMENT

2 (RESCISSION)

3 Of the amounts recaptured from terminated con-
4 tracts under section 101 of the Housing and Urban Devel-
5 opment Act of 1965 (12 U.S.C. 1701s) and section 236
6 of the National Housing Act (12 U.S.C. 1715z-1)
7 \$27,600,000 are rescinded.

8 PAYMENT TO MANUFACTURED HOUSING FEES TRUST

9 FUND

10 For necessary expenses as authorized by the National
11 Manufactured Housing Construction and Safety Stand-
12 ards Act of 1974 (42 U.S.C. 5401 et seq.), up to
13 \$16,000,000, to remain available until expended, of which
14 \$7,000,000 is to be derived from the Manufactured Hous-
15 ing Fees Trust Fund: *Provided*, That not to exceed the
16 total amount appropriated under this heading shall be
17 available from the general fund of the Treasury to the ex-
18 tent necessary to incur obligations and make expenditures
19 pending the receipt of collections to the Fund pursuant
20 to section 620 of such Act: *Provided further*, That the
21 amount made available under this heading from the gen-
22 eral fund shall be reduced as such collections are received

8 to nonprofit and governmental entities in connection with
9 sales of single family real properties owned by the Sec-

11 Insurance Fund. For administrative contract expenses of
12 the Federal Housing Administration, \$188,900,000, of
13 which up to \$70,794,000 may be transferred to the Work-
14 ing Capital Fund, and of which up to \$7,500,000 shall
15 be for education and outreach of FHA single family loan
16 products: *Provided further*, That to the extent guaranteed
17 loan commitments exceed \$200,000,000,000 on or before
18 April 1, 2010, an additional \$1,400 for administrative

2 RESEARCH AND TECHNOLOGY

3 For contracts, grants, and necessary expenses of pro-
4 grams of research and studies relating to housing and
5 urban problems, not otherwise provided for, as authorized
6 by title V of the Housing and Urban Development Act
7 of 1970 (12 U.S.C. 1701z-1 et seq.), including carrying
8 out the functions of the Secretary of Housing and Urban
9 Development under section 1(a)(1)(i) of Reorganization
10 Plan No. 2 of 1968, \$50,000,000, to remain available
11 until September 30, 2011.

12 FAIR HOUSING AND EQUAL OPPORTUNITY

13 FAIR HOUSING ACTIVITIES

14 For contracts, grants, and other assistance, not oth-
15 erwise provided for, as authorized by title VIII of the Civil
16 Rights Act of 1968, as amended by the Fair Housing
17 Amendments Act of 1988, and section 561 of the Housing
18 and Community Development Act of 1987, as amended,
19 \$72,000,000, to remain available until September 30,
20 2011, of which \$42,500,000 shall be to carry out activities
21 pursuant to such section 561: *Provided*, That notwith-
22 standing 31 U.S.C. 3302, the Secretary may assess and
23 collect fees to cover the costs of the Fair Housing Training
24 Academy, and may use such funds to provide such train-
25 ing: *Provided further*, That no funds made available under

1 this heading shall be used to lobby the executive or legisla-
2 tive branches of the Federal Government in connection
3 with a specific contract, grant or loan.

4 OFFICE OF LEAD HAZARD CONTROL AND HEALTHY
5 HOMES

6 LEAD HAZARD REDUCTION

7 For the Lead Hazard Reduction Program, as author-
8 ized by section 1011 of the Residential Lead-Based Paint
9 Hazard Reduction Act of 1992, \$140,000,000, to remain
10 available until September 30, 2011, of which not less than
11 \$20,000,000 shall be for the Healthy Homes Initiative,
12 pursuant to sections 501 and 502 of the Housing and
13 Urban Development Act of 1970 that shall include re-
14 search, studies, testing, and demonstration efforts, includ-
15 ing education and outreach concerning lead-based paint
16 poisoning and other housing-related diseases and hazards:
17 *Provided*, That for purposes of environmental review, pur-
18 suant to the National Environmental Policy Act of 1969
19 (42 U.S.C. 4321 et seq.) and other provisions of the law
20 that further the purposes of such Act, a grant under the
21 Healthy Homes Initiative, Operation Lead Elimination
22 Action Plan (LEAP), or the Lead Technical Studies pro-
23 gram under this heading or under prior appropriations
24 Acts for such purposes under this heading, shall be consid-
25 ered to be funds for a special project for purposes of sec-

tion 305(c) of the Multifamily Housing Property Disposition Reform Act of 1994: *Provided further*, That amounts made available under this heading in this or prior appropriations Acts, and that still remain available, may be used for any purpose under this heading notwithstanding the purpose for which such amounts were appropriated if a program competition is undersubscribed and there are other program competitions under this heading that are oversubscribed.

WORKING CAPITAL FUND

(INCLUDING TRANSFER OF FUNDS)

For additional capital for the Working Capital Fund (42 U.S.C. 3535) for the maintenance of infrastructure for Department-wide information technology systems, for the continuing operation and maintenance of both Department-wide and program-specific information systems, and for program-related maintenance activities, \$200,000,000, to remain available until September 30, 2011: *Provided*, That any amounts transferred to this Fund under this Act shall remain available until expended: *Provided further*, That any amounts transferred to this Fund from amounts appropriated by previously enacted appropriations Acts or from within this Act may be used only for the purposes specified under this Fund, in addition to the purposes for

1 which such amounts were appropriated: *Provided further*,
 2 That up to \$15,000,000 may be transferred to this ac-
 3 count from all other accounts in this title (except for the
 4 Office of the Inspector General account) that make funds
 5 available for salaries and expenses.

6 OFFICE OF INSPECTOR GENERAL

7 For necessary salaries and expenses of the Office of
 8 Inspector General in carrying out the Inspector General
 9 Act of 1978, as amended, \$120,000,000: *Provided*, That
 10 the Inspector General shall have independent authority
 11 over all personnel issues within this office.

12 TRANSFORMATION INITIATIVE

13 For necessary expenses for combating mortgage
 14 fraud, \$20,000,000, to remain available until expended.

15 In addition, of the amounts made available in this
 16 Act under each of the following headings under this title,
 17 the Secretary may transfer to, and merge with, this ac-
 18 count up to 1 percent from each such account, and such
 19 transferred amounts shall be available until September 30,
 20 2012, for: (1) research, evaluation, and program metrics;
 21 (2) program demonstrations; (3) technical assistance and
 22 capacity building; and (4) information technology: “Public
 23 Housing Capital Fund”, “Energy Innovation Fund”,
 24 “Native American Housing Block Grants”, “Native Ha-

 8 ities”, “Housing Counseling Assistance”, “Payment to
 9 Manufactured Housing Fees Trust Fund”, “Mutual Mort-
 10 gage Insurance Program Account”, “General and Special
 11 Risk Program Account”, “Research and Technology”,
 12 “Lead Hazard Reduction”, “Rental Housing Assistance”,
 13 and “Fair Housing Activities”: *Provided*, That the Sec-
 14 retary shall fund each of the four general purposes speci-
 15 fied above at not less than 10 percent, and not more than
 16 50 percent, of the aggregate transferred amount.

17 GENERAL PROVISIONS—DEPARTMENT OF HOUSING AND
 18 URBAN DEVELOPMENT

19 SEC. 201. Fifty percent of the amounts of budget au-
 20 thority, or in lieu thereof 50 percent of the cash amounts
 21 associated with such budget authority, that are recaptured
 22 from projects described in section 1012(a) of the Stewart
 23 B. McKinney Homeless Assistance Amendments Act of
 24 1988 (42 U.S.C. 1437 note) shall be rescinded or in the
 25 case of cash, shall be remitted to the Treasury, and such

1 amounts of budget authority or cash recaptured and not
2 rescinded or remitted to the Treasury shall be used by
3 State housing finance agencies or local governments or
4 local housing agencies with projects approved by the Sec-
5 retary of Housing and Urban Development for which set-
6 tlement occurred after January 1, 1992, in accordance
7 with such section. Notwithstanding the previous sentence,
8 the Secretary may award up to 15 percent of the budget
9 authority or cash recaptured and not rescinded or remitted
10 to the Treasury to provide project owners with incentives
11 to refinance their project at a lower interest rate.

12 SEC. 202. None of the amounts made available under
13 this Act may be used during fiscal year 2010 to investigate
14 or prosecute under the Fair Housing Act any otherwise
15 lawful activity engaged in by one or more persons, includ-
16 ing the filing or maintaining of a non-frivolous legal ac-
17 tion, that is engaged in solely for the purpose of achieving
18 or preventing action by a Government official or entity,
19 or a court of competent jurisdiction.

20 SEC. 203. (a) Notwithstanding section 854(c)(1)(A)
21 of the AIDS Housing Opportunity Act (42 U.S.C.
22 12903(c)(1)(A)), from any amounts made available under
23 this title for fiscal year 2010 that are allocated under such
24 section, the Secretary of Housing and Urban Development

1 shall allocate and make a grant, in the amount determined
2 under subsection (b), for any State that—

3 (1) received an allocation in a prior fiscal year
4 under clause (ii) of such section; and

5 (2) is not otherwise eligible for an allocation for
6 fiscal year 2010 under such clause (ii) because the
7 areas in the State outside of the metropolitan statis-
8 tical areas that qualify under clause (i) in fiscal year
9 2010 do not have the number of cases of acquired
10 immunodeficiency syndrome (AIDS) required under
11 such clause.

12 (b) The amount of the allocation and grant for any
13 State described in subsection (a) shall be an amount based
14 on the cumulative number of AIDS cases in the areas of
15 that State that are outside of metropolitan statistical
16 areas that qualify under clause (i) of such section
17 854(e)(1)(A) in fiscal year 2010, in proportion to AIDS
18 cases among cities and States that qualify under clauses
19 (i) and (ii) of such section and States deemed eligible
20 under subsection (a).

21 (c) Notwithstanding any other provision of law, the
22 amount allocated for fiscal year 2010 under section 854(e)
23 of the AIDS Housing Opportunity Act (42 U.S.C.
24 12903(e)), to the City of New York, New York, on behalf
25 of the New York-Wayne-White Plains, New York-New

1 Jersey Metropolitan Division (hereafter “metropolitan di-
2 vision”) of the New York-Newark-Edison, NY-NJ-PA
3 Metropolitan Statistical Area, shall be adjusted by the
4 Secretary of Housing and Urban Development by: (1) allo-
5 cating to the City of Jersey City, New Jersey, the propor-
6 tion of the metropolitan area’s or division’s amount that
7 is based on the number of cases of AIDS reported in the
8 portion of the metropolitan area or division that is located
9 in Hudson County, New Jersey, and adjusting for the pro-
10 portion of the metropolitan division’s high incidence bonus
11 if this area in New Jersey also has a higher than average
12 per capita incidence of AIDS; and (2) allocating to the
13 City of Paterson, New Jersey, the proportion of the metro-
14 politan area’s or division’s amount that is based on the
15 number of cases of AIDS reported in the portion of the
16 metropolitan area or division that is located in Bergen
17 County and Passaic County, New Jersey, and adjusting
18 for the proportion of the metropolitan division’s high inci-
19 dence bonus if this area in New Jersey also has a higher
20 than average per capita incidence of AIDS. The recipient
21 cities shall use amounts allocated under this subsection
22 to carry out eligible activities under section 855 of the
23 AIDS Housing Opportunity Act (42 U.S.C. 12904) in
24 their respective portions of the metropolitan division that
25 is located in New Jersey.

1 (d) Notwithstanding any other provision of law, the
2 amount allocated for fiscal year 2010 under section 854(e)
3 of the AIDS Housing Opportunity Act (42 U.S.C.
4 12903(c)) to areas with a higher than average per capita
5 incidence of AIDS, shall be adjusted by the Secretary on
6 the basis of area incidence reported over a 3-year period.

7 SEC. 204. Except as explicitly provided in law, any
8 grant, cooperative agreement or other assistance made
9 pursuant to title II of this Act shall be made on a competi-
10 tive basis and in accordance with section 102 of the De-
11 partment of Housing and Urban Development Reform Act
12 of 1989 (42 U.S.C. 3545).

13 SEC. 205. Funds of the Department of Housing and
14 Urban Development subject to the Government Corpora-
15 tion Control Act or section 402 of the Housing Act of
16 1950 shall be available, without regard to the limitations

 20 salary at a rate not to exceed level II of the Executive
 21 Schedule”: *Provided further*, That in addition,
 22 \$63,800,000 shall be made available until expended to the
 23 Neighborhood Reinvestment Corporation for mortgage
 24 foreclosure mitigation activities, under the following terms
 25 and conditions:

1 (1) The Neighborhood Reinvestment Corpora-
2 tion (“NRC”), shall make grants to counseling inter-
3 mediaries approved by the Department of Housing
4 and Urban Development (HUD) (with match to be
5 determined by the NRC based on affordability and
6 the economic conditions of an area; a match also
7 may be waived by the NRC based on the aforemen-
8 tioned conditions) to provide mortgage foreclosure
9 mitigation assistance primarily to States and areas
10 with high rates of defaults and foreclosures pri-
11 marily in the subprime housing market to help elimi-
12 nate the default and foreclosure of mortgages of
13 owner-occupied single-family homes that are at risk
14 of such foreclosure. Other than areas with high rates
15 of defaults and foreclosures, grants may also be pro-
16 vided to approved counseling intermediaries based on
17 a geographic analysis of the Nation by the NRC
18 which determines where there is a prevalence of

 11 *retary may amend the plan with the approval of the House*
 12 *and Senate Committees on Appropriations.*

13 *GENERAL PROVISIONS—DEPARTMENT OF HOUSING AND*

14 *URBAN DEVELOPMENT*

15 *(INCLUDING RESCISSION OF FUNDS)*

16 *SEC. 201. Fifty percent of the amounts of budget au-*
 17 *thority, or in lieu thereof 50 percent of the cash amounts*
 18 *associated with such budget authority, that are recaptured*
 19 *from projects described in section 1012(a) of the Stewart*
 20 *B. McKinney Homeless Assistance Amendments Act of 1988*
 21 *(42 U.S.C. 1437 note) shall be rescission or in the case of*
 22 *cash, shall be remitted to the Treasury, and such amounts*
 23 *of budget authority or cash recaptured and not rescission*
 24 *or remitted to the Treasury shall be used by State housing*
 25 *finance agencies or local governments or local housing agen-*

1 *cies with projects approved by the Secretary of Housing and*
2 *Urban Development for which settlement occurred after*
3 *January 1, 1992, in accordance with such section. Notwith-*
4 *standing the previous sentence, the Secretary may award*
5 *up to 15 percent of the budget authority or cash recaptured*
6 *and not rescission or remitted to the Treasury to provide*
7 *project owners with incentives to refinance their project at*
8 *a lower interest rate.*

9 *SEC. 202. None of the amounts made available under*
10 *this Act may be used during fiscal year 2010 to investigate*
11 *or prosecute under the Fair Housing Act any otherwise law-*
12 *ful activity engaged in by one or more persons, including*
13 *the filing or maintaining of a non-frivolous legal action,*
14 *that is engaged in solely for the purpose of achieving or*
15 *preventing action by a Government official or entity, or a*
16 *court of competent jurisdiction.*

17 *SEC. 203. (a) Notwithstanding section 854(c)(1)(A) of*
18 *the AIDS Housing Opportunity Act (42 U.S.C.*
19 *12903(c)(1)(A)), from any amounts made available under*
20 *this title for fiscal year 2010 that are allocated under such*
21 *section, the Secretary of Housing and Urban Development*
22 *shall allocate and make a grant, in the amount determined*
23 *under subsection (b), for any State that—*

24 *(1) received an allocation in a prior fiscal year*
25 *under clause (ii) of such section; and*

1 (2) is not otherwise eligible for an allocation for
2 fiscal year 2010 under such clause (ii) because the
3 areas in the State outside of the metropolitan statis-
4 tical areas that qualify under clause (I) in fiscal year
5 2010 do not have the number of cases of acquired im-
6 munodeficiency syndrome (AIDS) required under
7 such clause.

8 (b) The amount of the allocation and grant for any
9 State described in subsection (a) shall be an amount based
10 on the cumulative number of AIDS cases in the areas of
11 that State that are outside of metropolitan statistical areas
12 that qualify under clause (I) of such section 854(c)(1)(A)
13 in fiscal year 2010, in proportion to AIDS cases among
14 cities and States that qualify under clauses (I) and (ii) of
15 such section and States deemed eligible under subsection
16 (a).

17 (c) Notwithstanding any other provision of law, the
18 amount allocated for fiscal year 2010 under section 854(c)
19 of the AIDS Housing Opportunity Act (42 U.S.C.
20 12903(c)), to the City of New York, New York, on behalf
21 of the New York-Wayne-White Plains, New York-New Jersey
22 Metropolitan Division (hereafter “metropolitan division”)
23 of the New York-Newark-Edison, NY-NJ-PA Metropolitan
24 Statistical Area, shall be adjusted by the Secretary of Hous-
25 ing and Urban Development by: (1) allocating to the City

1 of Jersey City, New Jersey, the proportion of the metropoli-
2 tan area's or division's amount that is based on the number
3 of cases of AIDS reported in the portion of the metropolitan
4 area or division that is located in Hudson County, New
5 Jersey, and adjusting for the proportion of the metropolitan
6 division's high incidence bonus if this area in New Jersey
7 also has a higher than average per capita incidence of
8 AIDS; and (2) allocating to the City of Paterson, New Jer-
9 sey, the proportion of the metropolitan area's or division's
10 amount that is based on the number of cases of AIDS re-
11 ported in the portion of the metropolitan area or division
12 that is located in Bergen County and Passaic County, New
13 Jersey, and adjusting for the proportion of the metropolitan
14 division's high incidence bonus if this area in New Jersey
15 also has a higher than average per capita incidence of
16 AIDS. The recipient cities shall use amounts allocated
17 under this subsection to carry out eligible activities under
18 section 855 of the AIDS Housing Opportunity Act (42
19 U.S.C. 12904) in their respective portions of the metropoli-
20 tan division that is located in New Jersey.

21 (d) Notwithstanding any other provision of law, the
22 amount allocated for fiscal year 2010 under section 854(c)
23 of the AIDS Housing Opportunity Act (42 U.S.C. 12903(c))
24 to areas with a higher than average per capita incidence

1 of AIDS, shall be adjusted by the Secretary on the basis
2 of area incidence reported over a 3 year period.

3 SEC. 204. Except as explicitly provided in law, any
4 grant, cooperative agreement or other assistance made pur-
5 suant to title II of this Act shall be made on a competitive
6 basis and in accordance with section 102 of the Department
7 of Housing and Urban Development Reform Act of 1989
8 (42 U.S.C. 3545).

9 SEC. 205. Funds of the Department of Housing and
10 Urban Development subject to the Government Corporation
11 Control Act or section 402 of the Housing Act of 1950 shall
12 be available, without regard to the limitations on adminis-
13 trative expenses, for legal services on a contract or fee basis,
14 and for utilizing and making payment for services and fa-
15 cilities of the Federal National Mortgage Association, Gov-
16 ernment National Mortgage Association, Federal Home
17 Loan Mortgage Corporation, Federal Financing Bank, Fed-
18 eral Reserve banks or any member thereof, Federal Home
19 Loan banks, and any insured bank within the meaning of
20 the Federal Deposit Insurance Corporation Act, as amended
21 (12 U.S.C. 1811—1).

22 SEC. 206. Unless otherwise provided for in this Act
23 or through a reprogramming of funds, no part of any ap-
24 propriation for the Department of Housing and Urban De-
25 velopment shall be available for any program, project or

1 activity in excess of amounts set forth in the budget esti-
2 mates submitted to Congress.

3 SEC. 207. Corporations and agencies of the Depart-
4 ment of Housing and Urban Development which are subject
5 to the Government Corporation Control Act, are hereby au-
6 thorized to make such expenditures, within the limits of
7 funds and borrowing authority available to each such cor-
8 poration or agency and in accordance with law, and to
9 make such contracts and commitments without regard to
10 fiscal year limitations as provided by section 104 of such
11 Act as may be necessary in carrying out the programs set
12 forth in the budget for 2010 for such corporation or agency
13 except as hereinafter provided: Provided, That collections
14 of these corporations and agencies may be used for new loan
15 or mortgage purchase commitments only to the extent ex-
16 pressly provided for in this Act (unless such loans are in
17 support of other forms of assistance provided for in this or
18 prior appropriations Acts), except that this proviso shall
19 not apply to the mortgage insurance or guaranty operations
20 of these corporations, or where loans or mortgage purchases
21 are necessary to protect the financial interest of the United
22 States Government.

23 SEC. 208. The Secretary of Housing and Urban Devel-
24 opment shall provide quarterly reports to the House and
25 Senate Committees on Appropriations regarding all uncom-

1 *mitted, unobligated, recaptured and excess funds in each*
2 *program and activity within the jurisdiction of the Depart-*
3 *ment and shall submit additional, updated budget informa-*
4 *tion to these Committees upon request.*

5 *SEC. 209. (a) Notwithstanding any other provision of*
6 *law, the amount allocated for fiscal year 2010 under section*
7 *854(c) of the AIDS Housing Opportunity Act (42 U.S.C.*
8 *12903(c)), to the City of Wilmington, Delaware, on behalf*
9 *of the Wilmington, Delaware-Maryland-New Jersey Metro-*
10 *politan Division (hereafter “metropolitan division”), shall*
11 *be adjusted by the Secretary of Housing and Urban Devel-*
12 *opment by allocating to the State of New Jersey the propor-*
13 *tion of the metropolitan division’s amount that is based on*
14 *the number of cases of AIDS reported in the portion of the*
15 *metropolitan division that is located in New Jersey, and*
16 *adjusting for the proportion of the metropolitan division’s*
17 *high incidence bonus if this area in New Jersey also has*
18 *a higher than average per capita incidence of AIDS. The*
19 *State of New Jersey shall use amounts allocated to the State*
20 *under this subsection to carry out eligible activities under*
21 *section 855 of the AIDS Housing Opportunity Act (42*
22 *U.S.C. 12904) in the portion of the metropolitan division*
23 *that is located in New Jersey.*

24 *(b) Notwithstanding any other provision of law, the*
25 *Secretary of Housing and Urban Development shall allocate*

1 to Wake County, North Carolina, the amounts that other-
2 wise would be allocated for fiscal year 2010 under section
3 854(c) of the AIDS Housing Opportunity Act (42 U.S.C.
4 12903(c)) to the City of Raleigh, North Carolina, on behalf
5 of the Raleigh-Cary, North Carolina Metropolitan Statis-
6 tical Area. Any amounts allocated to Wake County shall
7 be used to carry out eligible activities under section 855
8 of such Act (42 U.S.C. 12904) within such metropolitan sta-
9 tistical area.

10 (c) Notwithstanding section 854(c) of the AIDS Hous-
11 ing Opportunity Act (42 U.S.C. 12903(c)), the Secretary
12 of Housing and Urban Development may adjust the alloca-
13 tion of the amounts that otherwise would be allocated for
14 fiscal year 2010 under section 854(c) of such Act, upon the
15 written request of an applicant, in conjunction with the
16 State(s), for a formula allocation on behalf of a metropoli-
17 tan statistical area, to designate the State or States in
18 which the metropolitan statistical area is located as the eli-
19 gible grantee(s) of the allocation. In the case that a metro-
20 politan statistical area involves more than one State, such
21 amounts allocated to each State shall be in proportion to
22 the number of cases of AIDS reported in the portion of the
23 metropolitan statistical area located in that State. Any
24 amounts allocated to a State under this section shall be used

1 *to carry out eligible activities within the portion of the met-*
2 *ropolitan statistical area located in that State.*

3 *SEC. 210. The President's formal budget request for fis-*
4 *cal year 2011, as well as the Department of Housing and*
5 *Urban Development's congressional budget justifications to*
6 *be submitted to the Committees on Appropriations of the*
7 *House of Representatives and the Senate, shall use the iden-*
8 *tical account and sub-account structure provided under this*
9 *Act.*

10 *SEC. 211. A public housing agency or such other entity*
11 *that administers Federal housing assistance for the Housing*
12 *Authority of the county of Los Angeles, California, the*
13 *States of Alaska, Iowa, and Mississippi shall not be re-*
14 *quired to include a resident of public housing or a recipient*
15 *of assistance provided under section 8 of the United States*
16 *Housing Act of 1937 on the board of directors or a similar*
17 *governing board of such agency or entity as required under*
18 *section (2)(b) of such Act. Each public housing agency or*
19 *other entity that administers Federal housing assistance*
20 *under section 8 for the Housing Authority of the county*
21 *of Los Angeles, California and the States of Alaska, Iowa*
22 *and Mississippi that chooses not to include a resident of*
23 *Public Housing or a recipient of section 8 assistance on*
24 *the board of directors or a similar governing board shall*
25 *establish an advisory board of not less than six residents*

1 of public housing or recipients of section 8 assistance to
2 provide advice and comment to the public housing agency
3 or other administering entity on issues related to public
4 housing and section 8. Such advisory board shall meet not
5 less than quarterly.

6 SEC. 212. (a) Notwithstanding any other provision of
7 law, subject to the conditions listed in subsection (b), for
8 fiscal years 2009 and 2010, the Secretary of Housing and
9 Urban Development may authorize the transfer of some or
10 all project-based assistance, debt and statutorily required
11 low-income and very low-income use restrictions, associated
12 with one or more multifamily housing project to another
13 multifamily housing project or projects.

14 (b) The transfer authorized in subsection (a) is subject
15 to the following conditions:

16 (1) The number of low-income and very low-in-
17 come units and the net dollar amount of Federal as-
18 sistance provided by the transferring project shall re-
19 main the same in the receiving project or projects.

20 (2) The transferring project shall, as determined
21 by the Secretary, be either physically obsolete or eco-
22 nomically non-viable.

23 (3) The receiving project or projects shall meet or
24 exceed applicable physical standards established by
25 the Secretary.

1 (4) *The owner or mortgagor of the transferring*
2 *project shall notify and consult with the tenants re-*
3 *siding in the transferring project and provide a cer-*
4 *tification of approval by all appropriate local govern-*
5 *mental officials.*

6 (5) *The tenants of the transferring project who*
7 *remain eligible for assistance to be provided by the re-*
8 *ceiving project or projects shall not be required to va-*
9 *cate their units in the transferring project or projects*
10 *until new units in the receiving project are available*
11 *for occupancy.*

12 (6) *The Secretary determines that this transfer is*
13 *in the best interest of the tenants.*

14 (7) *If either the transferring project or the re-*
15 *ceiving project or projects meets the condition speci-*
16 *fied in subsection (c)(2)(A), any lien on the receiving*
17 *project resulting from additional financing obtained*
18 *by the owner shall be subordinate to any FHA-in-*
19 *sured mortgage lien transferred to, or placed on, such*
20 *project by the Secretary.*

21 (8) *If the transferring project meets the require-*
22 *ments of subsection (c)(2)(E), the owner or mortgagor*
23 *of the receiving project or projects shall execute and*
24 *record either a continuation of the existing use agree-*
25 *ment or a new use agreement for the project where,*

1 *in either case, any use restrictions in such agreement*
2 *are of no lesser duration than the existing use restric-*
3 *tions.*

4 *(9) Any financial risk to the FHA General and*
5 *Special Risk Insurance Fund, as determined by the*
6 *Secretary, would be reduced as a result of a transfer*
7 *completed under this section.*

8 *(10) The Secretary determines that Federal li-*
9 *ability with regard to this project will not be in-*
10 *creased.*

11 *(c) For purposes of this section—*

12 *(1) the terms “low-income” and “very low-in-*
13 *come” shall have the meanings provided by the statute*
14 *and/or regulations governing the program under*
15 *which the project is insured or assisted;*

16 *(2) the term “multifamily housing project”*
17 *means housing that meets one of the following condi-*
18 *tions—*

19 *(A) housing that is subject to a mortgage*
20 *insured under the National Housing Act;*

21 *(B) housing that has project-based assist-*
22 *ance attached to the structure including projects*
23 *undergoing mark to market debt restructuring*
24 *under the Multifamily Assisted Housing Reform*
25 *and Affordability Housing Act;*

1 (C) housing that is assisted under section
2 202 of the Housing Act of 1959 as amended by
3 section 801 of the Cranston-Gonzales National
4 Affordable Housing Act;

5 (D) housing that is assisted under section
6 202 of the Housing Act of 1959, as such section
7 existed before the enactment of the Cranston-
8 Gonzales National Affordable Housing Act; or

9 (E) housing or vacant land that is subject
10 to a use agreement;

11 (3) the term “project-based assistance” means—

12 (A) assistance provided under section 8(b)
13 of the United States Housing Act of 1937;

14 (B) assistance for housing constructed or
15 substantially rehabilitated pursuant to assistance
16 provided under section 8(b)(2) of such Act (as
17 such section existed immediately before October
18 1, 1983);

19 (C) rent supplement payments under sec-
20 tion 101 of the Housing and Urban Development
21 Act of 1965;

22 (D) interest reduction payments under sec-
23 tion 236 and/or additional assistance payments
24 under section 236(f)(2) of the National Housing
25 Act; and

1 (E) assistance payments made under sec-
2 tion 202(c)(2) of the Housing Act of 1959;

3 (4) the term “receiving project or projects”
4 means the multifamily housing project or projects to
5 which some or all of the project-based assistance, debt,
6 and statutorily required use low-income and very
7 low-income restrictions are to be transferred;

8 (5) the term “transferring project” means the
9 multifamily housing project which is transferring
10 some or all of the project-based assistance, debt and
11 the statutorily required low-income and very low-in-
12 come use restrictions to the receiving project or
13 projects; and

14 (6) the term “Secretary” means the Secretary of
15 Housing and Urban Development.

16 SEC. 213. The funds made available for Native Alas-
17 kans under the heading “Native American Housing Block
18 Grants” in title III of this Act shall be allocated to the same
19 Native Alaskan housing block grant recipients that received
20 funds in fiscal year 2005.

21 SEC. 214. No funds provided under this title may be
22 used for an audit of the Government National Mortgage As-
23 sociation that makes applicable requirements under the
24 Federal Credit Reform Act of 1990 (2 U.S.C. 661 et seq.).

1 *SEC. 215. (a) No assistance shall be provided under*
2 *section 8 of the United States Housing Act of 1937 (42*
3 *U.S.C. 1437f) to any individual who—*

4 *(1) is enrolled as a student at an institution of*
5 *higher education (as defined under section 102 of the*
6 *Higher Education Act of 1965 (20 U.S.C. 1002));*

7 *(2) is under 24 years of age;*

8 *(3) is not a veteran;*

9 *(4) is unmarried;*

10 *(5) does not have a dependent child;*

11 *(6) is not a person with disabilities, as such*
12 *term is defined in section 3(b)(3)(E) of the United*
13 *States Housing Act of 1937 (42 U.S.C.*
14 *1437a(b)(3)(E)) and was not receiving assistance*
15 *under such section 8 as of November 30, 2005; and*

16 *(7) is not otherwise individually eligible, or has*
17 *parents who, individually or jointly, are not eligible,*
18 *to receive assistance under section 8 of the United*
19 *States Housing Act of 1937 (42 U.S.C. 1437f).*

20 *(b) For purposes of determining the eligibility of a per-*
21 *son to receive assistance under section 8 of the United States*
22 *Housing Act of 1937 (42 U.S.C. 1437f), any financial as-*
23 *sistance (in excess of amounts received for tuition) that an*
24 *individual receives under the Higher Education Act of 1965*
25 *(20 U.S.C. 1001 et seq.), from private sources, or an institu-*

1 *tion of higher education (as defined under the Higher Edu-*
 2 *cation Act of 1965 (20 U.S.C. 1002)), shall be considered*
 3 *income to that individual, except for a person over the age*
 4 *of 23 with dependent children.*

5 *SEC. 216. Notwithstanding the limitation in the first*
 6 *sentence of section 255(g) of the National Housing Act (12*
 7 *U.S.C. 1715z–g)), the Secretary of Housing and Urban De-*
 8 *velopment may, until September 30, 2010, insure and enter*
 9 *into commitments to insure mortgages under section 255(g)*
 10 *of the National Housing Act (12 U.S.C. 1715z–20).*

11 *SEC. 217. Notwithstanding any other provision of law,*
 12 *in fiscal year 2010, in managing and disposing of any mul-*
 13 *tifamily property that is owned or has a mortgage held by*
 14 *the Secretary of Housing and Urban Development, the Sec-*
 15 *retary shall maintain any rental assistance payments*
 16 *under section 8 of the United States Housing Act of 1937*
 17 *and other programs that are attached to any dwelling units*
 18 *in the property. To the extent the Secretary determines, in*
 19 *consultation with the tenants and the local government, that*
 20 *such a multifamily property owned or held by the Secretary*
 21 *is not feasible for continued rental assistance payments*
 22 *under such section 8 or other programs, based on consider-*
 23 *ation of (1) the costs of rehabilitating and operating the*
 24 *property and all available Federal, State, and local re-*
 25 *sources, including rent adjustments under section 524 of the*

1 *Multifamily Assisted Housing Reform and Affordability*
2 *Act of 1997 (“MAHRAA”) and (2) environmental condi-*
3 *tions that cannot be remedied in a cost-effective fashion, the*
4 *Secretary may, in consultation with the tenants of that*
5 *property, contract for project-based rental assistance pay-*
6 *ments with an owner or owners of other existing housing*
7 *properties, or provide other rental assistance. The Secretary*
8 *shall also take appropriate steps to ensure that project-based*
9 *contracts remain in effect prior to foreclosure, subject to the*
10 *exercise of contractual abatement remedies to assist reloca-*
11 *tion of tenants for imminent major threats to health and*
12 *safety. After disposition of any multifamily property de-*
13 *scribed under this section, the contract and allowable rent*
14 *levels on such properties shall be subject to the requirements*
15 *under section 524 of MAHRAA.*

16 *SEC. 218. The Secretary of Housing and Urban Devel-*
17 *opment shall report quarterly to the House of Representa-*
18 *tives and Senate Committees on Appropriations on HUD’s*
19 *use of all sole source contracts, including terms of the con-*
20 *tracts, cost, and a substantive rationale for using a sole*
21 *source contract.*

22 *SEC. 219. Notwithstanding any other provision of law,*
23 *the recipient of a grant under section 202b of the Housing*
24 *Act of 1959 (12 U.S.C. 1701q) after December 26, 2000,*
25 *in accordance with the unnumbered paragraph at the end*

1 of section 202(b) of such Act, may, at its option, establish
2 a single-asset nonprofit entity to own the project and may
3 lend the grant funds to such entity, which may be a private
4 nonprofit organization described in section 831 of the
5 American Homeownership and Economic Opportunity Act
6 of 2000.

7 SEC. 220. (a) The amounts provided under the sub-
8 heading “Program Account” under the heading “Commu-
9 nity Development Loan Guarantees” may be used to guar-
10 antee, or make commitments to guarantee, notes, or other
11 obligations issued by any State on behalf of non-entitlement
12 communities in the State in accordance with the require-
13 ments of section 108 of the Housing and Community Devel-
14 opment Act of 1974: Provided, That, any State receiving
15 such a guarantee or commitment shall distribute all funds
16 subject to such guarantee to the units of general local gov-
17 ernment in non-entitlement areas that received the commit-
18 ment.

19 (b) Not later than 60 days after the date of enactment
20 of this Act, the Secretary of Housing and Urban Develop-
21 ment shall promulgate regulations governing the adminis-
22 tration of the funds described under subsection (a).

23 SEC. 221. Section 24 of the United States Housing Act
24 of 1937 (42 U.S.C. 1437v) is amended—

1 (1) in subsection (m)(1), by striking “2009” and
2 inserting “2010”; and

3 (2) in subsection (o), by striking “September 30,
4 2009” and inserting “September 30, 2010”.

5 *SEC. 222. Public housing agencies that own and oper-*
6 *ate 400 or fewer public housing units may elect to be exempt*
7 *from any asset management requirement imposed by the*
8 *Secretary of Housing and Urban Development in connec-*
9 *tion with the operating fund rule: Provided, That an agency*
10 *seeking a discontinuance of a reduction of subsidy under*
11 *the operating fund formula shall not be exempt from asset*
12 *management requirements.*

13 *SEC. 223. With respect to the use of amounts provided*
14 *in this Act and in future Acts for the operation, capital*
15 *improvement and management of public housing as author-*
16 *ized by sections 9(d) and 9(e) of the United States Housing*
17 *Act of 1937 (42 U.S.C. 1437g(d) and (e)), the Secretary*
18 *shall not impose any requirement or guideline relating to*
19 *asset management that restricts or limits in any way the*
20 *use of capital funds for central office costs pursuant to sec-*
21 *tion 9(g)(1) or 9(g)(2) of the United States Housing Act*
22 *of 1937 (42 U.S.C. 1437g(g)(1), (2)): Provided, That a pub-*
23 *lic housing agency may not use capital funds authorized*
24 *under section 9(d) for activities that are eligible under sec-*
25 *tion 9(e) for assistance with amounts from the operating*

1 *fund in excess of the amounts permitted under section*
2 *9(g)(1) or 9(g)(2).*

3 *SEC. 224. The Secretary of Housing and Urban Devel-*
4 *opment shall report quarterly to the House of Representa-*
5 *tives and Senate Committees on Appropriations on the sta-*
6 *tus of all section 8 project-based housing, including the*
7 *number of all project-based units by region as well as an*
8 *analysis of all federally subsidized housing being refinanced*
9 *under the Mark-to-Market program. The Secretary shall in*
10 *the report identify all existing units maintained by region*
11 *as section 8 project-based units and all project-based units*
12 *that have opted out of section 8 or have otherwise been*
13 *eliminated as section 8 project-based units. The Secretary*
14 *shall identify in detail and by project all the efforts made*
15 *by the Department to preserve all section 8 project-based*
16 *housing units and all the reasons for any units which opted*
17 *out or otherwise were lost as section 8 project-based units.*
18 *Such analysis shall include a review of the impact of the*
19 *loss of any subsidized units in that housing marketplace,*
20 *such as the impact of cost and the loss of available sub-*

 23 *based rental housing assistance programs of the De-*
 24 *partment of Housing and Urban Development, in-*
 25 *cluding the rent supplement program under section*

1 *101 of the Housing and Urban Development Act of*
2 *1965 (12 U.S.C. 1701s)) or any successor project-*
3 *based rental assistance program, except as provided*
4 *by subsection (a)(2)(B); and*

5 *(2) the prepayment may involve refinancing of*
6 *the loan if such refinancing results—*

7 *(A) in a lower interest rate on the principal*
8 *of the loan for the project and in reductions in*
9 *debt service related to such loan; or*

10 *(B) in the case of a project that is assisted*
11 *with a loan under such section 202 carrying an*
12 *interest rate of 6 percent or lower, a transaction*
13 *under which—*

14 *(i) the project owner shall address the*
15 *physical needs of the project;*

16 *(ii) the prepayment plan for the trans-*
17 *action, including the refinancing, shall meet*
18 *a cost benefit analysis, as established by the*
19 *Secretary, that the benefit of the transaction*
20 *outweighs the cost of the transaction includ-*
21 *ing any increases in rent charged to unas-*
22 *sisted tenants;*

23 *(iii) the overall cost for providing rent-*
24 *al assistance under section 8 for the project*

1 *(if any) is not increased, except, upon ap-*
2 *proval by the Secretary to—*

3 *(I) mark-up-to-market contracts*
4 *pursuant to section 524(a)(3) of the*
5 *Multifamily Assisted Housing Reform*
6 *and Affordability Act (42 U.S.C. 1437f*
7 *note), as such section is carried out by*
8 *the Secretary for properties owned by*
9 *nonprofit organizations; or*

10 *(II) mark-up-to-budget contracts*
11 *pursuant to section 524(a)(4) of the*
12 *Multifamily Assisted Housing Reform*
13 *and Affordability Act (42 U.S.C. 1437f*
14 *note), as such section is carried out by*
15 *the Secretary for properties owned by*
16 *eligible owners (as such term is de-*
17 *finied in section 202(k) of the Housing*
18 *Act of 1959 (12 U.S.C. 1701q(k));*

19 *(iv) the project owner may charge ten-*
20 *ants rent sufficient to meet debt service pay-*
21 *ments and operating cost requirements, as*
22 *approved by the Secretary, if project-based*
23 *rental assistance is not available or is in-*
24 *sufficient for the debt service and operating*

1 *cost of the project after refinancing. Such*
2 *approval by the Secretary—*

3 *(I) shall be the basis for the owner*
4 *to agree to terminate the project-based*
5 *rental assistance contract that is insuf-*
6 *ficient for the debt service and oper-*
7 *ating cost of the project after refi-*
8 *nancing; and*

9 *(II) shall be an eligibility event*
10 *for the project for purposes of section*
11 *8(t) of the United States Housing Act*
12 *of 1937 (42 U.S.C. 1437f(t));*

13 *(v) units to be occupied by tenants as-*
14 *sisted under section 8(t) of the United*
15 *States Housing Act of 1937 (42 U.S.C.*
16 *1437f(t)) shall, upon termination of the oc-*
17 *cupancy of such tenants, become eligible for*
18 *project-based assistance under section*
19 *8(o)(13) of the United States Housing Act*
20 *of 1937 (42 U.S.C. 1437f(o)(13)) without*
21 *regard to the percentage limitations pro-*
22 *vided in such section; and*

23 *(vi) there shall be a use agreement of*
24 *20 years from the date of the maturity date*
25 *of the original 202 loan for all units, in-*

1 cluding units to be occupied by tenants as-
 2 sisted under section 8(t) of the United
 3 States Housing Act of 1937 (42 U.S.C.
 4 1437f(t)).

5 USE OF SURPLUS FEDERAL PROPERTY FOR THE HOMELESS

6 SEC. 229. No property identified by the Secretary of
 7 Housing and Urban Development as surplus Federal prop-
 8 erty for use to assist the homeless shall be made available
 9 to any homeless group unless the group is a member in good
 10 standing under any of HUD's homeless assistance programs
 11 or is in good standing with any other program which re-
 12 ceives funds from any other Federal or State agency or enti-
 13 ty: Provided, That an exception may be made for an entity
 14 not involved with Federal homeless programs to use surplus
 15 Federal property for the homeless only after the Secretary
 16 or another responsible Federal agency has fully and com-
 17 prehensively reviewed all relevant finances of the entity, the
 18 track record of the entity in assisting the homeless, the abil-
 19 ity of the entity to manage the property, including all costs,
 20 the ability of the entity to administer homeless programs
 21 in a manner that is effective to meet the needs of the home-
 22 less population that is expected to use the property and any
 23 other related issues that demonstrate a commitment to as-
 24 sist the homeless: Provided further, That the Secretary shall
 25 not require the entity to have cash in hand in order to dem-

1 *onstrate financial ability but may rely on the entity's prior*
 2 *demonstrated fundraising ability or commitments for in-*
 3 *kind donations of goods and services: Provided further, That*
 4 *the Secretary shall make all such information and its deci-*
 5 *sion regarding the award of the surplus property available*
 6 *to the committees of jurisdiction, including a full justifica-*
 7 *tion of the appropriateness of the use of the property to as-*
 8 *sist the homeless as well as the appropriateness of the group*
 9 *seeking to obtain the property to use such property to assist*
 10 *the homeless: Provided further, That, this section shall*
 11 *apply to properties in fiscal year 2009 and 2010 made*
 12 *available as surplus Federal property for use to assist the*
 13 *homeless.*

14 *SEC. 230. The Secretary of Housing and Urban Devel-*
 15 *opment shall increase, pursuant to this section, the number*
 16 *of Moving-to-Work agencies authorized under section 204,*
 17 *title II, of the Departments of Veterans Affairs and Housing*
 18 *and Urban Development and Independent Agencies Appro-*
 19 *priations Act, 1996 (Public Law 104–134; 110 Stat. 1321)*
 20 *by adding to the program three Public Housing Agencies*
 21 *that meet the following requirements: is a High Performing*
 22 *Agency under the Public Housing Assessment System*
 23 *(PHAS). No PHA shall be granted this designation through*
 24 *this section that administers in excess of 5,000 aggregate*
 25 *housing vouchers and public housing units. No PHA grant-*

1 *ed this designation through this section shall receive more*
2 *funding under sections 8 or 9 of the United States Housing*
3 *Act of 1937 than they otherwise would have received absent*
4 *this designation. In addition to other reporting require-*
5 *ments, all Moving-to-Work agencies shall report financial*
6 *data to the Department of Housing and Urban Develop-*
7 *ment as specified by the Secretary, so that the effect of Mov-*
8 *ing-to-Work policy changes can be measured.*

9 *SEC. 231. Notwithstanding any other provision of law,*
10 *in determining the market value of any multifamily real*

14 *appraisal practices, including the cost of repairs needed to*

 5 *percent by all such transfers.*

6 *SEC. 233. The Disaster Housing Assistance Programs,*
 7 *administered by the Department of Housing and Urban De-*
 8 *velopment, shall be considered a “program of the Depart-*
 9 *ment of Housing and Urban Development” under section*
 10 *904 of the McKinney Act for the purpose of income*
 11 *verifications and matching.*

5 *SEC. 404. The expenditure of any appropriation under*
6 *this Act for any consulting service through procurement*
7 *contract pursuant to section 3109 of title 5, United States*
8 *Code, shall be limited to those contracts where such expendi-*
9 *tures are a matter of public record and available for public*
10 *inspection, except where otherwise provided under existing*

13 *not later than 60 days after the date of enactment of this*
14 *Act, each agency funded by this Act shall submit a report*
15 *to the Committees on Appropriations of the Senate and of*
16 *the House of Representatives to establish the baseline for*
17 *application of reprogramming and transfer authorities for*

20 are funded under this Act shall issue a report to the House
21 and Senate Committees on Appropriations on all sole
22 source contracts by no later than July 30, 2010. Such report
23 shall include the contractor, the amount of the contract and
24 the rationale for using a sole source contract.

1 *SEC. 408. (a) None of the funds made available in this*
2 *Act may be obligated or expended for any employee training*

4 *(1) does not meet identified needs for knowledge,*
5 *skills, and abilities bearing directly upon the perform-*

24 *SEC. 409. No funds in this Act may be used to support*

1 *power of eminent domain, unless eminent domain is em-*
 2 *ployed only for a public use: Provided, That for purposes*
 3 *of this section, public use shall not be construed to include*
 4 *economic development that primarily benefits private enti-*

23 *SEC. 411. No part of any appropriation contained in*
 24 *this Act shall be available to pay the salary for any person*
 25 *filling a position, other than a temporary position, formerly*

1 *held by an employee who has left to enter the Armed Forces*
2 *of the United States and has satisfactorily completed his*
3 *period of active military or naval service, and has within*
4 *90 days after his release from such service or from hos-*
5 *pitalization continuing after discharge for a period of not*
6 *more than 1 year, made application for restoration to his*
7 *former position and has been certified by the Office of Per-*
8 *sonnel Management as still qualified to perform the duties*
9 *of his former position and has not been restored thereto.*

10 *SEC. 412. No funds appropriated pursuant to this Act*
11 *may be expended by an entity unless the entity agrees that*
12 *in expending the assistance the entity will comply with sec-*
13 *tions 2 through 4 of the Act of March 3, 1933 (41 U.S.C.*
14 *10a–10c, popularly known as the “Buy American Act”).*

15 *SEC. 413. No funds appropriated or otherwise made*
16 *available under this Act shall be made available to any per-*
17 *son or entity that has been convicted of violating the Buy*
18 *American Act (41 U.S.C. 10a–10c).*

19 *SEC. 414. All departments, agencies or other Federal*
20 *entities funded under this Act shall notify the Senate and*
21 *House of Representatives Committees on Appropriations no*
22 *later than 7 days before any public or internet announce-*
23 *ment by the Department or Administration regarding any*
24 *new program or activity, including any changes to existing*
25 *or proposed programs or activities.*

2 *ing and Urban Development, and Related Agencies Appro-*
