# **A BILL**

To designate the Federal building under construction at 1220 Echelon Parkway in Jackson, Mississippi, as the “Chaney, Goodman, Schwerner Federal Building”.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. BUILDING DESIGNATION.**

4 The Federal building under construction at 1220  
5 Echelon Parkway in Jackson, Mississippi, shall be known  
6 and designated as the “Chaney, Goodman, Schwerner  
7 Federal Building”.

8 **SEC. 2. REFERENCES.**

9 Any reference in a law, map, regulation, document,  
10 paper, or other record of the United States to the building  
11 referred to in section 1 shall be deemed to be a reference  
12 to the “Chaney, Goodman, Schwerner Federal Building”.

13 **SECTION 1. BUILDING DESIGNATION.**

14 *The Administrator of General Services shall ensure*  
15 *that the federally occupied building located at 1220 Echelon*  
16 *Parkway in Jackson, Mississippi, is known and designated*  
17 *as the “James Chaney, Andrew Goodman, and Michael*  
18 *Schwerner Federal Building”.*

19 **SEC. 2. REFERENCES.**

20 *With respect to the period in which the building re-*  
21 *ferred to in section 1 is federally occupied, any reference*  
22 *in a law, map, regulation, document, paper, or other record*  
23 *of the United States to that building shall be deemed to*  
24 *be a reference to the “James Chaney, Andrew Goodman,*  
25 *and Michael Schwerner Federal Building”.*

Amend the title so as to read: “A bill to designate the federally occupied building located at 1220 Echelon Parkway in Jackson, Mississippi, as the ‘James Chaney, Andrew Goodman, and Michael Schwerner Federal Building’.”.
