## AN ACT

To extend the Generalized System of Preferences and the Andean Trade Preference Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. EXTENSION OF GENERALIZED SYSTEM OF**  
2 **PREFERENCES.**

3 Section 505 of the Trade Act of 1974 (19 U.S.C.  
4 2465) is amended by striking “December 31, 2009” and  
5 inserting “December 31, 2010”.

6 **SEC. 2. EXTENSION OF ANDEAN TRADE PREFERENCE ACT.**

7 (a) EXTENSION.—Section 208(a) of the Andean  
8 Trade Preference Act (19 U.S.C. 3206(a)) is amended in  
9 paragraphs (1) and (2) by striking “December 31, 2009”  
10 each place it appears and inserting “December 31, 2010”.

11 (b) TREATMENT OF CERTAIN APPAREL ARTICLES.—  
12 Section 204(b)(3) of the Andean Trade Preference Act  
13 (19 U.S.C. 3203(b)(3)) is amended—

14 (1) in subparagraph (B)—

15 (A) in clause (iii)—

16 (i) in subclause (II), by striking “7  
17 succeeding 1-year periods” and inserting  
18 “8 succeeding 1-year periods”; and

19 (ii) in subclause (III)(bb), by striking  
20 “and for the succeeding 2-year period” and  
21 inserting “and for the succeeding 3-year  
22 period”; and

23 (B) in clause (v)(II), by striking “6 suc-  
24 ceeding 1-year periods” and inserting “7 suc-  
25 ceeding 1-year periods”; and

1           (2) in subparagraph (E)(ii)(II), by striking  
2           “December 31, 2009” and inserting “December 31,  
3           2010”.

4           (c) REPORT.—Section 203(f)(1) of the Andean Trade  
5 Preference Act (19 U.S.C. 3202(f)(1)) is amended by  
6 striking “April 30, 2003” and inserting “June 30, 2010”.

7 **SEC. 3. CUSTOMS USER FEES.**

8           Section 13031(j)(3) of the Consolidated Omnibus  
9 Budget Reconciliation Act of 1985 (19 U.S.C. 58c(j)(3))  
10 is amended—

11           (1) in subparagraph (A), by striking “February  
12           14, 2018” and inserting “May 14, 2018”; and

13           (2) in subparagraph (B)(i), by striking “Feb-  
14           ruary 7, 2018” and inserting “June 7, 2018”.

15 **SEC. 4. TIME FOR PAYMENT OF CORPORATE ESTIMATED**  
16 **TAXES.**

17           The percentage under paragraph (1) of section  
18 202(b) of the Corporate Estimated Tax Shift Act of 2009  
19 in effect on the date of the enactment of this Act is in-  
20 creased by 1.5 percentage points.
