## A BILL

To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to direct the President to take actions to address the needs of children and families who are victims of a major disaster, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "Kids Wish II Act".

#### 1 SEC. 2. DEFINITIONS.

- 2 Section 102 of the Robert T. Stafford Disaster Relief
- 3 and Emergency Assistance Act (42 U.S.C. 5122) is
- 4 amended—
- 5 (1) in paragraph (9)(C) by inserting "child
- 6 care," after "educational,";
- 7 (2) in paragraph (10)(A) by inserting "child
- 8 care," after "educational,"; and
- 9 (3) by adding at the end the following:
- 10 "(11) CHILDREN.—The term 'children' means
- individuals who are 18 years of age or younger.
- 12 "(12) EMERGENCY CHILD CARE.—The term
- 13 'emergency child care' means supervision, recreation,
- and other services offered by a State or local govern-
- ment (or a child care provider regulated by a State)
- 16 for the purpose of providing nonparental care for
- 17 children in the event of a major disaster or emer-
- 18 gency.".
- 19 SEC. 3. ELIGIBILITY OF FOR-PROFIT CHILD CARE FACILI-
- 20 TIES FOR DISASTER ASSISTANCE.
- 21 Title I of the Robert T. Stafford Disaster Relief and
- 22 Emergency Assistance Act (42 U.S.C. 5121 et seq.) is
- 23 amended by adding at the end the following:
- 24 "SEC. 103. FOR-PROFIT CHILD CARE FACILITIES.
- 25 "Notwithstanding any other provision of this Act, a
- 26 private for-profit child care facility shall be eligible for as-

1	sistance under this Act to the same extent as a private
2	nonprofit child care facility.".
3	SEC. 4. DISASTER PLANNING.
4	Title III of the Robert T. Stafford Disaster Relief
5	and Emergency Assistance Act (42 U.S.C. 5141 et seq.)
6	is amended by adding at the end the following:
7	"SEC. 327. DISASTER PLANNING TO ADDRESS NEEDS OF
8	CHILDREN AND FAMILIES.
9	"(a) State and Local Disaster Planning.—
10	"(1) In general.—The President shall encour-
11	age States and localities to include consideration of
12	services and facilities for children within all phases
13	of their disaster planning, training, and exercises.
14	"(2) Services and facilities for children
15	DEFINED.—In this subsection, the term 'services
16	and facilities for children' includes—
17	"(A) health and mental health services and
18	facilities for children;
19	"(B) school services and facilities;
20	"(C) child care services and facilities;
21	"(D) services and facilities associated with
22	early education programs, including the Head
23	Start program;
24	"(E) juvenile corrections, detention, and
25	court services and facilities.

1	"(F) child welfare services and facilities;
2	and
3	"(G) residential care services and facilities
4	for children, including residential treatment
5	centers and group homes.
6	"(b) National Disaster Planning.—The Presi-
7	dent shall take such actions as may be necessary to include
8	the provision of services and facilities for children within
9	national planning activities, including the National Re-
10	sponse Framework and the National Disaster Recovery
11	Framework.
12	"(c) Specific Measurable Capabilities of Dis-
13	ASTER PLANS.—The President shall ensure, to the max-
14	imum extent practicable, that disaster plans for services
15	and facilities for children, at a minimum, incorporate spe-
16	cific measurable capabilities for shelter-in-place, evacu-
17	ation, relocation, family reunification, temporary oper-
18	ating standards, and accommodation of children with dis-
19	abilities and chronic health needs and other special needs
20	child populations.".
21	SEC. 5. DISASTER ASSISTANCE FOR CHILD CARE SERVICES
22	AND FACILITIES.
23	(a) Essential Assistance.—Section 403(a)(3) of
24	the Robert T. Stafford Disaster Relief and Emergency As-
25	sistance Act (42 II S.C. 5170b(a)(3)) is amended—

(1) in subparagraph (D) by inserting ", child 1 2 care," after "schools"; (2) by striking "and" at the end of subpara-3 4 graph (I); 5 (3) by striking the period at the end of sub-6 paragraph (J) and inserting "; and"; and 7 (4) by adding at the end the following: "(K) provision of emergency child care and 8 9 assistance to families for child placement in 10 emergency child care.". 11 (b) REPAIR, RESTORATION, AND REPLACEMENT OF DAMAGED FACILITIES.—Section 406(a)(3)(B) of such Act 12 (42 U.S.C. 5172(a)(3)(B)) is amended by inserting "child 13 care," after "education,". 14 15 (c) Federal Assistance to Individuals and Households.—Section 408(e)(2) of such Act (42 U.S.C. 16 17 5174(e)(2)) is amended— 18 (1) in the paragraph heading by inserting "CHILD CARE," after "TRANSPORTATION,"; and 19 (2) by inserting "child care," after "transpor-20 21 tation.". 22 SEC. 6. CASE MANAGEMENT SERVICES. 23 Section 426 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5189d) is amended— 25

1	(1) by inserting "(a) In General.—" before
2	"The President"; and
3	(2) by adding at the end the following:
4	"(b) Program Requirements.—
5	"(1) Emphasis on Children and Families.—
6	In carrying out this section, the President shall es-
7	tablish a single Federal disaster case management
8	program with an emphasis on achieving tangible
9	positive outcomes for all children and families who
10	are victims of a major disaster.
11	"(2) Components.—The program shall—
12	"(A) adequately address the physical
13	health, mental health, nutrition, education,
14	housing, transportation, and other human serv-
15	ices needs of children and families who are vic-
16	tims of a major disaster;
17	"(B) provide for the involvement of non-
18	profit agencies that provide disaster case man-
19	agement services;
20	"(C) provide access to funding that sup-
21	ports all aspects of disaster case management.
22	including direct services to survivors;
23	"(D) provide for a single point of contact
24	for disaster assistance applicants who need a

1	wide variety of services that may be provided by
2	many different organizations; and
3	"(E) provide funding to support case man-
4	ager training.".
5	SEC. 7. ASSISTANCE TO MEET NEEDS OF CHILDREN AND
6	FAMILIES.
7	Title IV of the Robert T. Stafford Disaster Relief and
8	Emergency Assistance Act (42 U.S.C. 5170 et seq.) is
9	amended—
10	(1) by redesignating the second section 425, re-
11	lating to essential service providers, as section 427;
12	and
13	(2) by adding at the end the following:
14	"SEC. 428. ASSISTANCE TO MEET NEEDS OF CHILDREN AND
15	FAMILIES.
16	"(a) Mass Care Shelters.—
17	"(1) In general.—The President may provide
18	mass care shelters for victims of major disasters.
19	Such shelters shall provide a safe and secure mass
20	care shelter environment for children, including ap-
21	propriate access to essential services and supplies.
22	"(2) Standards.—In carrying out this sub-
23	section, the President shall—

1	"(A) develop and implement national
2	standards and indicators for mass care shelters
3	that are specific and responsive to children;
4	"(B) develop a list of essential age-appro-
5	priate shelter supplies for infants and children
6	and fund the addition of child-specific supplies
7	to caches for immediate deployment to support
8	shelter operations;
9	"(C) ensure the implementation of stand-
10	ards and training to mitigate risks unique to
11	children in shelters, including child abduction
12	and sex offenders; and
13	"(D) ensure all shelter operators have ac-
14	cess to a fast, accurate, and low-cost system for
15	conducting national fingerprint-based criminal
16	history background checks for shelter workers
17	and volunteers.
18	"(b) Housing.—The President—
19	"(1) shall give priority to families with children
20	in providing disaster housing assistance under this
21	title; and
22	"(2) may provide financial and other assistance
23	for individuals and families who are victims of a
24	major disaster to ensure an expedited transition into
25	permanent housing, especially for families with chil-

- dren who have disabilities or other special health,
- 2 mental health, or educational needs.
- 3 "(c) EVACUATION.—The President, in coordination
- 4 with the heads of other appropriate Federal agencies, shall
- 5 develop a standardized, interoperable national evacuee
- 6 tracking and family reunification system that ensures the
- 7 safety and well-being of children.".
- 8 SEC. 8. DISASTER RELATED INFORMATION SERVICES.
- 9 Section 616(a)(2)(B) of the Robert T. Stafford Dis-
- 10 aster Relief and Emergency Assistance Act (42 U.S.C.
- 11 5196f(a)(2)(B)) is amended by inserting "children and"
- 12 before "individuals with disabilities".
