1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION OF THE STEWART LEE UDALL**

4 **DEPARTMENT OF THE INTERIOR BUILDING.**

5 The Department of the Interior Building located at  
6 1849 C Street, Northwest, in Washington, District of Co-  
7 lumbia, shall be known and designated as the “Stewart  
8 Lee Udall Department of the Interior Building”.

9 **SEC. 2. REFERENCES TO THE BUILDING.**

10 Any reference in a law, map, regulation, document,  
11 record, or other paper of the United States to the building  
12 described in section 1 shall be considered to be a reference  
13 to the “Stewart Lee Udall Department of the Interior  
14 Building”.

15 **SECTION 1. DESIGNATION.**

16 *The United States Department of the Interior Build-*  
17 *ing located at 1849 C Street, Northwest, in Washington,*  
18 *District of Columbia, shall be known and designated as the*  
19 *“Stewart Lee Udall Department of the Interior Building”.*

20 **SEC. 2. REFERENCES.**

21 *Any reference in a law, map, regulation, document,*  
22 *record, or other paper of the United States to the building*  
23 *referred to in section 1 shall be considered to be a reference*  
24 *to the “Stewart Lee Udall Department of the Interior*  
25 *Building”.*

Amend the title so as to read: “A bill to designate the United States Department of the Interior Building in Washington, District of Columbia, as the ‘Stewart Lee Udall Department of the Interior Building’.”.
