A BILL

To amend title 36, United States Code, to include in the Federal charter of the Reserve Officers Association leadership positions newly added in its constitution and bylaws.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Reserve Officers Asso-
5 ciation Modernization Act of 2009”.

1 **SEC. 2. INCLUSION OF NEW LEADERSHIP POSITIONS IN**
2 **THE FEDERAL CHARTER OF THE RESERVE**
3 **OFFICERS ASSOCIATION.**

4 (a) NATIONAL EXECUTIVE COMMITTEE.—Section
5 190104(b)(2) of title 36, United States Code, is amend-
6 ed—

7 (1) by inserting “the president elect,” after
8 “the president,”;

9 (2) by inserting “a minimum of” before “3 na-
10 tional executive committee members,”; and

11 (3) by striking “except the executive director,”
12 and inserting “except the president elect and the ex-
13 ecutive director,”.

14 (b) OFFICERS.—Section 190104(c) of such title is
15 amended—

16 (1) in paragraph (1)—

17 (A) by inserting “a president elect,” after
18 “a president,”;

19 (B) by inserting “a minimum of” before
20 “3 national executive committee members,”;

21 (C) by striking “a surgeon, a chaplain, a
22 historian, a public relations officer,”; and

23 (D) by striking “as decided at the national
24 convention” and inserting “specified in the con-
25 stitution of the corporation”; and

26 (2) in paragraph (2)—

1 (A) by inserting “and take office” after
2 “be elected”; and

3 (B) by striking “and the national public
4 relations officer,” and inserting “the judge ad-
5 vocate, and any other national officers specified
6 in the constitution of the corporation,”.

7 (c) VACANCIES.—Section 190104(d)(1) of such title
8 is amended by striking “president and last past presi-
9 dent,” and inserting “president, president elect, and last
10 past president,”.

11 (d) RECORDS AND INSPECTION.—Section
12 190109(a)(2) of such title is amended by striking “na-
13 tional council;” and inserting “other national entities of
14 the corporation;”.
