A BILL

To amend title 36, United States Code, to include in the Federal charter of the Reserve Officers Association leadership positions newly added in its constitution and bylaws.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Reserve Officers Asso-
3 ciation Modernization Act of 2009”.

4 **SEC. 2. INCLUSION OF NEW LEADERSHIP POSITIONS IN**
5 **THE FEDERAL CHARTER OF THE RESERVE**
6 **OFFICERS ASSOCIATION.**

7 (a) NATIONAL EXECUTIVE COMMITTEE.—Section
8 190104(b)(2) of title 36, United States Code, is amend-
9 ed—

10 (1) by inserting “the president elect,” after
11 “the president,”;

12 (2) by inserting “a minimum of” before “3 na-
13 tional executive committee members,”; and

14 (3) by striking “except the executive director,”
15 and inserting “except the president elect and the ex-
16 ecutive director,”.

17 (b) OFFICERS.—Section 190104(c) of such title is
18 amended—

19 (1) in paragraph (1)—

20 (A) by inserting “a president elect,” after
21 “a president,”;

22 (B) by inserting “a minimum of” before
23 “3 national executive committee members,”;

24 (C) by striking “a surgeon, a chaplain, a
25 historian, a public relations officer,”; and

1 (D) by striking “as decided at the national
2 convention” and inserting “specified in the con-
3 stitution of the corporation”; and

4 (2) in paragraph (2)—

5 (A) by inserting “and take office” after
6 “be elected”; and

7 (B) by striking “and the national public
8 relations officer,” and inserting “the judge ad-
9 vocate, and any other national officers specified
10 in the constitution of the corporation,”.

11 (c) VACANCIES.—Section 190104(d)(1) of such title
12 is amended by striking “president and last past presi-
13 dent,” and inserting “president, president elect, and last
14 past president,”.

15 (d) RECORDS AND INSPECTION.—Section
16 190109(a)(2) of such title is amended by striking “na-
17 tional council;” and inserting “other national entities of
18 the corporation;”.
