# **A BILL**

To amend the Public Health Service Act to convert funding for graduate medical education in qualified teaching health centers from direct appropriations to an authorization of appropriations.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CONVERTING FUNDING FOR GRADUATE MED-**  
4 **ICAL EDUCATION IN QUALIFIED TEACHING**  
5 **HEALTH CENTERS FROM DIRECT APPRO-**  
6 **PRIATIONS TO AN AUTHORIZATION OF AP-**  
7 **PROPRIATIONS.**

8 (a) IN GENERAL.—Section 340H of the Public  
9 Health Service Act (42 U.S.C. 256h), as added by section  
10 5508(c) of the Patient Protection and Affordable Care Act  
11 (Public Law 111–148), is amended—

12 (1) in subsection (b)(2)(A), by striking “under  
13 subsection (g)” each place it appears and inserting  
14 “pursuant to subsection (g)”;

15 (2) in subsection (d)(2)(B), by striking “in sub-  
16 section (g)” and inserting “pursuant to subsection  
17 (g)”;

18 (3) by amending subsection (g) to read as fol-  
19 lows:

20 “(g) AUTHORIZATION OF APPROPRIATIONS.—To  
21 carry out this section, there are authorized to be appro-  
22 priated \$46,000,000 for each of fiscal years 2012 through  
23 2015.”.

1           (b) RESCISSION OF UNOBLIGATED FUNDS.—Of the  
2 amounts made available by such section 340H (42 U.S.C.  
3 256h), the unobligated balance is rescinded.

4           (c) TECHNICAL CORRECTION.—The second subpart  
5 XI of part D of title III of the Public Health Service Act  
6 (42 U.S.C. 256i), as added by section 10333 of the Pa-  
7 tient Protection and Affordable Care Act (Public Law  
8 111–148), is amended—

9                   (1) by redesignating subpart XI as subpart XII;

10           and

11                   (2) by redesignating section 340H of the Public  
12           Health Service Act (42 U.S.C. 256i) as section 340I.
