# **A BILL**

To remove restrictions from a parcel of land situated in  
the Atlantic District, Accomack County, Virginia.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REMOVAL OF RESTRICTIONS.**

4        (a) *REMOVAL.*—*Not later than 90 days after the date*  
5 *of the enactment of this Act, the Secretary of the Interior*  
6 *shall execute such instruments as may be necessary to re-*  
7 *move all deed restrictions described in subsection (b) relat-*  
8 *ing to the parcel of land described in subsection (c).*

9        (b) *DEED RESTRICTIONS.*—*The deed restrictions re-*  
10 *ferred to in subsection (a) are those restrictions, including*  
11 *easements, exceptions, reservations, terms, conditions, and*  
12 *covenants described in Quitclaim Deed No. 17808A from*  
13 *the United States to Accomack County, Virginia, executed*  
14 *on December 20, 1976, and recorded among the real estate*  
15 *records of Accomack County, Virginia, by the Clerk of the*  
16 *Circuit Court, on pages 292 through 296 of Deed Book 381.*

17        (c) *DESCRIPTION OF LAND.*—*The parcel of land re-*  
18 *ferred to in subsection (a) consists of approximately 31.6*  
19 *acres situated in the Atlantic District, Accomack County,*  
20 *Virginia, more particularly described in the metes and*  
21 *bounds description recorded on page 292 of the quitclaim*  
22 *deed described in subsection (b).*
