## A BILL

To designate certain National Forest System lands and public lands under the jurisdiction of the Secretary of the Interior in the States of Idaho, Montana, Oregon, Washington, and Wyoming as wilderness and wild and scenic rivers, to provide for the establishment of a Northern Rockies Wildlife Habitat and Corridors Information System and Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

 5 “Northern Rockies Ecosystem Protection Act”.

### 1 **SEC. 2. PURPOSES.**

2 The purposes of this Act are—

3 (1) to designate certain National Forest System  
4 land, certain National Park System land, and cer-  
5 tain public land administered by the Bureau of Land  
6 Management in Idaho, Montana, Oregon, Wash-  
7 ington, and Wyoming as components of the National  
8 Wilderness Preservation System;

9 (2) to designate certain National Forest System  
10 land, public land administered by the Bureau of  
11 Land Management, and waterways on these lands in  
12 Montana, Idaho, and Wyoming as components of the  
13 National Wild and Scenic River System; and

14 (3) to establish an integrated Federal program  
15 to protect, restore, and conserve natural resources in  
16 response to threats of climate change.

### 17 **SEC. 3. DEFINITIONS.**

18 In this Act:

19 (1) **CORRIDORS.**—The term “corridors” means  
20 areas that provide connectivity of habitat or poten-  
21 tial habitat and that facilitate the ability of terres-  
22 trial, estuarine, and freshwater fish, or wildlife to

1 move within a landscape as needed for migration,  
2 gene flow, or dispersal, or in response to the impacts  
3 of climate change or other impacts.

4 (2) HABITAT.—The term “habitat” means the  
5 physical, chemical, and biological properties that are  
6 used by fish, wildlife, or plants for growth, reproduc-  
7 tion, survival, food, water, and cover, on a tract of  
8 land, in a body of water, or in an area or region.

9 (3) INDIAN TRIBE.—The term “Indian tribe”  
10 has the meaning given the term in section 4 of the  
11 Indian Self-Determination and Education Assistance  
12 Act (25 U.S.C. 450b).

13 (4) NATURAL RESOURCES.—The term “natural  
14 resources” means the terrestrial, freshwater, estua-  
15 rine, and marine fish, wildlife, plants, land, water,  
16 habitats, and ecosystems of the United States.

17 (5) NATURAL RESOURCES ADAPTATION.—The  
18 term “natural resources adaptation” means the pro-  
19 tection, restoration, and conservation of natural re-  
20 sources to enable them to become more resilient,  
21 adapt to, and withstand the impacts of climate  
22 change.

23 (6) PUBLIC LAND.—The term “public land”  
24 has the meaning given the term in section 103(e) of

1 the Federal Land Policy and Management Act of  
2 1976 (43 U.S.C. 1702(e)).

3 (7) RESILIENCE.—The terms “resilience” and  
4 “resilient” means the ability to resist or recover  
5 from disturbance and preserve diversity, produc-  
6 tivity, and sustainability.

7 (8) SECRETARY CONCERNED.—The term “Sec-  
8 retary concerned” means—

9 (A) the Secretary of Agriculture, with re-  
10 spect to National Forest System lands; and

11 (B) the Secretary of the Interior, with re-  
12 spect to National Park System lands and public  
13 land.

## 14 **TITLE I—DESIGNATION OF** 15 **WILDERNESS**

### 16 **Subtitle A—Designation**

17 **SEC. 101. PURPOSE AND EFFECT OF DESIGNATION OF CER-**  
18 **TAIN NATIONAL FOREST SYSTEM LAND, NA-**  
19 **TIONAL PARK SYSTEM LAND, AND PUBLIC**  
20 **LAND AS WILDERNESS.**

21 In furtherance of the purposes of the Wilderness Act  
22 (16 U.S.C. 1131 et seq.), certain National Forest System  
23 land, National Park System land, and public land in the  
24 States of Idaho, Montana, Oregon, Washington, and Wyo-  
25 ming are designated as wilderness and as either a new

1 component of the National Wilderness Preservation Sys-  
2 tem or as an addition to an existing component of the Na-  
3 tional Wilderness Preservation System, as described in  
4 this subtitle.

5 **SEC. 102. IDAHO WILDERNESS DESIGNATIONS.**

6 (a) CARIBOU-TARGHEE NATIONAL FOREST.—

7 (1) ADDITIONS TO MOUNT NAOMI WILDER-  
8 NESS.—Certain Federal land within the Caribou-  
9 Targhee National Forest comprising approximately  
10 28,000 as generally depicted on the map entitled  
11 “\_\_\_\_\_” and dated \_\_\_\_\_, which  
12 shall be added to and administered as part of the  
13 Mount Naomi Wilderness.

14 (2) NEW COMPONENTS OF NATIONAL WILDER-  
15 NESS PRESERVATION SYSTEM.—

16 (A) GARNS MOUNTAIN WILDERNESS.—Cer-  
17 tain Federal land within the Caribou-Targhee  
18 National Forest comprising approximately  
19 104,000 acres as generally depicted on the map  
20 entitled “\_\_\_\_\_” and dated  
21 \_\_\_\_\_, which shall be known as the  
22 Garns Mountain Wilderness.

23 (B) ANTELOPE CREEK WILDERNESS.—  
24 Certain Federal land within Caribou-Targhee  
25 National Forest comprising approximately

1 17,000 acres as generally depicted on the map  
2 entitled “\_\_\_\_\_” and dated  
3 \_\_\_\_\_, which shall be known as the  
4 Bald Mountain Antelope Creek Wilderness.

5 (C) BEAR CREEK WILDERNESS.—Certain  
6 Federal land within the Caribou-Targhee Na-  
7 tional Forest comprising approximately 98,000  
8 acres as generally depicted on the map entitled  
9 “\_\_\_\_\_” and dated \_\_\_\_\_, which  
10 shall be known as the Bear Creek Wilderness.

11 (D) CARIBOU-TARGHEE WILDERNESS.—  
12 Certain Federal land within the Caribou-  
13 Targhee National Forest comprising approxi-  
14 mately 94,000 acres as generally depicted on  
15 the map entitled “\_\_\_\_\_” and dated  
16 \_\_\_\_\_, which shall be known as the  
17 Caribou-Targhee Wilderness.

18 (E) POKER PEAK WILDERNESS.—Certain  
19 Federal land within the Caribou-Targhee Na-  
20 tional Forest comprising approximately 20,000  
21 acres as generally depicted on the map entitled  
22 “\_\_\_\_\_” and dated \_\_\_\_\_, which  
23 shall be known as the Poker Peak Wilderness.

24 (F) TINCUP WILDERNESS.—Certain Fed-  
25 eral land within the Caribou-Targhee National

1 Forest comprising approximately 7,000 acres as  
2 generally depicted on the map entitled  
3 “\_\_\_\_\_” and dated \_\_\_\_\_,  
4 which shall be known as the Tincup Wilderness.

5 (G) SCHMID PEAK WILDERNESS.—Certain  
6 Federal land within the Caribou-Targhee Na-  
7 tional Forest comprising approximately 20,000  
8 acres as generally depicted on the map entitled  
9 “\_\_\_\_\_” and dated \_\_\_\_\_, which  
10 shall be known as the Schmid Peak Wilderness.

11 (H) SAGE CREEK WILDERNESS.—Certain  
12 Federal land within the Caribou-Targhee Na-  
13 tional Forest comprising approximately 11,000  
14 acres as generally depicted on the map entitled  
15 “\_\_\_\_\_” and dated \_\_\_\_\_, which  
16 shall be known as the Sage Creek Wilderness.

17 (I) PREUSS CREEK WILDERNESS.—Certain  
18 Federal land within the Caribou-Targhee Na-  
19 tional Forest comprising approximately 14,000  
20 acres as generally depicted on the map entitled  
21 “\_\_\_\_\_” and dated \_\_\_\_\_, which  
22 shall be known as the Preuss Creek Wilderness.

23 (J) DRY RIDGE WILDERNESS.—Certain  
24 Federal land within the Caribou-Targhee Na-  
25 tional Forest comprising approximately 23,000



1 acres as generally depicted on the map entitled  
2 “\_\_\_\_\_” and dated \_\_\_\_\_, which  
3 shall be known as the Dry Ridge Wilderness.

4 (K) MEADE PEAK WILDERNESS.—Certain  
5 Federal land within the Caribou-Targhee Na-  
6 tional Forest comprising approximately 45,000  
7 acres as generally depicted on the map entitled  
8 “\_\_\_\_\_” and dated \_\_\_\_\_, which  
9 shall be known as the Meade Peak Wilderness.

10 (L) PARIS PEAK WILDERNESS.—Certain  
11 Federal land within the Caribou-Targhee Na-  
12 tional Forest comprising approximately 9,000  
13 acres as generally depicted on the map entitled  
14 “\_\_\_\_\_” and dated \_\_\_\_\_, which  
15 shall be known as the Paris Peak Wilderness.

16 (M) STATION CREEK WILDERNESS.—Cer-  
17 tain Federal land within the Caribou-Targhee  
18 National Forest comprising approximately  
19 9,000 acres as generally depicted on the map  
20 entitled “\_\_\_\_\_” and dated  
21 \_\_\_\_\_, which shall be known as the  
22 Station Creek Wilderness.

23 (N) MINK CREEK WILDERNESS.—Certain

9 \_\_\_\_\_, which shall be known as the  
10 Liberty Creek Wilderness.

11 (P) WILLIAMS CREEK WILDERNESS.—Cer-  
12 tain Federal land within the Caribou-Targhee

7 the map entitled “\_\_\_\_\_” and dated  
8 \_\_\_\_\_, which shall be known as the Ox-  
9 ford Mountain Wilderness.

10 (W) ELKHORN MOUNTAIN WILDERNESS.—  
11 Certain Federal land within the Caribou-  
12 Targhee National Forest comprising approxi-  
13 mately 42,000 acres as generally depicted on  
14 the map entitled “\_\_\_\_\_” and dated  
15 \_\_\_\_\_, which shall be known as the  
16 Elkhorn Mountain Wilderness.

17 (X) BONNEVILLE PEAK WILDERNESS.—  
18 Certain Federal land within the Caribou-  
19 Targhee National Forest comprising approxi-  
20 mately 32,000 acres as generally depicted on  
21 the map entitled “\_\_\_\_\_” and dated  
22 \_\_\_\_\_, which shall be known as the  
23 Bonneville Peak Wilderness.

24 (Y) NORTH PEBBLE WILDERNESS.—Cer-  
25 tain Federal land within the Caribou-Targhee

1 National Forest comprising approximately  
2 5,000 acres as generally depicted on the map  
3 entitled “\_\_\_\_\_” and dated  
4 \_\_\_\_\_, which shall be known as the  
5 North Pebble Wilderness.

6 (Z) TOPONCE WILDERNESS.—Certain Fed-  
7 eral land within the Caribou-Targhee National  
8 Forest comprising approximately 18,000 acres  
9 as generally depicted on the map entitled  
10 “\_\_\_\_\_” and dated \_\_\_\_\_,  
11 which shall be known as the Toponce Wilder-  
12 ness.

13 (AA) SCOUT MOUNTAIN WILDERNESS.—

16                   “\_\_\_\_\_” and dated \_\_\_\_\_, which  
17                   shall be known as the Stump Creek Wilderness.

18                   (d) NEW NATIONAL PARK COMPONENT OF THE NA-  
19                   TIONAL WILDERNESS PRESERVATION.—Certain Federal  
20                   land within Yellowstone National Park comprising ap-  
21                   proximately 2,033,000 acres as generally depicted on the  
22                   map entitled “\_\_\_\_\_” and dated \_\_\_\_\_,  
23                   which shall be known as the Yellowstone Wilderness.

1           **Subtitle B—Administration**

2   **SEC. 121. MANAGEMENT GENERALLY.**

3           Subject to valid existing rights, land designated as  
4 wilderness by this title shall be administered in accordance  
5 with the Wilderness Act (16 U.S.C. 1131 et seq.) by the  
6 Secretary concerned, except that—

7           (1) any reference in the Wilderness Act to the  
8 effective date of the Wilderness Act or any similar  
9 reference shall be deemed to be a reference to the  
10 date of the enactment of this Act;

11           (2) any reference in the Wilderness Act to the  
12 Secretary of Agriculture shall be considered to be a  
13 reference to Secretary concerned; and

14           (3) the Secretaries shall, to the greatest extent  
15 possible, coordinate the management of those wilder-  
16 ness areas containing land administered by more  
17 than one Federal land management agency.

18   **SEC. 122. MAPS AND LEGAL DESCRIPTION.**

19           (a) IN GENERAL.—As soon as practicable after the  
20 date of the enactment of this Act, the Secretary concerned  
21 shall file a map and legal description of the land des-  
22 ignated as wilderness by this title with—

23           (1) the Committee on Energy and Natural Re-  
24 sources of the Senate; and

1           (2) the Committee on Natural Resources of the  
2           House of Representatives.

3           (b) FORCE AND EFFECT.—Each map and legal de-  
4           scription shall have the same force and effect as if in-  
5           cluded in this Act, except that the Secretary concerned  
6           may correct clerical and typographical errors in the maps  
7           and legal descriptions.

8           (c) PUBLIC AVAILABILITY.—Each map and legal de-  
9           scription filed under subsection (a) shall be on file and  
10          available for public inspection in the Office of the Chief  
11          of the Forest Service, the Office of the Director of the  
12          Bureau of Land Management, or the Office of the Direc-  
13          tor of the National Park Service, as appropriate.

14       **SEC. 123. WITHDRAWAL.**

15          Subject to valid existing rights in existence on the  
16          date of enactment of this Act, land designated as wilder-  
17          ness by this title is withdrawn from all forms of—

18               (1) entry, appropriation, or disposal under the  
19               public land laws;

20               (2) location, entry, and patent under the mining  
21               laws; and

22               (3) disposition under all laws pertaining to min-  
23               eral and geothermal leasing or mineral materials.

1 **SEC. 124. WATER RIGHTS.**

2 Nothing in this title may be construed as a relin-  
3 quishment or reduction of any water rights reserved, ap-  
4 propriated, or otherwise secured by the United States in  
5 the State of Idaho, Montana, Wyoming, Oregon, or Wash-  
6 ington on or before the date of enactment of this Act.

7 **SEC. 125. INDIAN TRIBES.**

8 Nothing in this title may be construed to affect or  
9 modify any treaty or other right of an Indian tribe.

10 **SEC. 126. BUFFER ZONES.**

11 The fact that activities or uses inconsistent with the  
12 Wilderness Act can be seen or heard from land designated  
13 as wilderness by this title shall not, of itself, preclude the  
14 activities or uses up to the boundary of the wilderness  
15 area.

16 **SEC. 127. FISH AND WILDLIFE.**

17 (a) STATE JURISDICTION OR RESPONSIBILITIES.—In  
18 accordance with section 4(d)(7) of the Wilderness Act (16  
19 U.S.C. 1133(d)(7)), nothing in this title shall be construed  
20 as affecting the jurisdiction or responsibilities of the sev-  
21 eral States with respect to the wildlife and fish on Na-  
22 tional Forest System land and public land designated as  
23 wilderness by this title.

24 (b) WILDLIFE MANAGEMENT ACTIVITIES.—In ac-  
25 cordance with section 4(b) of the Wilderness Act (16  
26 U.S.C. 1133(b)), all wildlife management activities con-

1 ducted on land designated as wilderness by this title shall  
2 be conducted in a manner so as to preserve the wilderness  
3 character of the area, and all such activities shall further  
4 be conducted in accordance with section 4(c) of such Act  
5 (16 U.S.C. 1133(c)).

6 **SEC. 128. FIRE, INSECTS, AND DISEASE.**

7       In accordance with section 4(d)(1) of the Wilderness  
8 Act (16 U.S.C. 1133(d)(1)), and on land designated as  
9 wilderness by this title, the Secretary concerned may take  
10 such measures as are necessary to control fire, insects,  
11 and disease, subject to such terms and conditions as the  
12 Secretary concerned determines to be desirable and appro-  
13 priate. In implementing this section, and consistent with  
14 section 4(d)(1) of the Wilderness Act, the Secretary con-  
15 cerned shall consider the essential role of fire, insects, and  
16 disease in maintaining healthy, functioning wilderness eco-  
17 systems and as part of the wilderness character of the  
18 area.

19 **SEC. 129. GRAZING.**

20       For National Forest System land and public land  
21 designated as wilderness by this Act, grazing shall be ad-  
22 ministered in accordance with the provisions of section  
23 4(d)(4) of the Wilderness Act (16 U.S.C. 1133(d)(4)) and  
24 the guidelines set forth in House Report 96–617 to accom-  
25 pany H.R. 5487 of the 96th Congress, except as follows:

1           (1) The Secretary concerned shall accept the  
2           donation of any valid existing permits or leases au-  
3           thorizing grazing on public land, all or a portion of  
4           which is within a wilderness area designated by this  
5           Act.

6           (2) With respect to each permit or lease do-  
7           nated under paragraph (1), the Secretary concerned  
8           shall permanently terminate the grazing permit or  
9           lease, if donated in full, or permanently reduce the  
10          authorized grazing level to reflect the amount of the  
11          donation, if donated in part.

12 **SEC. 130. PRIVATE LAND.**

13          In accordance with section 5(a) of the Wilderness Act  
14          (16 U.S.C. 1134(a)), in any case where State-owned or  
15          privately owned land is completely surrounded by National  
16          Forest System land or public land designated as wilder-  
17          ness by this title, such State or private owner shall be  
18          given such rights as may be necessary to assure adequate  
19          access to such State-owned or privately owned land by  
20          such State or private owner and their successors in inter-  
21          est, or the State-owned land or privately owned land shall  
22          be exchanged for federally owned land in the same State  
23          of approximately equal value under authorities available  
24          to the Secretary concerned, except that the United States  
25          shall not transfer to a State or private owner any mineral

1 interests unless the State or private owner relinquishes or  
2 causes to be relinquished to the United States the mineral  
3 interests in the surrounded land.

## 4 **TITLE II—WILDLIFE CORRIDORS**

### 5 **SEC. 201. DEFINITIONS.**

6 In this title:

7 (1) **GEOSPATIAL INTEROPERABILITY FRAME-**  
8 **WORK.**—The term “Geospatial Interoperability  
9 Framework” means the strategy utilized by the Na-  
10 tional Biological Information Infrastructure that is  
11 based upon accepted standards, specifications, and  
12 protocols adopted through the International Stand-  
13 ards Organization, the Open Geospatial Consortium,  
14 and the Federal Geographic Data Committee, to  
15 manage, archive, integrate, analyze, and make acces-  
16 sible geospatial and biological data and metadata.

17 (2) **PROGRAM.**—The term “program” means  
18 the Northern Rockies Fish and Wildlife Habitat and  
19 Corridors Information Program established by the  
20 Secretary.

21 (3) **SECRETARY.**—The term “Secretary” means  
22 the Secretary of the Interior.

23 (4) **SYSTEM.**—The term “system” means the  
24 Northern Rockies Habitat and Corridors Informa-  
25 tion System developed by the Secretary.

1 **SEC. 202. NORTHERN ROCKIES WILDLIFE HABITAT AND**  
2 **CORRIDORS INFORMATION PROGRAM.**

3 (a) ESTABLISHMENT.—Not later than six months  
4 after the date of enactment of this Act, the Secretary shall  
5 establish a Northern Rockies Fish and Wildlife Habitat  
6 and Corridors Information Program.

7 (b) PURPOSE.—The purpose of the program is to—

8 (1) support States and Indian tribes in the de-  
9 velopment of a regional information system database  
10 of fish and wildlife habitat and corridors that would  
11 inform planning and development decisions within  
12 the States of Idaho, Montana, Oregon, Washington,  
13 and Wyoming, enabling each State to model climate  
14 impacts and adaptation, and provide geographically  
15 specific enhancements of State wildlife action plans;

16 (2) ensure the collaborative development, with  
17 the States and Indian tribes, of a comprehensive, re-  
18 gional geographic information system database of  
19 maps, models, data, surveys, informational products,  
20 and other geospatial information regarding fish and  
21 wildlife habitat and corridors, that—

22 (A) is based on consistent protocols for  
23 sampling and mapping across landscapes that  
24 take into account regional differences; and

25 (B) that utilizes—



1 (i) existing and planned State- and  
2 tribal-based geographic information system  
3 databases; and

4 (ii) existing databases, analytical  
5 tools, metadata activities, and other infor-  
6 mation products available through the Na-  
7 tional Biological Information Infrastruc-  
8 ture maintained by the Secretary and non-  
9 governmental organizations; and

10 (3) facilitate the use of such databases by Fed-  
11 eral, State, local, and tribal decision makers to in-  
12 corporate qualitative information on fish and wildlife  
13 habitat and corridors at the earliest possible stage  
14 to—

15 (A) prioritize and target natural resources  
16 adaptation strategies and activities;

17 (B) avoid, minimize, and mitigate the im-  
18 pacts on fish and wildlife habitat and corridors  
19 in siting energy development, water, trans-  
20 mission, transportation, and other land use  
21 projects;

22 (C) assess the impacts of existing develop-  
23 ment on habitats and corridors; and

24 (D) develop management strategies to en-  
25 hance the ability of fish, wildlife, and plant spe-

1           cies to migrate or respond to shifting habitats  
2           within existing habitats and corridors.

3 **SEC. 203. NORTHERN ROCKIES HABITAT AND CORRIDORS**  
4                                   **INFORMATION SYSTEM.**

5           (a) DEVELOPMENT.—The Secretary shall develop a  
6 Northern Rockies Habitat and Corridors Information Sys-  
7 tem.

8           (b) CONTENTS.—The system shall—

9                   (1) include maps, data, and descriptions of fish  
10 and wildlife habitat and corridors in the States of  
11 Idaho, Montana, Oregon, Washington, and Wyo-  
12 ming, that—

13                           (A) have been developed by Federal agen-  
14 cies, State wildlife agencies and natural herit-  
15 age programs, Indian tribes, local governments,  
16 nongovernmental organizations, and industry;  
17 and

18                           (B) meet accepted Geospatial Interoper-  
19 ability Framework data and metadata protocols  
20 and standards;

21                   (2) include maps and descriptions of projected  
22 shifts in habitats and corridors of fish and wildlife  
23 species in response to climate change;

1           (3) assure data quality and make the data,  
2 models, and analyses included in the System avail-  
3 able at scales useful to decisionmakers—

4           (A) to prioritize and target natural re-  
5 sources adaptation strategies and activities;

6           (B) to assess the impacts of proposed en-  
7 ergy development, water, transmission, trans-  
8 portation, and other land use projects and  
9 avoid, minimize, and mitigate those impacts on  
10 habitats and corridors;

11          (C) to assess the impacts of existing devel-  
12 opment on habitats and corridors; and

13          (D) to develop management strategies to  
14 enhance the ability of fish, wildlife, and plant  
15 species to migrate or respond to shifting habi-  
16 tats within existing habitats and corridors  
17 across the States of Idaho, Montana, Oregon,  
18 Washington, and Wyoming;

19          (4) establish a process for updating maps and  
20 other information as landscapes, habitats, corridors,  
21 and wildlife populations change or as other informa-  
22 tion becomes available;

23          (5) encourage the development of collaborative  
24 plans by Federal and State agencies and Indian

1 tribes to monitor and evaluate the efficacy of the  
2 System to meet the needs of decisionmakers;

3 (6) identify gaps in habitat and corridor infor-  
4 mation, mapping, and research that should be ad-  
5 dressed to fully understand assess current data and  
6 metadata, and to prioritize research and future data  
7 collection activities for use in updating the System  
8 and provide support for those activities;

9 (7) include mechanisms to support collaborative  
10 research, mapping, and planning of habitats and  
11 corridors by Federal and State agencies, Indian  
12 tribes, and other interested stakeholders;

13 (8) incorporate biological and geospatial data  
14 on species and corridors found in energy develop-  
15 ment and transmission plans, including renewable  
16 energy initiatives, transportation, and other land use  
17 plans;

18 (9) be based on the best scientific information  
19 available; and

20 (10) identify, prioritize, and describe key par-  
21 cels of non-Federal land located within the bound-  
22 aries of units of the National Park System, National  
23 Wildlife Refuge System, National Forest System, or  
24 National Grassland System that are critical to main-  
25 tenance of wildlife habitat and migration corridors.

1           (c) FINANCIAL AND OTHER SUPPORT.—The Sec-  
2 retary may provide support, including financial and tech-  
3 nical assistance, to the States of Idaho, Montana, Oregon,  
4 Washington, and Wyoming and Indian tribes in such  
5 States for activities that support the development and im-  
6 plementation of the system.

7           (d) COORDINATION.—The Secretary shall make rec-  
8 ommendations on how the information developed in the  
9 system may be incorporated into existing relevant State  
10 and Federal plans affecting fish and wildlife, including  
11 land management plans, the State Comprehensive Wildlife  
12 Conservation Strategies, and appropriate tribal conserva-  
13 tion plans, to ensure that they—

14           (1) prevent unnecessary habitat fragmentation  
15           and disruption of corridors;

16           (2) promote the landscape connectivity nec-  
17           essary to allow wildlife to move as necessary to meet  
18           biological needs, adjust to shifts in habitat, and  
19           adapt to climate change; and

20           (3) minimize the impacts of energy, develop-  
21           ment, water, transportation, and transmission  
22           projects and other activities expected to impact habi-  
23           tat and corridors.

1 **SEC. 204. COOPERATION.**

2       The Secretary shall establish the program, develop  
3 the system, and otherwise carry out this title in coopera-  
4 tion with the Secretary of Agriculture, the States of Idaho,  
5 Montana, Oregon, Washington, and Wyoming, and Indian  
6 tribes in such States.

7 **TITLE III—ADDITIONAL PROVI-**  
8 **SIONS REGARDING INDIAN**  
9 **TRIBES**

10 **SEC. 301. FEDERAL TRUST RESPONSIBILITY.**

11       Nothing in this Act is intended to amend, alter, or  
12 give priority over the Federal trust responsibility to Indian  
13 tribes.

14 **SEC. 302. EXEMPTION FROM FREEDOM OF INFORMATION**  
15 **ACT.**

16       If a Federal department or agency receives any infor-  
17 mation related to sacred sites or cultural activities identi-  
18 fied by an Indian tribe as confidential, such information  
19 shall be exempt from disclosure under section 552 of title  
20 5, United States Code, popularly known as the Freedom  
21 of Information Act (5 U.S.C. 552).

22 **SEC. 303. APPLICATION OF INDIAN SELF-DETERMINATION**  
23 **AND EDUCATION ASSISTANCE ACT.**

24       The Secretary of the Interior may apply the provi-  
25 sions of Indian Self-Determination and Education Assist-

1 ance Act (25 U.S.C. 450 et seq.; Public Law 93–638)  
 2 when appropriate in the implementation of this Act.

3 **TITLE IV—WILD AND SCENIC**  
 4 **RIVERS DESIGNATIONS**

5 **SEC. 401. DESIGNATION OF WILD AND SCENIC RIVERS IN**  
 6 **IDAHO, MONTANA, AND WYOMING.**

7 Section 3(a) of the Wild and Scenic Rivers Act (16  
 8 U.S.C. 1274(a)) is amended by adding at the end the fol-  
 9 lowing:

10 “( ) SOUTH FORK PAYETTE, IDAHO.—The seg-  
 11 ment within the Boise and Sawtooth National For-  
 12 ests from the Sawtooth Wilderness Boundary down-  
 13 stream approximately 54 miles to the confluence  
 14 with the Middle Fork and then downstream on the  
 15 main stem to the confluence with the North Fork,  
 16 which shall be administered by the Secretary of Ag-  
 17 riculture.

18 “( ) MIDDLE FORK PAYETTE, IDAHO.—The seg-  
 19 ment within the Boise National Forest from the  
 20 Railroad Pass downstream approximately 33 miles  
 21 to the national forest boundary, which shall be ad-  
 22 ministered by the Secretary of Agriculture.

23 “( ) DEADWOOD, IDAHO.—The segment within  
 24 the Boise National Forest from Three-mile Creek  
 25 downstream approximately 22 miles to the South

1 Fork of the Payette, which shall be administered by  
2 the Secretary of Agriculture.

3 “( ) UPPER PRIEST, IDAHO.—The segment  
4 within the Panhandle National Forest from the Ca-  
5 nadian border downstream approximately 19 miles  
6 to Upper Priest Lake, which shall be administered  
7 by the Secretary of Agriculture.

8 “( ) COEUR D’ALENE, IDAHO.—The segment  
9 within the Panhandle National Forest from the  
10 headwaters downstream approximately 58 miles to  
11 the national forest boundary, which shall be admin-  
12 istered by the Secretary of Agriculture.

13 “( ) LITTLE NORTH FORK CLEARWATER,  
14 IDAHO.—The segment within the Panhandle Na-  
15 tional Forest from the headwaters downstream ap-  
16 proximately 37 miles to the National Forest bound-  
17 ary, which shall be administered by the Secretary of  
18 Agriculture.

19 “( ) KELLY CREEK, IDAHO.—The segment  
20 within the Clearwater National Forest from its  
21 headwaters downstream approximately 31 miles to  
22 the North Fork of the Clearwater River, which shall  
23 be administered by the Secretary of Agriculture.

24 “( ) CAYUSE CREEK, IDAHO.—The segment  
25 within the Clearwater National Forest from its



1 headwaters downstream approximately 39 miles to  
2 the confluence of Kelly Creek, which shall be admin-  
3 istered by the Secretary of Agriculture.

4 “( ) BARGAMIN CREEK, IDAHO.—The segment  
5 within the Nez Perce National Forest, comprising  
6 approximately 21 miles, which shall be administered  
7 by the Secretary of Agriculture.

8 “( ) LAKE CREEK, IDAHO.—The segment within  
9 the Nez Perce National Forest from the wilderness  
10 boundary downstream approximately 10 miles to  
11 Crooked Creek, which shall be administered by the  
12 Secretary of Agriculture.

13 “( ) MEADOW CREEK, IDAHO.—The segment  
14 within the Nez Perce National Forest from its head-  
15 waters downstream approximately 34 miles to its  
16 confluence with the Selway River, which shall be ad-  
17 ministered by the Secretary of Agriculture.

18 “( ) RUNNING CREEK, IDAHO.—The segment  
19 within the Nez Perce National Forest from its head-  
20 waters downstream approximately 20 miles to its  
21 confluence with the Selway River, which shall be ad-  
22 ministered by the Secretary of Agriculture.

23 “( ) SALMON, IDAHO.—

24 “(A) VINEGAR CREEK.—The segment  
25 within the Nez Perce and Payette National

1 Forests from Vinegar Creek downstream ap-  
2 proximately 25 miles to the Little Salmon  
3 River, which shall be administered by the Sec-  
4 retary of Agriculture.

5 “(B) SALMON.—The segment on public  
6 lands managed by the Bureau of Land Manage-  
7 ment from Hammer Creek downstream approxi-  
8 mately 45 miles to the confluence with the  
9 Snake River, which shall be administered by the  
10 Secretary of the Interior.

11 “(C) SALMON.—The segment on public  
12 lands within the Sawtooth National Recreation  
13 Area from its headwaters downstream approxi-  
14 mately 60 miles to the recreation area boundary,  
15 which shall be administered by the Secretary of  
16 Agriculture.

17 “( ) EAST FORK SALMON, IDAHO.—The seg-  
18 ment within the Sawtooth National Recreation Area  
19 from the headwaters downstream approximately 42  
20 miles to the recreation area boundary, which shall be  
21 administered by the Secretary of Agriculture.

22 “( ) NORTH FORK CLEARWATER, IDAHO.—The  
23 segment within the Clearwater National Forest from  
24 the headwaters downstream to the Dworshak Res-

1       ervoir, which shall be administered by the Secretary  
2       of Agriculture.

3           “( ) NORTH FORK COEUR D’ALENE, IDAHO.—  
4       The segment within the Panhandle National Forest  
5       from its headwaters south of Honey Mountain down-  
6       stream to its confluence with the Coeur d’Alene  
7       River, which shall be administered by the Secretary  
8       of Agriculture.

9           “( ) PACK, IDAHO.—The segment within the  
10       Panhandle National Forest from Harrison Lake  
11       downstream approximately 14 miles to the National  
12       Forest boundary, which shall be administered by the  
13       Secretary of Agriculture.

14          “( ) HENRY’S FORK, IDAHO.—The segment  
15       within the Targhee National Forest from Big  
16       Springs downstream to the national forest boundary,  
17       except for Island Park Reservoir, which shall be ad-  
18       ministered by the Secretary of Agriculture.

19          “( ) FALLS RIVER, IDAHO.—The segment with-  
20       in the Caribou-Targhee National Forest from Yel-  
21       lowstone National Park downstream approximately  
22       13 miles to the National Forest boundary, which  
23       shall be administered by the Secretary of Agri-  
24       culture.

1           “( ) LOCHSA RIVER WATERSHED, IDAHO.—The  
2 segment within the Clearwater National Forest of  
3 the Lochsa River from the confluence of Colt Killed  
4 Creek and Crooked Fork downstream approximately  
5 2 miles to the beginning of the Loschsa Recreational  
6 River, which shall be administered by the Secretary  
7 of Agriculture.

8           “( ) COLT KILLED CREEK, IDAHO.—The seg-  
9 ment within the Clearwater National Forest from its  
10 headwaters at Big Sand Lake downstream approxi-  
11 mately 23 miles to its confluence with Crooked Fork,  
12 which shall be administered by the Secretary of Ag-  
13 riculture.

14           “( ) MOOSE CREEK COMPLEX, IDAHO.—The  
15 main segment, including the North Fork segment,  
16 the East Fork segment, the West Moose segment,  
17 and the Rhoda Creek segment comprising approxi-  
18 mately 86 miles within the Nez Perce National For-  
19 est, which shall be administered by the Secretary of  
20 Agriculture.

21           “( ) BEAR CREEK COMPLEX, IDAHO.—The Bear  
22 Creek segment, the Club Creek segment, the Para-  
23 disie Creek segment, the Brushy Fork Creek seg-  
24 ment, and the Wahoo Creek segment comprising ap-  
25 proximately 70 miles within the Nez Perce National

1 Forest, which shall be administered by the Secretary  
2 of Agriculture.

3 “( ) THREE LINKS CREEK COMPLEX, IDAHO.—  
4 The Three Links Creek segment and the West Fork  
5 Three Links Creek segment comprising approxi-  
6 mately 23 miles within the Nez Perce National For-  
7 est, which shall be administered by the Secretary of  
8 Agriculture.

9 “( ) GEDNEY CREEK, IDAHO.—The segment  
10 within the Nez Perce National Forest from its head-  
11 waters downstream approximately 14.5 to the con-  
12 fluence the Selway River, which shall be adminis-  
13 tered by the Secretary of Agriculture.

14 “( ) SOUTH FORK CLEARWATER, IDAHO.—The  
15 segment within the Nez Perce National Perce Na-  
16 tional Forest from the confluence of the Red and  
17 American Rivers downstream approximately 40  
18 miles to the forest boundary, which shall be adminis-  
19 tered by the Secretary of Agriculture.

20 “( ) JOHNS CREEK, IDAHO.—The segment with-  
21 in the Nez Perce National Forest from the head-  
22 waters downstream to its confluence with the South  
23 Fork Clearwater, which shall be administered by the  
24 Secretary of Agriculture.

1           “( ) SLATE CREEK, IDAHO.—The segment with-  
2           in the Nez Perce National Forest from the head-  
3           waters downstream approximately 15 miles to the  
4           forest boundary, which shall be administered by the  
5           Secretary of Agriculture.

6           “( ) SOUTH FORK TWO MEDICINE RIVER, MON-  
7           TANA.—The segment within the Lewis and Clark  
8           National Forest from its headwaters downstream ap-  
9           proximately 10 miles to the Sawmill Flat Trailhead,  
10          which shall be administered by the Secretary of Ag-  
11          riculture.

12          “( ) BADGER CREEK, MONTANA.—The segment  
13          within the Lewis and Clark National Forest from its  
14          headwaters downstream approximately 24 miles to  
15          the national forest boundary, which shall be admin-  
16          istered by the Secretary of Agriculture.

17          “( ) DEARBORN, MONTANA.—The segment  
18          within the Lewis and Clark National Forest down-  
19          stream approximately 18 miles to the national forest  
20          boundary, which shall be administered by the Sec-  
21          retary of Agriculture.

22          “( ) NORTH FORK BIRCH CREEK, MONTANA.—  
23          The segment within the Lewis and Clark National  
24          Forest from its headwaters downstream approxi-

1 mately 7 miles to the forest boundary, which shall  
2 be administered by the Secretary of Agriculture.

3 “( ) SOUTH FORK SUN, MONTANA.—The seg-  
4 ment within the Lewis and Clark National Forest  
5 from its headwaters at Sun Lake downstream ap-  
6 proximately 26 miles to its confluence with the  
7 North Fork, which shall be administered by the Sec-  
8 retary of Agriculture.

9 “( ) NORTH FORK SUN, MONTANA.—The seg-  
10 ment within the Lewis and Clark National Forest  
11 from the confluence of Open Creek and Fool creek  
12 downstream approximately 27 miles to the con-  
13 fluence of the South Fork, which shall be adminis-  
14 tered by the Secretary of Agriculture.

15 “( ) TENDERFOOT CREEK, MONTANA.—The  
16 segment within the Lewis and Clark National Forest  
17 from the top of the Tenderfoot Creek Falls down-  
18 stream approximately 5 miles to the Smith River,  
19 which shall be administered by the Secretary of Ag-  
20 riculture.

21 “( ) GREEN FORK STRAIGHT CREEK, MON-  
22 TANA.—The segment within the Lewis and Clark  
23 National Forest from its headwaters downstream ap-  
24 proximately 5 miles to Straight Creek, which shall  
25 be administered by the Secretary of Agriculture.

1           “( ) YAAK RIVER, MONTANA.—The segment  
2 within the Kootenai National Forest from the Yaak  
3 Falls downstream 46 miles to the mouth of the Yaak  
4 River at the junction of the Kootenai River, which  
5 shall be administered by the Secretary of Agri-  
6 culture.

7           “( ) KOOTENAI RIVER, MONTANA.—The seg-  
8 ment within the Kootenai National Forest from the  
9 junction of the Fisher River downstream approxi-  
10 mately 46 miles to the state line, which shall be ad-  
11 ministered by the Secretary of Agriculture.

12           “( ) BULL RIVER, MONTANA.—The segment  
13 within the Kootenai National Forest from the junc-  
14 tion of the North and South Forks downstream 21  
15 miles to the Cabinet Gorge Reservoir, which shall be  
16 administered by the Secretary of Agriculture.

17           “( ) VERMILLION RIVER, MONTANA.—The seg-  
18 ment within the Kootenai National Forest from the  
19 junction of Willow Creek downstream approximately  
20 12 miles to the Noxon Reservoir, which shall be ad-  
21 ministered by the Secretary of Agriculture.

22           “( ) WEST FORK MADISION, MONTANA.—The  
23 segment within the Beaverhead-Deerlodge National  
24 Forest from the midpoint of Section 28, R. 2 W., T.  
25 12 S., downstream approximately 21 miles to the



1 West Fork Rest Area, which shall be administered  
2 by the Secretary of Agriculture.

3 “( ) ELK RIVER, MONTANA.—The segment  
4 within the Beaverhead-Deerlodge National Forest in  
5 the southeast corner of Section 16, R. 2 W., T. 11  
6 S., downstream approximately 17 miles to the con-  
7 fluence with the West Fork of the Madison River,  
8 which shall be administered by the Secretary of Ag-  
9 riculture.

10 “( ) BROWNS CREEK, MONTANA.—The segment  
11 within the Beaverhead-Deerlodge National Forest  
12 from the west central part of Section 1, R. 14 W.,  
13 T. 8 S., downstream approximately 4 miles to the  
14 forest boundary, which shall be administered by the  
15 Secretary of Agriculture.

16 “( ) CANYON CREEK, MONTANA.—The segment  
17 within the Beaverhead-Deerlodge National Forest  
18 from Canyon Lake downstream approximately 4  
19 miles to the end of USFS road 7401, which shall be  
20 administered by the Secretary of Agriculture.

21 “( ) DEADMAN CREEK, MONTANA.—The seg-  
22 ment within the Beaverhead-Deerlodge National  
23 Forest from its headwaters downstream approxi-  
24 mately 10 miles to the forest boundary, which shall  
25 be administered by the Secretary of Agriculture.

1           “( ) SMITH RIVER, MONTANA.—The segment  
2           within the Lewis and Clark National Forest from  
3           Tenderfoot Creek downstream approximately 12  
4           miles to Deep Creek, which shall be administered by  
5           the Secretary of Agriculture.

6           “( ) MIDDLE FORK JUDITH RIVER, MONTANA.—  
7           The segment within the Lewis and Clark National  
8           Forest from Arch Coulee Junction downstream ap-  
9           proximately 5 miles to the national forest boundary,  
10          which shall be administered by the Secretary of Ag-  
11          riculture.

12          “( ) ROCK CREEK WATERSHED, MONTANA.—  
13          The segments within the Lolo and Beaverhead-  
14          Deerlodge National Forests including the main fork  
15          of Rock Creek, the West Fork of Rock Creek, the  
16          East Fork of Rock Creek, the Ross Fork of Rock  
17          Creek, the Middle Fork of Rock Creek, the Carpp  
18          Creek segment, the Copper Creek segment, the  
19          Ranch Creek segment, the Welcome Creek segment,  
20          the Alder Creek segment, the Hogback Creek seg-  
21          ment, the Wyman Gulch segment, the Stony Creek  
22          segment, the West Fork segment, and the Ross  
23          Fork segment, comprising approximately 134 miles,  
24          which shall be administered by the Secretary of Ag-  
25          riculture.

1           “( ) SALT RIVER, WYOMING.—The segment  
2           within the Bridger-Teton National Forest from the  
3           headwaters downstream approximately 12 miles to  
4           forest road 10072, which shall be administered by  
5           the Secretary of Agriculture.

6           “( ) SWIFT CREEK, WYOMING.—The segment  
7           within the Bridger-Teton National Forest from the  
8           headwaters downstream approximately 8 miles to  
9           Periodic Spring, which shall be administered by the  
10          Secretary of Agriculture.

11          “( ) HOBACK RIVER, WYOMING.—The segment  
12          within the Bridger-Teton National Forest from the  
13          headwaters downstream approximately 10 miles to  
14          the end of forest road 30710, which shall be admin-  
15          istered by the Secretary of Agriculture.

16          “( ) THOROFARE, WYOMING.—The segment of  
17          the main stem within the Bridger-Teton National  
18          Forest from the headwaters downstream approxi-  
19          mately 25 miles to the confluence with the Yellow-  
20          stone River, and the headwaters of Open Creek  
21          downstream 10 miles to the confluence with the  
22          main stem, which shall be administered by the Sec-  
23          retary of Agriculture.

24          “( ) ATLANTIC CREEK, WYOMING.—The seg-  
25          ment within the Bridger-Teton National Forest from

1 the Parting of the Waters downstream approxi-  
2 mately 10 miles to the confluence with the Yellow-  
3 stone River, which shall be administered by the Sec-  
4 retary of Agriculture.

5 “( ) YELLOWSTONE, WYOMING.—The segment  
6 within the Bridger-Teton National Forest from the  
7 headwaters downstream approximately 28 miles to  
8 the boundary of Yellowstone National Park, which  
9 shall be administered by the Secretary of Agri-  
10 culture.

11 “( ) YELLOWSTONE RIVER, WYOMING AND MON-  
12 TANA.—The segment within the Gallatin National  
13 Forest and Yellowstone National Park from the  
14 southern boundary of Yellowstone National Park  
15 downstream approximately 102 miles to the mouth  
16 of Yankee Jim canyon, which shall be administered  
17 by the Secretaries of Interior and Agriculture.”.
