A BILL

To prohibit Federal funding for lawsuits seeking to invalidate specified State laws that support the enforcement of Federal immigration laws.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FEDERAL FUNDING FOR LAWSUITS SEEKING**
4 **TO INVALIDATE STATE IMMIGRATION LAWS.**

5 Federal funds may not be used by any agency or in-
6 strumentality of the Federal Government to participate in

1 any lawsuit that seeks to overturn, enjoin, or in any other
2 way invalidate—

3 (1) Oklahoma Taxpayer and Citizen Protection
4 Act of 2007 (HB 1804), which became effective on
5 November 1, 2007;

6 (2) Missouri House Bill 390, First Regular Ses-
7 sion 2009, 9th General Assembly, which became ef-
8 fective on August 28, 2009;

9 (3) the Support Our Law Enforcement and
10 Safe Neighborhoods Act (SB 1070), which was
11 signed into law in Arizona on April 23, 2010;

12 (4) The Illegal Immigration Enforcement Act
13 (HB 497), which was signed into law in Utah on
14 March 15, 2011;

15 (5) Indiana Senate Enrolled Act No. 590, First
16 Regular Session, 117th General Assembly (2011),
17 which was signed into law on May 10, 2011;

18 (6) the Beason-Hammon Alabama Taxpayer
19 and Citizen Protection Act (HB 56), which was
20 passed by the Alabama State legislature on June 9,
21 2011;

22 (7) South Carolina Act No. 69 (SB 20), which
23 was signed into law on June 27, 2011;

1 (8) the Illegal Immigration Reform and En-
2 forcement Act of 2011 (HB 87), which became ef-
3 fective in the State of Georgia on July 1, 2011; or

4 (9) an Act to amend the Indiana Code con-
5 cerning education (HB 1402), which became effec-
6 tive in the State of Indiana on July 1, 2011.
