A BILL

To designate the facility of the United States Postal Service located at 8771 Auburn Folsom Road in Roseville, California, as the “Private First Class Victor A. Dew Post Office”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 The Congress finds and declares that—

5 (1) PFC Victor Dew, USMC, was born June 8,
6 1990 in Hayward, California;

7 (2) He graduated from Granite Bay High
8 School in 2008;

9 (3) He became a U.S. Marine in December
10 2009 to serve his country;

11 (4) He served valiantly as a proud U.S. Marine
12 in Helmand Province, Afghanistan;

13 (5) He combined a humble, quiet, kind nature
14 with a resolute character;

15 (6) He was a respected leader, determined to
16 protect family and friends;

17 (7) This genuine, honest, good man gave his life
18 for his country on October 13, 2010;

19 (8) The Congress of the United States, in ac-
20 knowledge of this debt that cannot be repaid,
21 honors Victor for his ultimate sacrifice and recog-
22 nizes his service to his country, faithfully executed to
23 his last, full measure of devotion.

1 **SEC. 2. PRIVATE FIRST CLASS VICTOR A. DEW POST OF-**
2 **FICE.**

3 (a) DESIGNATION.—The facility of the United States
4 Postal Service located at 8771 Auburn Folsom Road in
5 Roseville, California, shall be known and designated as the
6 “Private First Class Victor A. Dew Post Office”.

7 (b) REFERENCES.—Any reference in a law, map, reg-
8 ulation, document, paper, or other record of the United
9 States to the facility referred to in subsection (a) shall
10 be deemed to be a reference to the “Private First Class
11 Victor A. Dew Post Office”.
