2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “FISA Amendments  
5 Act Reauthorization Act of 2012”.

6 **SEC. 2. FIVE-YEAR EXTENSION OF FISA AMENDMENTS ACT**
