Mr. SESSIONS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 754) to authorize appropriations for fiscal year 2011 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee

1 of the Whole House on the state of the Union for consider-
2 ation of the bill (H.R. 754) to authorize appropriations
3 for fiscal year 2011 for intelligence and intelligence-re-
4 lated activities of the United States Government, the Com-
5 munity Management Account, and the Central Intelligence
6 Agency Retirement and Disability System, and for other
7 purposes. The first reading of the bill shall be dispensed
8 with. All points of order against consideration of the bill
9 are waived. General debate shall be confined to the bill
10 and shall not exceed one hour equally divided and con-
11 trolled by the chair and ranking minority member of the
12 Permanent Select Committee on Intelligence. After gen-
13 eral debate the bill shall be considered for amendment
14 under the five-minute rule. It shall be in order to consider
15 as an original bill for the purpose of amendment under
16 the five-minute rule the amendment in the nature of a sub-
17 stitute recommended by the Permanent Select Committee
18 on Intelligence now printed in the bill. The committee
19 amendment in the nature of a substitute shall be consid-
20 ered as read. All points of order against the committee
21 amendment in the nature of a substitute are waived. No
22 amendment to the committee amendment in the nature
23 of a substitute shall be in order except those printed in
24 the report of the Committee on Rules accompanying this
25 resolution. Each such amendment may be offered only in

1 the order printed in the report, may be offered only by
2 a Member designated in the report, shall be considered
3 as read, shall be debatable for the time specified in the
4 report equally divided and controlled by the proponent and
5 an opponent, shall not be subject to amendment, and shall
6 not be subject to a demand for division of the question
7 in the House or in the Committee of the Whole. All points
8 of order against such amendments are waived. At the con-
9 clusion of consideration of the bill for amendment the
10 Committee shall rise and report the bill to the House with
11 such amendments as may have been adopted. Any Member
12 may demand a separate vote in the House on any amend-
13 ment adopted in the Committee of the Whole to the bill
14 or to the committee amendment in the nature of a sub-
15 stitute. The previous question shall be considered as or-
16 dered on the bill and amendments thereto to final passage
17 without intervening motion except one motion to recommit
18 with or without instructions.
