Mr. DREIER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2) to repeal the job-killing health care law and health care-related provisions in the Health Care and Education Reconciliation Act of 2010; providing for consideration of the resolution (H. Res. 9) instructing certain committees to report legislation replacing the job-killing health care law; and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.

1 2) to repeal the job-killing health care law and health care-  
2 related provisions in the Health Care and Education Rec-  
3 onciliation Act of 2010. All points of order against consid-  
4 eration of the bill are waived. The amendment printed in  
5 part A of the report of the Committee on Rules accom-  
6 panying this resolution shall be considered as adopted.  
7 The bill, as amended, shall be considered as read. All  
8 points of order against provisions in the bill, as amended,  
9 are waived. The previous question shall be considered as  
10 ordered on the bill, as amended, to final passage without  
11 intervening motion except: (1) seven hours of debate, with  
12 30 minutes equally divided and controlled by the Majority  
13 Leader and Minority Leader or their respective designees,  
14 90 minutes equally divided and controlled by the chair and  
15 ranking minority member of the Committee on Education  
16 and the Workforce, 90 minutes equally divided and con-  
17 trolled by the chair and ranking minority member of the  
18 Committee on Energy and Commerce, 90 minutes equally  
19 divided and controlled by the chair and ranking minority  
20 member of the Committee on Ways and Means, 40 min-  
21 utes equally divided and controlled by the chair and rank-  
22 ing minority member of the Committee on the Budget, 40  
23 minutes equally divided and controlled by the chair and  
24 ranking minority member of the Committee on the Judici-  
25 ary, and 40 minutes equally divided and controlled by the

1 chair and ranking minority member of the Committee on  
2 Small Business; and (2) one motion to recommit with or  
3 without instructions.

4       SEC. 2. Upon adoption of this resolution it shall be  
5 in order without intervention of any point of order to con-  
6 sider in the House the resolution (H. Res. 9) instructing  
7 certain committees to report legislation replacing the job-  
8 killing health care law. The resolution shall be considered  
9 as read. The previous question shall be considered as or-  
10 dered on the resolution and any amendment thereto to  
11 final adoption without intervening motion or demand for  
12 division of the question except: (1) one hour of debate  
13 equally divided and controlled by the chair and ranking  
14 minority member of the Committee on Rules or their re-  
15 spective designees; (2) the amendment printed in part B  
16 of the report of the Committee on Rules, if offered by Rep-  
17 resentative Matheson of Utah or his designee, which shall  
18 be in order without intervention of any point of order,  
19 shall be considered as read, and shall be separately debat-  
20 able for 10 minutes equally divided and controlled by the  
21 proponent and an opponent; and (3) one motion to recom-  
22 mit which may not contain instructions.

23       SEC. 3. Upon adoption of this resolution it shall be  
24 in order without intervention of any point of order to con-  
25 sider in the House a resolution, if offered by the Majority

1 Leader or his designee, relating to the status of certain  
2 actions taken by Members-elect. The previous question  
3 shall be considered as ordered on the resolution to final  
4 adoption without intervening motion or demand for divi-  
5 sion of the question except four minutes of debate equally  
6 divided and controlled by the Majority Leader and Minor-  
7 ity Leader or their respective designees.
