Mr. SCOTT of South Carolina, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the resolution (H. Res. 292) declaring that the President shall not deploy, establish, or maintain the presence of units and members of the United States Armed Forces on the ground in Libya, and for other purposes, and providing for consideration of the concurrent resolution (H. Con. Res. 51) directing the President, pursuant to section 5(c) of the War Powers Resolution, to remove the United States Armed Forces from Libya.

1 *Resolved*, That upon the adoption of this resolution
2 it shall be in order without intervention of any point of
3 order to consider in the House the resolution (H. Res.
4 292) declaring that the President shall not deploy, estab-
5 lish, or maintain the presence of units and members of
6 the United States Armed Forces on the ground in Libya,
7 and for other purposes. The resolution shall be considered
8 as read. The previous question shall be considered as or-
9 dered on the resolution to its adoption without intervening
10 motion or demand for division of the question except one
11 hour of debate, with 40 minutes equally divided and con-
12 trolled by the chair and ranking minority member of the
13 Committee on Foreign Affairs, 20 minutes equally divided
14 and controlled by the chair and ranking minority member
15 of the Committee on Armed Services.

16 SEC. 2. Upon the adoption of this resolution it shall
17 be in order without intervention of any point of order to
18 consider in the House the concurrent resolution (H. Con.
19 Res. 51) directing the President, pursuant to section 5(c)
20 of the War Powers Resolution, to remove the United
21 States Armed Forces from Libya, if called up by the chair
22 of the Committee on Foreign Affairs or her designee. The
23 concurrent resolution shall be considered as read. The con-
24 current resolution shall be debatable for one hour, with
25 30 minutes controlled by Representative Ros-Lehtinen of

1 Florida or her designee and 30 minutes controlled by Rep-
2 resentative Kucinich of Ohio or his designee. The previous
3 question shall be considered as ordered on the concurrent
4 resolution to its adoption without intervening motion.
