## RESOLUTION

Providing for consideration of the joint resolution (H.J. Res. 68) authorizing the limited use of the United States Armed Forces in support of the NATO mission in Libya; and providing for consideration of the bill (H.R. 2278) to limit the use of funds appropriated to the Department of Defense for United States Armed Forces in support of North Atlantic Treaty Organization Operation Unified Protector with respect to Libya, unless otherwise specifically authorized by law.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the joint resolu-  
3 tion (H.J. Res. 68) authorizing the limited use of the  
4 United States Armed Forces in support of the NATO mis-  
5 sion in Libya, if called up by the chair of the Committee  
6 on Foreign Affairs or her designee. All points of order  
7 against consideration of the joint resolution are waived.  
8 The joint resolution shall be considered as read. All points  
9 of order against provisions in the joint resolution are  
10 waived. The previous question shall be considered as or-  
11 dered on the joint resolution to final passage without in-  
12 tervening motion except: (1) one hour of debate, with 40  
13 minutes equally divided and controlled by the chair and  
14 ranking minority member of the Committee on Foreign  
15 Affairs and 20 minutes equally divided and controlled by  
16 the chair and ranking minority member of the Committee  
17 on Armed Services; and (2) one motion to recommit.

18       SEC. 2. Upon adoption of this resolution it shall be  
19 in order to consider in the House the bill (H.R. 2278)  
20 to limit the use of funds appropriated to the Department  
21 of Defense for United States Armed Forces in support of  
22 North Atlantic Treaty Organization Operation Unified  
23 Protector with respect to Libya, unless otherwise specifi-  
24 cally authorized by law, if called up by the chair of the  
25 Committee on Armed Services or his designee. All points

1 of order against consideration of the bill are waived. The  
2 bill shall be considered as read. All points of order against  
3 provisions in the bill are waived. The previous question  
4 shall be considered as ordered on the bill to final passage  
5 without intervening motion except: (1) one hour of debate  
6 equally divided and controlled by chair and ranking minor-  
7 ity member of the Committee on Armed Services; and (2)  
8 one motion to recommit.
