Mr. WEBSTER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2838) to authorize appropriations for the Coast Guard for fiscal years 2012 through 2015, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2838) to authorize appropriations
6 for the Coast Guard for fiscal years 2012 through 2015,
7 and for other purposes. The first reading of the bill shall

1 be dispensed with. All points of order against consider-
2 ation of the bill are waived. General debate shall be con-
3 fined to the bill and amendments specified in this resolu-
4 tion and shall not exceed one hour equally divided and con-
5 trolled by the chair and ranking minority member of the
6 Committee on Transportation and Infrastructure. After
7 general debate the bill shall be considered for amendment
8 under the five-minute rule.

9 SEC. 2. (a) In lieu of the amendment in the nature
10 of a substitute recommended by the Committee on Trans-
11 portation and Infrastructure now printed in the bill, it
12 shall be in order to consider as an original bill for the
13 purpose of amendment under the five-minute rule an
14 amendment in the nature of a substitute consisting of the
15 text of the Rules Committee Print dated October 28,
16 2011. That amendment in the nature of a substitute shall
17 be considered as read. All points of order against that
18 amendment in the nature of a substitute are waived.

19 (b) No amendment to the amendment in the nature
20 of a substitute made in order as original text shall be in
21 order except those printed in the report of the Committee
22 on Rules accompanying this resolution and amendments
23 en bloc described in section 3 of this resolution.

24 (c) Each amendment printed in the report of the
25 Committee on Rules shall be considered only in the order

1 printed in the report, may be offered only by a Member
2 designated in the report, shall be considered as read, shall
3 be debatable for the time specified in the report equally
4 divided and controlled by the proponent and an opponent,
5 shall not be subject to amendment, and shall not be sub-
6 ject to a demand for division of the question in the House
7 or in the Committee of the Whole.

8 (d) All points of order against amendments printed
9 in the report of the Committee on Rules or amendments
10 en bloc described in section 3 of this resolution are waived.

11 SEC. 3. It shall be in order at any time for the chair
12 of the Committee on Transportation and Infrastructure
13 or his designee to offer amendments en bloc consisting of
14 amendments printed in the report of the Committee on
15 Rules accompanying this resolution not earlier disposed of.
16 Amendments en bloc offered pursuant to this section shall
17 be considered as read, shall be debatable for 10 minutes
18 equally divided and controlled by the chair and ranking
19 minority member of the Committee on Transportation and
20 Infrastructure or their designees, shall not be subject to
21 amendment, and shall not be subject to a demand for divi-
22 sion of the question in the House or in the Committee
23 of the Whole. The original proponent of an amendment
24 included in such amendments en bloc may insert a state-

1 ment in the Congressional Record immediately before the
2 disposition of the amendments en bloc.

3 SEC. 4. At the conclusion of consideration of the bill
4 for amendment the Committee shall rise and report the
5 bill to the House with such amendments as may have been
6 adopted. Any Member may demand a separate vote in the
7 House on any amendment adopted in the Committee of
8 the Whole to the bill or to the amendment in the nature
9 of a substitute made in order as original text. The previous
10 question shall be considered as ordered on the bill and
11 amendments thereto to final passage without intervening
12 motion except one motion to recommit with or without in-
13 structions.

14 SEC. 5. It shall be in order at any time on the legisla-
15 tive day of November 4, 2011, for the Speaker to entertain
16 motions that the House suspend the rules relating to a
17 measure addressing the applicability of the coastwise trade
18 laws.
