5           (a) AGGREGATE AMOUNT FOR CONGRESS.—Notwith-  
6 standing section 1(b) of House Resolution 147, the

1 amount paid out of the applicable accounts of the House

3 Twelfth Congress for the expenses (including the expenses  
4 of all staff salaries) of each committee named in such sec-
