Mr. BISHOP of Utah, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1837) to address certain water-related concerns on the San Joaquin River, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 1837) to address certain water-re-
6 lated concerns on the San Joaquin River, and for other
7 purposes. The first reading of the bill shall be dispensed

1 with. All points of order against consideration of the bill
2 are waived. General debate shall be confined to the bill
3 and shall not exceed one hour equally divided and con-
4 trolled by the chair and ranking minority member of the
5 Committee on Natural Resources. After general debate the
6 bill shall be considered for amendment under the five-
7 minute rule. In lieu of the amendment in the nature of
8 a substitute recommended by the Committee on Natural
9 Resources now printed in the bill, it shall be in order to
10 consider as an original bill for the purpose of amendment
11 under the five-minute rule an amendment in the nature
12 of a substitute consisting of the text of Rules Committee
13 Print 112-15. That amendment in the nature of a sub-
14 stitute shall be considered as read. All points of order
15 against that amendment in the nature of a substitute are
16 waived. No amendment to that amendment in the nature
17 of a substitute shall be in order except those printed in
18 the report of the Committee on Rules accompanying this
19 resolution. Each such amendment may be offered only in
20 the order printed in the report, may be offered only by
21 a Member designated in the report, shall be considered
22 as read, shall be debatable for the time specified in the
23 report equally divided and controlled by the proponent and
24 an opponent, shall not be subject to amendment, and shall
25 not be subject to a demand for division of the question

1 in the House or in the Committee of the Whole. All points
2 of order against such amendments are waived. At the con-
3 clusion of consideration of the bill for amendment the
4 Committee shall rise and report the bill to the House with
5 such amendments as may have been adopted. Any Member
6 may demand a separate vote in the House on any amend-
7 ment adopted in the Committee of the Whole to the bill
8 or to the amendment in the nature of a substitute made
9 in order as original text. The previous question shall be
10 considered as ordered on the bill and amendments thereto
11 to final passage without intervening motion except one
12 motion to recommit with or without instructions.
