Ms. FOXX, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4970) to reauthorize the Violence Against Women Act of 1994, and providing for consideration of the bill (H.R. 4310) to authorize appropriations for fiscal year 2013 for military activities of the Department of Defense, to prescribe military personnel strengths for fiscal year 2013, and for other purposes.

- 1 *Resolved*, That upon the adoption of this resolution
- 2 it shall be in order to consider in the House the bill (H.R.
- 3 4970) to reauthorize the Violence Against Women Act of

1 1994. All points of order against consideration of the bill
2 are waived. The amendment in the nature of a substitute
3 recommended by the Committee on the Judiciary now
4 printed in the bill, modified by the amendment printed in
5 the report of the Committee on Rules accompanying this
6 resolution, shall be considered as adopted. The bill, as
7 amended, shall be considered as read. All points of order
8 against provisions in the bill, as amended, are waived. The
9 previous question shall be considered as ordered on the
10 bill, as amended, and any amendment thereto to final pas-
11 sage without intervening motion except: (1) one hour of
12 debate equally divided and controlled by the chair and
13 ranking minority member of the Committee on the Judici-
14 ary; and (2) one motion to recommit with or without in-
15 structions.

16 SEC. 2. At any time after the adoption of this resolu-
17 tion the Speaker may, pursuant to clause 2(b) of rule
18 XVIII, declare the House resolved into the Committee of
19 the Whole House on the state of the Union for consider-
20 ation of the bill (H.R. 4310) to authorize appropriations
21 for fiscal year 2013 for military activities of the Depart-
22 ment of Defense, to prescribe military personnel strengths
23 for fiscal year 2013, and for other purposes. The first
24 reading of the bill shall be dispensed with. All points of
25 order against consideration of the bill are waived. General

1 debate shall be confined to the bill and shall not exceed
2 one hour equally divided and controlled by the chair and
3 ranking minority member of the Committee on Armed
4 Services. After general debate, the Committee of the
5 Whole shall rise without motion. No further consideration
6 of the bill shall be in order except pursuant to a subse-
7 quent order of the House.
