Mr. WEBSTER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 5856) making appropriations for the Department of Defense for the fiscal year ending September 30, 2013, and for other purposes; providing for consideration of the bill (H.R. 6020) making appropriations for financial services and general government for the fiscal year ending September 30, 2013, and for other purposes; and providing for

consideration of the conference report to accompany the bill (H.R. 4348) to provide an extension of Federal-aid highway, highway safety, motor carrier safety, transit, and other programs funded out of the Highway Trust Fund pending enactment of a multiyear law reauthorizing such programs, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 5856) making appropriations for
6 the Department of Defense for the fiscal year ending Sep-
7 tember 30, 2013, and for other purposes. The first reading
8 of the bill shall be dispensed with. All points of order
9 against consideration of the bill are waived. General de-
10 bate shall be confined to the bill and shall not exceed one
11 hour equally divided and controlled by the chair and rank-
12 ing minority member of the Committee on Appropriations.
13 After general debate the bill shall be considered for
14 amendment under the five-minute rule. Points of order
15 against provisions in the bill for failure to comply with
16 clause 2 of rule XXI are waived except for section 8121.
17 During consideration of the bill for amendment, the chair
18 of the Committee of the Whole may accord priority in rec-
19 ognition on the basis of whether the Member offering an
20 amendment has caused it to be printed in the portion of

1 the Congressional Record designated for that purpose in
2 clause 8 of rule XVIII. Amendments so printed shall be
3 considered as read. When the committee rises and reports
4 the bill back to the House with a recommendation that
5 the bill do pass, the previous question shall be considered
6 as ordered on the bill and amendments thereto to final
7 passage without intervening motion except one motion to
8 recommit with or without instructions.

9 SEC. 2. At any time after the adoption of this resolu-
10 tion the Speaker may, pursuant to clause 2(b) of rule
11 XVIII, declare the House resolved into the Committee of
12 the Whole House on the state of the Union for consider-
13 ation of the bill (H.R. 6020) making appropriations for
14 financial services and general government for the fiscal
15 year ending September 30, 2013, and for other purposes.
16 The first reading of the bill shall be dispensed with. All
17 points of order against consideration of the bill are waived.
18 General debate shall be confined to the bill and shall not
19 exceed one hour equally divided and controlled by the chair
20 and ranking minority member of the Committee on Appro-
21 priations. After general debate the bill shall be considered
22 for amendment under the five-minute rule. Points of order
23 against provisions in the bill for failure to comply with
24 clause 2 of rule XXI are waived except as follows: begin-
25 ning with “: Provided” on page 95, line 9, through “level”

1 on page 95, line 11. Where points of order are waived
2 against part of a paragraph, points of order against a pro-
3 vision in another part of such paragraph may be made
4 only against such provision and not against the entire
5 paragraph. During consideration of the bill for amend-
6 ment, the chair of the Committee of the Whole may accord
7 priority in recognition on the basis of whether the Member
8 offering an amendment has caused it to be printed in the
9 portion of the Congressional Record designated for that
10 purpose in clause 8 of rule XVIII. Amendments so printed
11 shall be considered as read. When the committee rises and
12 reports the bill back to the House with a recommendation
13 that the bill do pass, the previous question shall be consid-
14 ered as ordered on the bill and amendments thereto to
15 final passage without intervening motion except one mo-
16 tion to recommit with or without instructions.

17 SEC. 3. Upon adoption of this resolution it shall be
18 in order to consider the conference report to accompany
19 the bill (H.R. 4348) to provide an extension of Federal-
20 aid highway, highway safety, motor carrier safety, transit,
21 and other programs funded out of the Highway Trust
22 Fund pending enactment of a multiyear law reauthorizing
23 such programs, and for other purposes. All points of order
24 against the conference report and against its consideration
25 are waived. The conference report shall be considered as

1 read. The previous question shall be considered as ordered
2 on the conference report to its adoption without inter-
3 vening motion except: (1) one hour of debate; and (2) one
4 motion to recommit if applicable.

5 SEC. 4. It shall be in order at any time on the legisla-
6 tive day of June 29, 2012, for the Speaker to entertain
7 motions that the House suspend the rules, as though
8 under clause 1(c) of rule XV, relating to the following:
9 (a) measures addressing expiring provisions of law; and
10 (b) a concurrent resolution correcting the enrollment of
11 H.R. 4348.

12 SEC. 5. The requirement of clause 6(a) of rule XIII
13 for a two-thirds vote to consider a report from the Com-
14 mittee on Rules on the same day it is presented to the
15 House is waived with respect to any resolution reported
16 on the legislative day of June 29, 2012, providing for con-
17 sideration or disposition of the following: (a) measures ad-
18 dressing expiring provisions of law; and (b) a concurrent
19 resolution correcting the enrollment of H.R. 4348.
