AN ACT

To provide for an additional temporary extension of programs under the Small Business Act and the Small Business Investment Act of 1958, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Small Business Addi-
3 tional Temporary Extension Act of 2011”.

4 **SEC. 2. ADDITIONAL TEMPORARY EXTENSION OF AUTHOR-
5 IZATION OF PROGRAMS UNDER THE SMALL
6 BUSINESS ACT AND THE SMALL BUSINESS IN-
7 VESTMENT ACT OF 1958.**

8 (a) IN GENERAL.—Section 1 of the Act entitled “An
9 Act to extend temporarily certain authorities of the Small
10 Business Administration”, approved October 10, 2006
11 (Public Law 109–316; 120 Stat. 1742), as most recently
12 amended by section 1 of Public Law 112–1 (125 Stat. 3),
13 is amended—

14 (1) by striking “Any” and inserting “Except as
15 provided in section 3 of the Small Business Addi-
16 tional Temporary Extension Act of 2011, any”; and

17 (2) by striking “May 31, 2011” each place it
18 appears and inserting “July 31, 2011”.

19 (b) EFFECTIVE DATE.—The amendments made by
20 subsection (a) shall take effect on May 30, 2011.

21 **SEC. 3. EXTENSION OF SBIR AND STTR TERMINATION
22 DATES.**

23 (a) SBIR.—Section 9(m) of the Small Business Act
24 (15 U.S.C. 638(m)) is amended—

1 (1) by striking “TERMINATION.—” and all that
2 follows through “the authorization” and inserting
3 “TERMINATION.—The authorization”;

4 (2) by striking “2008” and inserting “2011”;
5 and

6 (3) by striking paragraph (2).

7 (b) STTR.—Section 9(n)(1)(A) of the Small Busi-
8 ness Act (15 U.S.C. 638(n)(1)(A)) is amended—

9 (1) by striking “IN GENERAL.—” and all that
10 follows through “with respect” and inserting “IN
11 GENERAL.—With respect”;

12 (2) by striking “2009” and inserting “2011”;
13 and

14 (3) by striking clause (ii).

15 (c) COMMERCIALIZATION PILOT PROGRAM.—Section
16 9(y)(6) of the Small Business Act (15 U.S.C. 638(y)(6))
17 is amended by striking “2010” and inserting “2011”.

18 **SEC. 4. COMPETITIVE SELECTION PROCEDURES FOR SBIR**
19 **AND STTR PROGRAMS.**

20 Section 9 of the Small Business Act (15 U.S.C. 638)
21 is amended by inserting after subsection (r) the following:

22 “(s) COMPETITIVE SELECTION PROCEDURES FOR
23 SBIR AND STTR PROGRAMS.—All funds awarded, appro-
24 priated, or otherwise made available in accordance with

1 subsection (f) or (n) must be awarded pursuant to com-
2 petitive and merit-based selection procedures.”.
