For the relief of Sopuruchi Chukwueke.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ADJUSTMENT OF STATUS.**

4 (a) IN GENERAL.—Notwithstanding any other provi-
 5 sion of law, for the purposes of the Immigration and Na-
 6 tionality Act (8 U.S.C. 1101 et seq.), Sopuruchi
 7 Chukwueke shall be deemed to have been lawfully admit-
 8 ted to, and remained in, the United States, and shall be

1 eligible for adjustment of status to that of an alien law-
2 fully admitted for permanent residence under section 245
3 of the Immigration and Nationality Act (8 U.S.C. 1255)
4 upon filing an application for such adjustment of status.

5 (b) APPLICATION AND PAYMENT OF FEES.—Sub-
6 section (a) shall apply only if the application for adjust-
7 ment of status is filed with appropriate fees not later than
8 2 years after the date of the enactment of this Act.

9 (c) REDUCTION OF IMMIGRANT VISA NUMBERS.—
10 Upon the granting of permanent resident status to
11 Sopuruchi Chukwueke, the Secretary of State shall in-
12 struct the proper officer to reduce by 1, during the current
13 or next following fiscal year, the total number of immi-
14 grant visas that are made available to natives of the coun-
15 try of the birth of Sopuruchi Chukwueke under section
16 202(a)(2) of the Immigration and Nationality Act (8
17 U.S.C. 1152(a)(2)).

18 (d) DENIAL OF PREFERENTIAL IMMIGRATION TREAT-
19 MENT FOR CERTAIN RELATIVES.—*The natural parents,*
20 *brothers, and sisters of Sopuruchi Victor Chukwueke shall*
21 *not, by virtue of such relationship, be accorded any right,*
22 *privilege, or status under the Immigration and Nationality*
23 *Act (8 U.S.C. 1101 et seq.).*
