AN ACT

To repeal or modify certain mandates of the Government
Accountability Office.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “GAO Mandates Revi-
3 sion Act of 2012”.

4 **SEC. 2. REPEALS AND MODIFICATIONS.**

5 (a) **CAPITOL PRESERVATION FUND FINANCIAL**
6 **STATEMENTS.**—Section 804 of the Arizona-Idaho Con-
7 servation Act of 1988 (2 U.S.C. 2084) is amended by
8 striking “annual audits of the transactions of the Commis-
9 sion” and inserting “periodic audits of the transactions
10 of the Commission, which shall be conducted at least once
11 every 3 years, unless the Chairman or the Ranking Mem-
12 ber of the Committee on Rules and Administration of the
13 Senate or the Committee on House Administration of the
14 House of Representatives, the Secretary of the Senate, or
15 the Clerk of the House of Representatives requests that
16 an audit be conducted at an earlier date,”.

17 (b) **JUDICIAL SURVIVORS’ ANNUITIES FUND AUDIT**
18 **BY GAO.**—

19 (1) **IN GENERAL.**—Section 376 of title 28,
20 United States Code, is amended—

21 (A) by striking subsection (w); and

22 (B) by redesignating subsections (x) and
23 (y) as subsections (w) and (x), respectively.

24 (2) **TECHNICAL AND CONFORMING AMEND-**
25 **MENT.**—Section 376(h)(2) of title 28, United States

1 Code, is amended by striking “subsection (x)” and
2 inserting “subsection (w)”.

3 (c) ONDCP ANNUAL REPORT REQUIREMENT.—Sec-
4 tion 203 of the Office of National Drug Control Policy
5 Reauthorization Act of 2006 (21 U.S.C. 1708a) is amend-
6 ed—

7 (1) in subsection (a), by striking “of each year”
8 and inserting “, 2013, and every 3 years there-
9 after,”; and

10 (2) in subsection (b), in the matter preceding
11 paragraph (1), by striking “at a frequency of not
12 less than once per year—” and inserting “not later
13 than December 31, 2013, and every 3 years there-
14 after—”.

15 (d) USERRA GAO REPORT.—Section 105(g)(1) of
16 the Veterans’ Benefits Act of 2010 (Public Law 111–275;
17 38 U.S.C. 4301 note) is amended by striking “, and annu-
18 ally thereafter during the period when the demonstration
19 project is conducted,”.

20 (e) SEMIPOSTAL PROGRAM REPORTS BY THE GEN-
21 ERAL ACCOUNTING OFFICE.—Section 2 of the Semipostal
22 Authorization Act (Public Law 106–253; 114 Stat. 636;
23 39 U.S.C. 416 note) is amended—

24 (1) by striking subsection (e); and

1 (2) by redesignating subsections (d) and (e) as
2 subsections (c) and (d), respectively.

3 (f) EARNED IMPORT ALLOWANCE PROGRAM REVIEW
4 BY GAO.—Section 231A(b)(4) of the Caribbean Basin
5 Economic Recovery Act (19 U.S.C. 2703a(b)(4)) is
6 amended—

7 (1) by striking subparagraph (C); and

8 (2) by redesignating subparagraph (D) as sub-
9 paragraph (C).

10 (g) AMERICAN BATTLE MONUMENTS COMMISSION’S
11 FINANCIAL STATEMENTS AND AUDITS.—Section 2103(h)
12 of title 36, United States Code, is amended—

13 (1) in paragraph (1), by striking “of paragraph
14 (2) of this subsection” and inserting “of section
15 3515 of title 31”;

16 (2) in paragraph (1), by striking “(1)”; and

17 (3) by striking paragraph (2).

18 (h) SENATE PRESERVATION FUND AUDITS.—Section
19 3(c)(6) of the Legislative Branch Appropriations Act,
20 2004 (2 U.S.C. 2108(c)(6)) is amended by striking “an-
21 nual audits of the Senate Preservation Fund” and insert-
22 ing “periodic audits of the Senate Preservation Fund,
23 which shall be conducted at least once every 3 years, un-
24 less the Chairman or the Ranking Member of the Com-
25 mittee on Rules and Administration of the Senate or the

1 Secretary of the Senate requests that an audit be con-
2 ducted at an earlier date.”.
