A BILL

To modify a land grant patent issued by the Secretary of
the Interior.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 Congress finds that—

5 (1) pursuant to section 5505 of division A of
6 the Omnibus Consolidated Appropriations Act, 1997
7 (Public Law 104–208; 110 Stat. 3009–516), the
8 Secretary of the Interior, acting through the Bureau
9 of Land Management, issued to the Great Lakes
10 Shipwreck Historical Society located in Chippewa
11 County of the State of Michigan United States Pat-
12 ent Number 61–98–0040 on September 23, 1998;

13 (2) United States Patent Number 61–98–0040
14 was recorded in the Office of the Register of Deeds
15 of Chippewa County of the State of Michigan, on
16 January 22, 1999, at Liber 757, on pages 115
17 through 118;

18 (3) in order to correct an error in United States
19 Patent Number 61–98–0040, the Secretary issued a
20 corrected patent, United States Patent Number 61–
21 2000–0007, on March 10, 2000;

22 (4) after issuance of the corrected United
23 States Patent Number 61–2000–0007, the original
24 United States Patent Number 61–98–0040 was can-

1 celled on the records of the Bureau of Land Man-
2 agement; and

3 (5) corrected United States Patent Number 61–
4 2000–0007 should be modified in accordance with
5 this Act—

6 (A) to effectuate—

7 (i) the Human Use/Natural Resource
8 Plan for Whitefish Point, dated December
9 2002; and

10 (ii) the settlement agreement dated
11 July 16, 2001, filed in Docket Number
12 2:00–CV–206 in the United States District
13 Court for the Western District of Michi-
14 gan; and

15 (B) to ensure a clear chain of title, re-
16 corded in the Office of the Register of Deeds of
17 Chippewa County of the State of Michigan.

18 **SEC. 2. MODIFICATION OF LAND GRANT PATENT ISSUED BY**

19 **SECRETARY OF THE INTERIOR.**

20 (a) IN GENERAL.—The Secretary of the Interior shall
21 modify the matter under the heading “Subject Also to the
22 Following Conditions” of paragraph 6 of United States
23 Patent Number 61–2000–0007 by striking “Whitefish
24 Point Comprehensive Plan of October 1992 or for a gift

1 shop” and inserting “Human Use/Natural Resource Plan
2 for Whitefish Point, dated December 2002”.

3 (b) EFFECT.—Each other term of the conveyance re-
4 lating to the property that is the subject of United States
5 Patent Number 61–2000–0007, including each obligation
6 to maintain the property in accordance with the National
7 Historic Preservation Act (16 U.S.C. 470 et seq.) and any
8 other appropriate law (including regulations), and the obli-
9 gation to use the property in a manner that does not im-
10 pair or interfere with the conservation values of the prop-
11 erty, shall remain in effect.

12 **SEC. 3. EFFECTIVE DATE.**

13 (a) IN GENERAL.—The modification of United States
14 Patent Number 61–2000–0007 in accordance with section
15 2 shall become effective on the date of the recording of
16 the modification in the Office of the Register of Deeds
17 of Chippewa County of the State of Michigan.

18 (b) ENDORSEMENT.—The Office of the Register of
19 Deeds of Chippewa County of the State of Michigan is
20 requested to endorse on the recorded copy of United
21 States Patent Number 61–2000–0007 the fact that the

- 2 Act.
