RESOLUTION

To provide for expedited Senate consideration of certain nominations subject to advice and consent.

1 *Resolved,*

2 **SECTION 1. PROCEDURE FOR CONSIDERATION.**

3 (a) PRIVILEGED NOMINATIONS; INFORMATION RE-
4 QUESTED.—Upon receipt by the Senate of a nomination
5 described in section 2, the nomination shall—

6 (1) be placed on the Executive Calendar under
7 the heading “Privileged Nominations—Information
8 Requested”; and

1 (2) remain on the Executive Calendar under
 2 such heading until the Executive Clerk receives a
 3 written certification from the Chairman of the com-
 4 mittee of jurisdiction under subsection (b).

5 (b) QUESTIONNAIRES.—The Chairman of the com-
 6 mittee of jurisdiction shall notify the Executive Clerk in
 7 writing when the appropriate biographical and financial
 8 questionnaires have been received from an individual nom-
 9 inated for a position described in section 2.

10 (c) PRIVILEGED NOMINATIONS; INFORMATION RE-
 11 CEIVED.—Upon receipt of the certification under sub-
 12 section (b), the nomination shall—

13 (1) be placed on the Executive Calendar under
 14 the heading “Privileged Nomination—Information
 15 Received” and remain on the Executive Calendar
 16 under such heading for 10 session days; and

17 (2) after the expiration of the period referred to
 18 in paragraph (1), be placed on the “Nominations”
 19 section of the Executive Calendar.

20 (d) REFERRAL TO COMMITTEE OF JURISDICTION.—
 21 During the period when a nomination described in sub-
 22 section (a) is listed under the “Privileged Nomination—
 23 Information Requested” section of the Executive Calendar
 24 described in section (a)(1) or the “Privileged Nomina-

1 tion—Information Received” section of the Executive Cal-
2endar described in section (c)(1)—

3 (1) any Senator may request on his or her own
4 behalf, or on the behalf of any identified Senator
5 that the nomination be referred to the appropriate
6 committee of jurisdiction; and

7 (2) if a Senator makes a request described in
8 paragraph (1), the nomination shall be referred to
9 the appropriate committee of jurisdiction.

10 **SEC. 2. NOMINATIONS COVERED.**

11 The following nominations for the positions described
12 (including total number of individuals to be appointed for
13 the position) shall be considered under the provisions of
14 this resolution:

15 (1) The Chairman and the Members of the Ad-
16 visory Board for Cuba Broadcasting (9 Members in-
17 cluding Chairman).

18 (2) The Chairman and the Members of the Cor-
19 poration for National and Community Service (15
20 Members including Chairman).

21 (3) The Chairman and the Members of the
22 Federal Retirement Thrift Investment Boards (5
23 Members including Chairman).

24 (4) The Members of the Internal Revenue Serv-
25 ice Oversight Board (7 Members).

1 (5) The Members of the Board of the Millen-
2 nium Challenge Corporation (4 Members).

3 (6) The Members of the National Council on
4 the Arts (18 Members).

5 (7) The Members of the National Council for
6 the Humanities (26 Members).

7 (8) The Members of the Board of Directors of
8 the Overseas Private Investment Corporation (8
9 Members).

10 (9) The Members of the Peace Corps National
11 Advisory Council (15 Members).

12 (10) The Chairman, Vice Chairman, and the
13 Members of the Board of Directors for the United
14 States Institute of Peace (12 Members including
15 Chairman and Vice Chairman).

7 date of adoption of this resolution.
