## **JOINT RESOLUTION**

Making continuing appropriations for Head Start for fiscal  
year 2014, and for other purposes.

1       *Resolved by the Senate and House of Representatives*  
2       *of the United States of America in Congress assembled,*  
3       That the following sums are hereby appropriated, out of  
4       any money in the Treasury not otherwise appropriated,  
5       and out of applicable corporate or other revenues,

1 receipts, and funds, for Head Start for fiscal year 2014,  
2 and for other purposes, namely:

3       SEC. 101. (a) Such amounts as may be necessary,  
4 at a rate for operations as provided in the Full-Year Con-  
5 tinuing Appropriations Act, 2013 (division F of Public  
6 Law 113–6) and under the authority and conditions pro-  
7 vided in such Act, for continuing all projects or activities  
8 under the Head Start Act (including the costs of direct  
9 loans and loan guarantees) that are not otherwise specifi-  
10 cally provided for in this joint resolution, that were con-  
11 ducted in fiscal year 2013, and for which appropriations,  
12 funds, or other authority were made available by such Act  
13 under the heading “Department of Health and Human  
14 Services—Administration for Children and Families, Chil-  
15 dren and Families Services Programs”.

16       (b) The rate for operations provided by subsection (a)  
17 for each project or activity shall be calculated to reflect  
18 the full amount of any reduction required in fiscal year  
19 2013 pursuant to—

20           (1) any provision of division G of the Consoli-  
21 dated and Further Continuing Appropriations Act,  
22 2013 (Public Law 113–6), including section 3004;  
23 and

24           (2) the Presidential sequestration order dated  
25 March 1, 2013, except as attributable to budget au-

1           thority made available by the Disaster Relief Appro-  
2           priations Act, 2013 (Public Law 113–2).

3           SEC. 102. Appropriations made by section 101 shall  
4 be available to the extent and in the manner that would  
5 be provided by the pertinent appropriations Act.

6           SEC. 103. Unless otherwise provided for in this joint  
7 resolution or in the applicable appropriations Act for fiscal  
8 year 2014, appropriations and funds made available and  
9 authority granted pursuant to this joint resolution shall  
10 be available until whichever of the following first occurs:  
11 (1) the enactment into law of an appropriation for any  
12 project or activity provided for in this joint resolution; (2)  
13 the enactment into law of the applicable appropriations  
14 Act for fiscal year 2014 without any provision for such  
15 project or activity; or (3) December 15, 2013.

16          SEC. 104. Expenditures made pursuant to this joint  
17 resolution shall be charged to the applicable appropriation,  
18 fund, or authorization whenever a bill in which such appli-  
19 cable appropriation, fund, or authorization is contained is  
20 enacted into law.

21          SEC. 105. This joint resolution shall be implemented  
22 so that only the most limited funding action of that per-  
23 mitted in the joint resolution shall be taken in order to  
24 provide for continuation of projects and activities.

1        SEC. 106. Amounts made available under section 101  
2 for civilian personnel compensation and benefits in each  
3 department and agency may be apportioned up to the rate  
4 for operations necessary to avoid furloughs within such de-  
5 partment or agency, consistent with the applicable appro-  
6 priations Act for fiscal year 2013, except that such author-  
7 ity provided under this section shall not be used until after  
8 the department or agency has taken all necessary actions  
9 to reduce or defer non-personnel-related administrative ex-  
10 penses.

11        SEC. 107. It is the sense of Congress that this joint  
12 resolution may also be referred to as the “Head Start for  
13 Low-Income Children Act”.

14        This joint resolution may be cited as the “Head Start  
15 Continuing Appropriations Resolution, 2014”.
