3 **SECTION 1. DESIGNATION.**

4 The United States courthouse located at ~~333~~ West
5 Broadway in San Diego, California, shall be known and
6 designated as the “James M. Carter and Judith N. Keep
7 United States Courthouse”.

8 **SEC. 2. REFERENCES.**

9 Any reference in a law, map, regulation, document,
10 paper, or other record of the United States to the United
11 States courthouse referred to in section 1 shall be deemed
12 to be a reference to the “James M. Carter and Judith
13 N. Keep United States Courthouse”.

14 **SECTION 1. JUDICIAL CENTER DESIGNATION.**

15 *The United States Federal Judicial Center located at*
16 *333 West Broadway in San Diego, California, shall be*
17 *known and designated as the “John Rhoades Federal Judi-*
18 *cial Center”. The Judicial Center includes the Federal*
19 *property located at 221 West Broadway, 333 West Broad-*
20 *way, 880 Front Street, 325 West F Street, 808 Union*
21 *Street, and the adjoining plaza.*

22 **SEC. 2. COURTHOUSE BUILDING DESIGNATION.**

23 *The United States courthouse located at 333 West*
24 *Broadway in San Diego, California, shall be known and*

1 *designated as the “James M. Carter and Judith N. Keep*
2 *United States Courthouse”.*

3 **SEC. 3. REFERENCES.**

4 *Any reference in a law, map, regulation, document,*
5 *paper, or other record of the United States to the United*
6 *States Federal Judicial Center referred to in section 1 shall*
7 *be deemed to be a reference to the “John Rhoades Federal*
8 *Judicial Center”.* *Any reference in a law, map, regulation,*
9 *document, paper, or other record of the United States to*
10 *the United States courthouse referred to in section 2 shall*
11 *be deemed to be a reference to the “James M. Carter and*
12 *Judith N. Keep United States Courthouse”.*

Amend the title so as to read: “A bill to designate the United States Federal Judicial Center located at 333 West Broadway in San Diego, California, as the ‘John Rhoades Federal Judicial Center’ and to designate the United States courthouse located at 333 West Broadway in San Diego, California, as the ‘James M. Carter and Judith N. Keep United States Courthouse’.”.
