## A BILL

To amend the Controlled Substances Act to allow a veterinarian to transport and dispense controlled substances in the usual course of veterinary practice outside of the registered location.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veterinary Medicine  
5 Mobility Act of 2013”.

6 **SEC. 2. TRANSPORT AND DISPENSING OF CONTROLLED**  
7 **SUBSTANCES IN THE USUAL COURSE OF VET-**  
8 **ERINARY PRACTICE.**

9 Section 302(e) of the Controlled Substances Act (21  
10 U.S.C. 822(e)) is amended—

11 (1) by striking “(e)” and inserting “(e)(1)”;  
12 and

13 (2) by adding at the end the following:

14 “(2) Notwithstanding paragraph (1), a registrant  
15 who is a veterinarian shall not be required to have a sepa-  
16 rate registration in order to transport and dispense con-  
17 trolled substances in the usual course of veterinary prac-  
18 tice at a site other than the registrant’s registered prin-  
19 cipal place of business or professional practice, so long as  
20 the site of dispensing is located in a State where the vet-  
21 erinarian is licensed to practice veterinary medicine.”.

22 **SECTION 1. SHORT TITLE.**

23 *This Act may be cited as the “Veterinary Medicine Mo-*  
24 *bility Act of 2014”.*

10 *registration in order to transport and dispense controlled*  
11 *substances in the usual course of veterinary practice at a*  
12 *site other than the registrant’s registered principal place of*  
13 *business or professional practice, so long as the site of trans-*  
14 *porting and dispensing is located in a State where the vet-*  
15 *erinarian is licensed to practice veterinary medicine and*  
16 *is not a principal place of business or professional prac-*  
17 *tice.”.*
