## A BILL

To direct the Secretary of Defense to establish within the Department of Defense centers of excellence in the prevention, diagnosis, mitigation, treatment, and rehabilitation of health conditions relating to exposure to open burn pits.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Helping Veterans Ex-  
5        posed to Toxic Chemicals Act”.

1 **SEC. 2. CENTERS OF EXCELLENCE IN PREVENTION, DIAG-**  
2 **NOSIS, MITIGATION, TREATMENT, AND REHA-**  
3 **BILITATION OF HEALTH CONDITIONS RELAT-**  
4 **ING TO EXPOSURE TO OPEN BURN PITS AND**  
5 **OTHER EXPOSURE TO OPEN BURN PITS AND**  
6 **OTHER ENVIRONMENTAL EXPOSURES.**

7 (a) ESTABLISHMENT.—The Secretary of Defense  
8 shall establish within the Department of Defense three  
9 centers of excellence in the prevention, diagnosis, mitiga-  
10 tion, treatment, and rehabilitation of health conditions re-  
11 lating to exposure to open burn pits and other environ-  
12 mental exposures to carry out the responsibilities specified  
13 in subsection (c). Such centers shall be established  
14 using—

15 (1) the directives, policies, and Comptroller  
16 General and Inspector General recommendations in  
17 effect as of the date of the enactment of this Act;  
18 and

19 (2) guidance issued pursuant to section 313 of  
20 the National Defense Authorization Act for Fiscal  
21 Year 2013 (Public Law 112–239; 126 Stat. 1692;  
22 10 U.S.C. 1074 note).

23 (b) SELECTION OF SITES.—In selecting sites for the  
24 centers of excellence under subsection (a), the Secretary  
25 of Defense shall select entities that—

1           (1) are equipped with the specialized equipment  
2           needed to study, diagnose, and treat health condi-  
3           tions relating to exposure to open burn pits and  
4           other environmental exposures;

5           (2) have a publication track record of post-de-  
6           ployment health exposures among veterans from  
7           Iraq and Afghanistan;

8           (3) have collaborated with a geosciences depart-  
9           ment that has a medical geology division;

10          (4) have developed animal models and in vitro  
11          models of dust immunology and lung injury from  
12          Iraq and Afghanistan; and

13          (5) have expertise in allergy and immunology,  
14          pulmonary diseases, and industrial and management  
15          engineering.

16          (c) PARTNERSHIPS.—The Secretary shall ensure that  
17          the centers collaborate to the maximum extent practicable  
18          with the Secretary of Veterans Affairs, institutions of  
19          higher education, and other appropriate public and private  
20          entities (including international entities) to carry out the  
21          responsibilities specified in subsection (d).

22          (d) RESPONSIBILITIES.—The center shall have re-  
23          sponsibilities as follows:

24                  (1) To implement the comprehensive plan and  
25                  strategy for the Department of Defense for the pre-

1       vention, diagnosis, mitigation, treatment, and reha-  
2       bilitation of health conditions relating to exposure to  
3       open burn pits and other environmental exposures.

4               (2) To provide for the development, testing, and  
5       dissemination within the Department of best prac-  
6       tices for the treatment of health conditions relating  
7       to exposure to open burn pits and other environ-  
8       mental exposures.

9               (3) To provide guidance for the health system  
10      of the Department in determining the personnel re-  
11      quired to provide quality health care for members of  
12      the Armed Forces with health conditions relating to  
13      exposure to open burn pits and other environmental  
14      exposures.

15              (4) To establish, implement, and oversee a com-  
16      prehensive program to train health professionals of  
17      the Department in the treatment of health condi-  
18      tions relating to exposure to open burn pits and  
19      other environmental exposures.

20              (5) To facilitate advancements in the study of  
21      the short-term and long-term effects of exposure to  
22      open burn pits and other environmental exposures.

23              (6) To disseminate within the military medical  
24      treatment facilities of the Department best practices  
25      for training health professionals with respect to

1 health conditions relating to exposure to open burn  
2 pits and other environmental exposures.

3 (7) To conduct basic science and translational  
4 research on health conditions relating to exposure to  
5 open burn pits and other environmental exposures  
6 for the purposes of understanding the etiology of  
7 such conditions and developing preventive interven-  
8 tions and new treatments.

9 (8) To provide medical treatment to all veterans  
10 identified as part of the burn pits registry estab-  
11 lished under section 201 of the Dignified Burial and  
12 Other Veterans' Benefits Improvement Act of 2012  
13 (Public Law 112–260; 38 U.S.C. 527 note).

14 (e) USE OF BURN PITS REGISTRY DATA.—In car-  
15 rying out its responsibilities under subsection (c), the cen-  
16 ter shall have access to and make use of the data accumu-  
17 lated by the burn pits registry established under section  
18 201 of the Dignified Burial and Other Veterans' Benefits  
19 Improvement Act of 2012 (Public Law 112–260; 38  
20 U.S.C. 527 note).

21 (f) DEFINITIONS.—In this section:

22 (1) The term “open burn pit” means an area  
23 of land located in Afghanistan or Iraq that—

1 (A) is designated by the Secretary of De-  
2 fense to be used for disposing solid waste by  
3 burning in the outdoor air; and

4 (B) does not contain a commercially manu-  
5 factured incinerator or other equipment specifi-  
6 cally designed and manufactured for the burn-  
7 ing of solid waste.

8 (2) The term “other environmental exposures”  
9 means exposure to environmental hazards, including  
10 burn pits, dust or sand, hazardous materials, and  
11 waste at any site in Afghanistan or Iraq that emits  
12 smoke containing pollutants present in the environ-  
13 ment or smoke from fires or explosions.

14 (g) AUTHORIZATION OF APPROPRIATIONS.—There is  
15 authorized to be appropriated to carry out this section  
16 \$30,000,000 for each of fiscal years 2014 through 2019.
