## AN ACT

To amend the Hobby Protection Act to make unlawful the provision of assistance or support in violation of that Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Collectible Coin Pro-  
3 tection Act”.

4 **SEC. 2. PROVISION OF ASSISTANCE OR SUPPORT.**

5 The Hobby Protection Act (15 U.S.C. 2101 et seq.)  
6 is amended—

7 (1) in section 2—

8 (A) in subsection (b), by inserting “, or the  
9 sale in commerce” after “distribution in com-  
10 merce”;

11 (B) by redesignating subsection (d) as sub-  
12 section (e) and inserting after subsection (c) the  
13 following:

14 “(d) PROVISION OF ASSISTANCE OR SUPPORT.—It  
15 shall be a violation of subsection (a) or (b) for a person  
16 to provide substantial assistance or support to any manu-  
17 facturer, importer, or seller if that person knows or should  
18 have known that the manufacturer, importer, or seller is  
19 engaged in any act or practice that violates subsection (a)  
20 or (b).”; and

21 (C) in subsection (e) (as so redesignated),  
22 by striking “and (b)” and inserting “(b), and  
23 (d)”;

24 (2) in section 3—

25 (A) by striking “If any person” and insert-  
26 ing “(a) IN GENERAL.—If any person”;

1 (B) by striking “or has an agent” and in-  
2 serting “, has an agent, transacts business, or  
3 wherever venue is proper under section 1391 of  
4 title 28, United States Code”; and

5 (C) by adding at the end the following:

6 “(b) TRADEMARK VIOLATIONS.—If the violation of  
7 section 2 (a) or (b) or a rule under section 2(c) also in-  
8 volves unauthorized use of registered trademarks belong-  
9 ing to a collectibles certification service, the owner of such  
10 trademarks shall have, in addition to the remedies pro-  
11 vided in subsection (a), all rights provided under sections  
12 34, 35, and 36 of the Trademark Act of 1946 (15 U.S.C.  
13 1116, 1117, and 1118) for violations of such Act.”; and

14 (3) in section 7, by adding at the end the fol-  
15 lowing:

16 “(8) The term ‘collectibles certification service’  
17 means a person recognized by collectors for pro-  
18 viding independent certification that collectible items  
19 are genuine.

20 “(9) The term ‘Trademark Act of 1946’ means  
21 the Act entitled ‘An Act to provide for the registra-  
22 tion and protection of trademarks used in commerce,  
23 to carry out the provisions of certain international

1 conventions, and for other purposes', approved July  
2 5, 1946 (15 U.S.C. 1051 et seq.).”
