# **A BILL**

To amend the Public Health Service Act to reauthorize support for graduate medical education programs in children's hospitals.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Children’s Hospital  
5 GME Support Reauthorization Act of 2013”.

6 **SEC. 2. PROGRAM OF PAYMENTS TO CHILDREN’S HOS-**  
7 **PITALS THAT OPERATE GRADUATE MEDICAL**  
8 **EDUCATION PROGRAMS.**

9 (a) IN GENERAL.—Section 340E of the Public  
10 Health Service Act (42 U.S.C. 256e) is amended—

11 (1) in subsection (a), by striking “through 2005  
12 and each of fiscal years 2007 through 2011” and in-  
13 sserting “through 2005, each of fiscal years 2007  
14 through 2011, and each of fiscal years 2013 through  
15 2017”;

16 (2) in subsection (f)(1)(A)(iv), by inserting  
17 “and each of fiscal years 2013 through 2017” after  
18 “2011”; and

19 (3) in subsection (f)(2)(D), by inserting “and  
20 each of fiscal years 2013 through 2017” after  
21 “2011”.

22 (b) REPORT TO CONGRESS.—Section 340E(b)(3)(D)  
23 of the Public Health Service Act (42 U.S.C.  
24 256e(b)(3)(D)) is amended by striking “Not later than the

- 1 end of fiscal year 2011” and inserting “Not later than
- 2 the end of fiscal year 2016”.
