## A BILL

To provide that Members of Congress may not receive pay after October 1 of any fiscal year in which Congress has not approved a concurrent resolution on the budget and passed the regular appropriations bills.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “No Budget, No Pay  
3 Act”.

4 **SEC. 2. DEFINITION.**

5 In this section, the term “Member of Congress”—

6 (1) has the meaning given under section 2106  
7 of title 5, United States Code; and

8 (2) does not include the Vice President.

9 **SEC. 3. TIMELY APPROVAL OF CONCURRENT RESOLUTION**  
10 **ON THE BUDGET AND THE APPROPRIATIONS**  
11 **BILLS.**

12 If both Houses of Congress have not approved a con-  
13 current resolution on the budget as described under sec-  
14 tion 301 of the Congressional Budget and Impoundment  
15 Control Act of 1974 (2 U.S.C. 632) for a fiscal year before  
16 October 1 of that fiscal year and have not passed all the  
17 regular appropriations bills for the next fiscal year before  
18 October 1 of that fiscal year, the pay of each Member of  
19 Congress may not be paid for each day following that Oc-  
20 tober 1 until the date on which both Houses of Congress  
21 approve a concurrent resolution on the budget for that fis-  
22 cal year and all the regular appropriations bills.

1 **SEC. 4. NO PAY WITHOUT CONCURRENT RESOLUTION ON**  
2 **THE BUDGET AND THE APPROPRIATIONS**  
3 **BILLS.**

4 (a) **IN GENERAL.**—Notwithstanding any other provi-  
5 sion of law, no funds may be appropriated or otherwise  
6 be made available from the United States Treasury for  
7 the pay of any Member of Congress during any period de-  
8 termined by the Chairpersons of the Committee on the  
9 Budget and the Committee on Appropriations of the Sen-  
10 ate or the Chairpersons of the Committee on the Budget  
11 and the Committee on Appropriations of the House of  
12 Representatives under section 5.

13 (b) **NO RETROACTIVE PAY.**—A Member of Congress  
14 may not receive pay for any period determined by the  
15 Chairpersons of the Committee on the Budget and the  
16 Committee on Appropriations of the Senate or the Chair-  
17 persons of the Committee on the Budget and the Com-  
18 mittee on Appropriations of the House of Representatives  
19 under section 5, at any time after the end of that period.

20 **SEC. 5. DETERMINATIONS.**

21 (a) **SENATE.**—

22 (1) **REQUEST FOR CERTIFICATIONS.**—On Octo-  
23 ber 1 of each year, the Secretary of the Senate shall  
24 submit a request to the Chairpersons of the Com-  
25 mittee on the Budget and the Committee on Appro-

1        priations of the Senate for certification of deter-  
2        minations made under paragraphs (2) (A) and (B).

3            (2) DETERMINATIONS.—The Chairpersons of  
4        the Committee on the Budget and the Committee on  
5        Appropriations of the Senate shall—

6            (A) on October 1 of each year, make a de-  
7        termination of whether Congress is in compli-  
8        ance with section 3 and whether Senators may  
9        not be paid under that section;

10          (B) determine the period of days following  
11        each October 1 that Senators may not be paid  
12        under section 3; and

13          (C) provide timely certification of the de-  
14        terminations under subparagraphs (A) and (B)  
15        upon the request of the Secretary of the Senate.

16        (b) HOUSE OF REPRESENTATIVES.—

17            (1) REQUEST FOR CERTIFICATIONS.—On Octo-  
18        ber 1 of each year, the Chief Administrative Officer  
19        of the House of Representatives shall submit a re-  
20        quest to the Chairpersons of the Committee on the  
21        Budget and the Committee on Appropriations of the  
22        House of Representatives for certification of deter-  
23        minations made under paragraphs (2) (A) and (B).

24            (2) DETERMINATIONS.—The Chairpersons of  
25        the Committee on the Budget and the Committee on

1 Appropriations of the House of Representatives  
2 shall—

3 (A) on October 1 of each year, make a de-  
4 termination of whether Congress is in compli-  
5 ance with section 3 and whether Members of  
6 the House of Representatives may not be paid  
7 under that section;

8 (B) determine the period of days following  
9 each October 1 that Members of the House of  
10 Representatives may not be paid under section  
11 3; and

12 (C) provide timely certification of the de-  
13 terminations under subparagraphs (A) and (B)  
14 upon the request of the Chief Administrative  
15 Officer of the House of Representatives.

16 **SEC. 6. EFFECTIVE DATE.**

17 This section shall take effect on February 1, 2015.
