A BILL

To amend title XII of the Public Health Service Act to expand the definition of trauma to include thermal, electrical, chemical, radioactive, and other extrinsic agents.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Improving Trauma
 5 Care Act of 2013”.

6 **SEC. 2. TRAUMA DEFINITION.**

7 Paragraph (4) of section 1231 of the Public Health
 8 Service Act (42 U.S.C. 300d–31) is amended to read as
 9 follows:

10 “(4) TRAUMA.—The term ‘trauma’ means an
 11 injury resulting from exposure to—

12 “(A) a mechanical force; or

13 “(B) another extrinsic agent, including an
 14 extrinsic agent that is thermal, electrical, chem-
 15 ical, or radioactive.”.

16 **SECTION 1. SHORT TITLE.**

17 *This Act may be cited as the “Improving Trauma Care*
 18 *Act of 2014”.*

19 **SEC. 2. TRAUMA DEFINITION.**

20 (a) *REVISED DEFINITION UNDER TRAUMA SYSTEMS*
 21 *GRANTS PROGRAMS.—Paragraph (4) of section 1231 of the*
 22 *Public Health Service Act (42 U.S.C. 300d–31) is amended*
 23 *to read as follows:*

24 “(4) TRAUMA.—The term ‘trauma’ means an in-
 25 jury resulting from exposure to—

1 “(A) a mechanical force; or

2 “(B) another extrinsic agent, including an
3 extrinsic agent that is thermal, electrical, chem-
4 ical, or radioactive.”.

5 (b) *REVISED DEFINITION UNDER INTERAGENCY PRO-*
6 *GRAM FOR TRAUMA RESEARCH.—Paragraph (3) of section*
7 *1261(h) of the Public Health Service Act (42 U.S.C. 300d-*
8 *61(h)) is amended to read as follows:*

9 “(3) The term ‘trauma’ means an injury result-
10 ing from exposure to—

11 “(A) a mechanical force; or

12 “(B) another extrinsic agent, including an
13 extrinsic agent that is thermal, electrical, chem-
14 ical, or radioactive.”.
