AN ACT

To revise the boundaries of certain John H. Chafee Coastal
Barrier Resources System units.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REPLACEMENT OF JOHN H. CHAFEE COASTAL**
2 **BARRIER RESOURCES SYSTEM MAPS.**

3 (a) IN GENERAL.—The maps subtitled “Lea Island
4 Complex L07”; “Wrightsville Beach Unit L08, Masonboro
5 Island Unit L09”; and “Masonboro Island Unit L09”, in-
6 cluded in the set of maps entitled “John H. Chafee Coast-
7 al Barrier Resources System” referred to in section 4(a)
8 of the Coastal Barrier Resources Act (16 U.S.C. 3503(a))
9 and relating to certain John H. Chafee Coastal Barrier
10 Resources System units in North Carolina, are hereby re-
11 placed by other maps relating to the units entitled “Lea
12 Island Complex L07”; “Wrightsville Beach Unit L08,
13 Masonboro Island Unit L09”; and “Masonboro Island
14 Unit L09”, respectively, and dated March 12, 2014.

15 (b) AVAILABILITY.—The Secretary of the Interior
16 shall keep the replacement maps referred to in subsection
17 (a) on file and available for inspection in accordance with
18 section 4(b) of the Coastal Barrier Resources Act (16
19 U.S.C. 3503(b)).

20 **SEC. 2. REPLACEMENT OF JOHN H. CHAFEE COASTAL BAR-**
21 **RIER RESOURCES SYSTEM MAP.**

22 (a) IN GENERAL.—The map subtitled “Sachuest
23 Point Unit RI–04P, Easton Beach Unit RI–05P, Almy
24 Pond Unit RI–06, Hazards Beach Unit RI–07”, included
25 in the set of maps entitled “John H. Chafee Coastal Bar-
26 rier Resources System” referred to in section 4(a) of the

1 Coastal Barrier Resources Act (16 U.S.C. 3503(a)) and
 2 relating to certain John H. Chafee Coastal Barrier Re-
 3 sources System units in Rhode Island, is hereby replaced
 4 by another map relating to the units entitled “John H.
 5 Chafee Coastal Barrier Resources System Sachuest Point
 6 Unit RI-04P, Easton Beach Unit RI-05P, Almy Pond
 7 Unit RI-06, and Hazards Beach Unit RI-07” and dated
 8 September 16, 2013.

9 (b) AVAILABILITY.—The Secretary of the Interior
 10 shall keep the replacement map referred to in subsection
 11 (a) on file and available for inspection in accordance with
 12 the provisions of section 4(b) of the Coastal Barrier Re-
 13 sources Act (16 U.S.C. 3503(b)).

14 **SEC. 3. JOHN H. CHAFEE COASTAL BARRIER RESOURCES**
 15 **SYSTEM GASPARILLA ISLAND UNIT, FLORIDA.**

16 (a) IN GENERAL.—The map subtitled “Gasparilla Is-
 17 land Unit FL-70P” included in the set of maps entitled
 18 “Coastal Barrier Resources System” referred to in section
 19 4(a) of the Coastal Barrier Resources Act (16 U.S.C.
 20 3503(a)) and relating to the Gasparilla Island Unit in
 21 Florida is hereby replaced by another map relating to the
 22 same unit entitled “John H. Chafee Coastal Barrier Re-
 23 sources System Gasparilla Unit FL-70/FL-70P”, draft
 24 dated May 23, 2012.

1 (b) AVAILABILITY.—The Secretary of the Interior
2 shall keep the replacement map referred to in subsection
3 (a) on file and available for inspection in accordance with
4 section 4(b) of the Coastal Barrier Resources Act (16
5 U.S.C. 3503(b)).

6 **SEC. 4. REMOVAL OF PROPERTIES IN SOUTH CAROLINA**
7 **FROM JOHN H. CHAFEE COASTAL BARRIER**
8 **RESOURCES SYSTEM.**

9 (a) IN GENERAL.—The map subtitled “Long Pond
10 Unit SC–01” included in the sets of maps entitled “Coast-
11 al Barrier Resources System” referred to in section 4(a)
12 of the Coastal Barrier Resources Act (16 U.S.C. 3503(a))
13 and relating to the Long Pond Unit in South Carolina
14 is hereby replaced by another map relating to the same
15 unit entitled “John H. Chafee Coastal Barrier Resources
16 System Long Pond Unit SC–01” dated September 30,
17 2014.

18 (b) AVAILABILITY.—The Secretary of the Interior
19 shall keep each map revised under subsection (a) on file
20 and available for inspection in accordance with section
21 4(b) of the Coastal Barrier Resources Act (16 U.S.C.
22 3503(b)).

1 **SEC. 5. REMOVAL OF PROPERTIES IN SOUTH CAROLINA**
2 **FROM JOHN H. CHAFEE COASTAL BARRIER**
3 **RESOURCES SYSTEM.**

4 (a) IN GENERAL.—The map subtitled “Huntington
5 Beach Unit SC–03” included in the sets of maps entitled
6 “Coastal Barrier Resources System” referred to in section
7 4(a) of the Coastal Barrier Resources Act (16 U.S.C.
8 3503(a)) and relating to the Huntington Beach Unit in
9 South Carolina is hereby replaced by another map relating
10 to the same unit entitled “John H. Chafee Coastal Barrier
11 Resources System Huntington Beach Unit SC–03” dated
12 September 30, 2014.

13 (b) AVAILABILITY.—The Secretary of the Interior
14 shall keep each map revised under subsection (a) on file
15 and available for inspection in accordance with section
16 4(b) of the Coastal Barrier Resources Act (16 U.S.C.
17 3503(b)).
