1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REPLACEMENT OF JOHN H. CHAFEE COASTAL**
4 **BARRIER RESOURCES SYSTEM MAPS.**

5 (a) *IN GENERAL.*—*The maps subtitled “Lea Island*
6 *Complex L07”; “Wrightsville Beach Unit L08, Masonboro*
7 *Island Unit L09”; and “Masonboro Island Unit L09”, in-*
8 *cluded in the set of maps entitled “John H. Chafee Coastal*
9 *Barrier Resources System” referred to in section 4(a) of the*
10 *Coastal Barrier Resources Act (16 U.S.C. 3503(a)) and re-*
11 *lating to certain John H. Chafee Coastal Barrier Resources*
12 *System units in North Carolina, are hereby replaced by*
13 *other maps relating to the units entitled “Lea Island Com-*
14 *plex L07”; “Wrightsville Beach Unit L08, Masonboro Is-*
15 *land Unit L09”; and “Masonboro Island Unit L09”, respec-*
16 *tively, and dated March 12, 2014.*

17 (b) *AVAILABILITY.*—*The Secretary of the Interior shall*
18 *keep the replacement maps referred to in subsection (a) on*
19 *file and available for inspection in accordance with section*
20 *4(b) of the Coastal Barrier Resources Act (16 U.S.C.*
21 *3503(b)).*
