# **A BILL**

To extend the legislative authority of the Adams Memorial Foundation to establish a commemorative work in honor of former President John Adams and his legacy, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF LEGISLATIVE AUTHORITY FOR**  
4 **MEMORIAL ESTABLISHMENT.**

5 *Section 1 of Public Law 107–62 (40 U.S.C. 1003 note),*  
6 *as amended by Public Law 111–169, is amended—*

7 *(1) by striking “2013” and inserting “2020” in*  
8 *subsection (c); and*

9 *(2) by amending subsection (e) to read as fol-*  
10 *lows:*

11 *“(e) DEPOSIT OF EXCESS FUNDS FOR ESTABLISHED*  
12 *MEMORIAL.—*

13 *“(1) If upon payment of all expenses for the es-*  
14 *tablishment of the memorial (including the mainte-*  
15 *nance and preservation amount required by section*  
16 *8906(b)(1) of title 40, United States Code), there re-*  
17 *mains a balance of funds received for the establish-*  
18 *ment of the commemorative work, the Adams Memo-*  
19 *rial Foundation shall transmit the amount of the bal-*  
20 *ance to the account provided for in section 8906(b)(3)*  
21 *of title 40, United States Code.*

22 *“(2) If upon expiration of the authority for the*  
23 *commemorative work under section 8903(e) of title*  
24 *40, United States Code, there remains a balance of*  
25 *funds received for the establishment of the commemo-*

1        *rative work, the Adams Memorial Foundation shall*  
2        *transmit the amount of the balance to a separate ac-*  
3        *count with the National Park Foundation for memo-*  
4        *rials, to be available to the Secretary of the Interior*  
5        *or the Administrator (as appropriate) following the*  
6        *process provided for in section 8906(b)(4) of title 40,*  
7        *United States Code, for accounts established under*  
8        *section 8906(b)(2) or (3) of title 40, United States*  
9        *Code.”.*
