AN ACT

Making appropriations for the Legislative Branch for the
fiscal year ending September 30, 2015, and for other
purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 Legislative Branch for the fiscal year ending September
6 30, 2015, and for other purposes, namely:

1 TITLE I—LEGISLATIVE BRANCH

2 HOUSE OF REPRESENTATIVES

3 SALARIES AND EXPENSES

4 For salaries and expenses of the House of Represent-
5 atives, \$1,180,736,000, as follows:

6 HOUSE LEADERSHIP OFFICES

7 For salaries and expenses, as authorized by law,
8 \$22,278,891, including: Office of the Speaker,
9 \$6,645,417, including \$25,000 for official expenses of the
10 Speaker; Office of the Majority Floor Leader, \$2,180,048,
11 including \$10,000 for official expenses of the Majority
12 Leader; Office of the Minority Floor Leader, \$7,114,471,
13 including \$10,000 for official expenses of the Minority
14 Leader; Office of the Majority Whip, including the Chief
15 Deputy Majority Whip, \$1,886,632, including \$5,000 for
16 official expenses of the Majority Whip; Office of the Mi-
17 nority Whip, including the Chief Deputy Minority Whip,
18 \$1,459,639, including \$5,000 for official expenses of the
19 Minority Whip; Republican Conference, \$1,505,426;
20 Democratic Caucus, \$1,487,258: *Provided*, That such
21 amount for salaries and expenses shall remain available
22 from January 3, 2015 until January 2, 2016.

1 MEMBERS' REPRESENTATIONAL ALLOWANCES
 2 INCLUDING MEMBERS' CLERK HIRE, OFFICIAL
 3 EXPENSES OF MEMBERS, AND OFFICIAL MAIL

4 For Members' representational allowances, including
 5 Members' clerk hire, official expenses, and official mail,
 6 \$554,317,732.

7 COMMITTEE EMPLOYEES

8 STANDING COMMITTEES, SPECIAL AND SELECT

9 For salaries and expenses of standing committees,
 10 special and select, authorized by House resolutions,
 11 \$123,903,173: *Provided*, That such amount shall remain
 12 available for such salaries and expenses until December
 13 31, 2016, except that \$2,300,000 of such amount shall
 14 remain available until expended for committee room up-
 15 grading.

16 COMMITTEE ON APPROPRIATIONS

17 For salaries and expenses of the Committee on Ap-
 18 propriations, \$23,271,004, including studies and examina-
 19 tions of executive agencies and temporary personal serv-
 20 ices for such committee, to be expended in accordance with
 21 section 202(b) of the Legislative Reorganization Act of
 22 1946 and to be available for reimbursement to agencies
 23 for services performed: *Provided*, That such amount shall
 24 remain available for such salaries and expenses until De-
 25 cember 31, 2016.

1 SALARIES, OFFICERS AND EMPLOYEES

2 For compensation and expenses of officers and em-
3 ployees, as authorized by law, \$171,344,864, including:
4 for salaries and expenses of the Office of the Clerk, includ-
5 ing the positions of the Chaplain and the Historian, and
6 including not more than \$25,000 for official representative
7 and reception expenses, of which not more than \$20,000
8 is for the Family Room and not more than \$2,000 is for
9 the Office of the Chaplain, \$24,009,473; for salaries and
10 expenses of the Office of the Sergeant at Arms, including
11 the position of Superintendent of Garages and the Office
12 of Emergency Management, and including not more than
13 \$3,000 for official representation and reception expenses,
14 \$11,926,729 of which \$4,344,000 shall remain available
15 until expended; for salaries and expenses of the Office of
16 the Chief Administrative Officer including not more than
17 \$3,000 for official representation and reception expenses,
18 \$113,100,000, of which \$4,000,000 shall remain available
19 until expended; for salaries and expenses of the Office of
20 the Inspector General, \$4,741,809; for salaries and ex-
21 penses of the Office of General Counsel, \$1,340,987; for
22 salaries and expenses of the Office of the Parliamentarian,
23 including the Parliamentarian, \$2,000 for preparing the
24 Digest of Rules, and not more than \$1,000 for official rep-
25 resentation and reception expenses, \$1,952,249; for sala-

1 ries and expenses of the Office of the Law Revision Coun-
 2 sel of the House, \$4,087,587, of which \$1,000,000 shall
 3 remain available until expended for the completion of the
 4 House Modernization Initiative; for salaries and expenses
 5 of the Office of the Legislative Counsel of the House,
 6 \$8,892,975, of which \$540,000 shall remain available
 7 until expended for the completion of the House Moderniza-
 8 tion Initiative; for salaries and expenses of the Office of
 9 Interparliamentary Affairs, \$814,069; for other author-
 10 ized employees, \$478,986.

11 ALLOWANCES AND EXPENSES

12 For allowances and expenses as authorized by House
 13 resolution or law, \$285,620,336, including: supplies, mate-
 14 rials, administrative costs and Federal tort claims,
 15 \$4,152,789; official mail for committees, leadership of-
 16 fices, and administrative offices of the House, \$190,486;
 17 Government contributions for health, retirement, Social
 18 Security, and other applicable employee benefits,
 19 \$256,635,776; to remain available until March 31, 2016;
 20 Business Continuity and Disaster Recovery, \$16,217,008
 21 of which \$5,000,000 shall remain available until expended;
 22 transition activities for new members and staff,
 23 \$3,737,000; to remain available until expended; Wounded
 24 Warrior Program \$2,500,000; to remain available until
 25 expended; Office of Congressional Ethics, \$1,467,030; and

1 miscellaneous items including purchase, exchange, mainte-
 2 nance, repair and operation of House motor vehicles,
 3 interparliamentary receptions, and gratuities to heirs of
 4 deceased employees of the House, \$720,247.

5 ADMINISTRATIVE PROVISIONS

6 SEC. 101. (a) ~~REQUIRING AMOUNTS REMAINING IN~~
 7 ~~MEMBERS' REPRESENTATIONAL ALLOWANCES TO BE~~
 8 ~~USED FOR DEFICIT REDUCTION OR TO REDUCE THE~~
 9 ~~FEDERAL DEBT.~~—Notwithstanding any other provision of
 10 law, any amounts appropriated under this Act for
 11 “HOUSE OF REPRESENTATIVES—SALARIES AND
 12 EXPENSES—MEMBERS' REPRESENTATIONAL ALLOW-
 13 ANCES” shall be available only for fiscal year 2015. Any
 14 amount remaining after all payments are made under such
 15 allowances for fiscal year 2015 shall be deposited in the
 16 Treasury and used for deficit reduction (or, if there is no
 17 Federal budget deficit after all such payments have been
 18 made, for reducing the Federal debt, in such manner as
 19 the Secretary of the Treasury considers appropriate).

20 (b) ~~REGULATIONS.~~—The Committee on House Ad-
 21 ministration of the House of Representatives shall have
 22 authority to prescribe regulations to carry out this section.

23 (c) ~~DEFINITION.~~—As used in this section, the term
 24 “Member of the House of Representatives” means a Rep-

1 representative in, or a Delegate or Resident Commissioner
2 to, the Congress.

3 ~~DELIVERY OF BILLS AND RESOLUTIONS~~

4 ~~SEC. 102.~~ None of the funds made available in this
5 Act may be used to deliver a printed copy of a bill, joint
6 resolution, or resolution to the office of a Member of the
7 House of Representatives (including a Delegate or Resi-
8 dent Commissioner to the Congress) unless the Member
9 requests a copy.

10 ~~DELIVERY OF CONGRESSIONAL RECORD~~

11 ~~SEC. 103.~~ None of the funds made available by this
12 Act may be used to deliver a printed copy of any version
13 of the Congressional Record to the office of a Member of
14 the House of Representatives (including a Delegate or
15 Resident Commissioner to the Congress).

16 ~~LIMITATION ON AMOUNT AVAILABLE TO LEASE VEHICLES~~

17 ~~SEC. 104.~~ None of the funds made available in this
18 Act may be used by the Chief Administrative Officer of
19 the House of Representatives to make any payments from
20 any Members' Representational Allowance for the leasing
21 of a vehicle, excluding mobile district offices, in an aggre-
22 gate amount that exceeds \$1,000 for the vehicle in any
23 month.

3 SEC. 105. None of the funds made available by this
4 Act may be used to provide an aggregate number of more
5 than 50 printed copies of any edition of the United States
6 Code to all offices of the House of Representatives.

9 JOINT ECONOMIC COMMITTEE

10 For salaries and expenses of the Joint Economic
11 Committee, \$4,203,000, to be disbursed by the Secretary
12 of the Senate.

13 JOINT COMMITTEE ON TAXATION

14 For salaries and expenses of the Joint Committee on
15 Taxation, \$10,004,000, to be disbursed by the Chief Ad-
16 ministrative Officer of the House of Representatives.

17 For other joint items, as follows:

18 OFFICE OF THE ATTENDING PHYSICIAN

19 For medical supplies, equipment, and contingent ex-
20 penses of the emergency rooms, and for the Attending
21 Physician and his assistants, including:

(1) an allowance of \$2,175 per month to the
Attending Physician;

(2) an allowance of \$1,300 per month to the Senior Medical Officer;

1 ~~(3)~~ an allowance of \$725 per month each to
 2 three medical officers while on duty in the Office of
 3 the Attending Physician;

4 ~~(4)~~ an allowance of \$725 per month to 2 assist-
 5 ants and \$580 per month each not to exceed 11 as-
 6 sistants on the basis heretofore provided for such as-
 7 sistants; and

8 ~~(5)~~ \$2,486,000 for reimbursement to the De-
 9 partment of the Navy for expenses incurred for staff
 10 and equipment assigned to the Office of the Attend-
 11 ing Physician, which shall be advanced and credited
 12 to the applicable appropriation or appropriations
 13 from which such salaries, allowances, and other ex-
 14 penses are payable and shall be available for all the
 15 purposes thereof, \$3,371,000, to be disbursed by the
 16 Chief Administrative Officer of the House of Rep-

18 OFFICE OF CONGRESSIONAL ACCESSIBILITY SERVICES

19 SALARIES AND EXPENSES

20 For salaries and expenses of the Office of Congres-
 21 sional Accessibility Services, \$1,387,000, to be disbursed
 22 by the Secretary of the Senate.

CAPITOL POLICE

SALARIES

For salaries of employees of the Capitol Police, including overtime, hazardous duty pay, and Government contributions for health, retirement, social security, professional liability insurance, and other applicable employee benefits, \$286,500,000 of which overtime shall not exceed \$23,425,000 unless the Committee on Appropriations of the House and Senate are notified, to be disbursed by the Chief of the Capitol Police or his designee.

GENERAL EXPENSES

For necessary expenses of the Capitol Police, including motor vehicles, communications and other equipment, security equipment and installation, uniforms, weapons, supplies, materials, training, medical services, forensic services, stenographic services, personal and professional services, the employee assistance program, the awards program, postage, communication services, travel advances, relocation of instructor and liaison personnel for the Federal Law Enforcement Training Center, and not more than \$5,000 to be expended on the certification of the Chief of the Capitol Police in connection with official representation and reception expenses, \$61,459,000, to be disbursed by the Chief of the Capitol Police or his designee: *Provided*, That, notwithstanding any other provi-

1 sion of law, the cost of basic training for the Capitol Police
 2 at the Federal Law Enforcement Training Center for fis-
 3 cal year 2015 shall be paid by the Secretary of Homeland
 4 Security from funds available to the Department of Home-
 5 land Security.

6 OFFICE OF COMPLIANCE

7 SALARIES AND EXPENSES

8 For salaries and expenses of the Office of Compli-
 9 ance, as authorized by section 305 of the Congressional
 10 Accountability Act of 1995 (2 U.S.C. 1385), \$3,959,000
 11 (increased by \$500,000), of which \$450,000 shall remain
 12 available until September 30, 2016: *Provided*, That not
 13 more than \$500 may be expended on the certification of
 14 the Executive Director of the Office of Compliance in con-
 15 nection with official representation and reception ex-
 16 penses.

17 CONGRESSIONAL BUDGET OFFICE

18 SALARIES AND EXPENSES

19 For salaries and expenses necessary for operation of
 20 the Congressional Budget Office, including not more than
 21 \$6,000 to be expended on the certification of the Director
 22 of the Congressional Budget Office in connection with offi-
 23 cial representation and reception expenses, \$45,700,000.

1 ARCHITECT OF THE CAPITOL

2 GENERAL ADMINISTRATION

3 For salaries for the Architect of the Capitol, and
4 other personal services, at rates of pay provided by law;
5 for surveys and studies in connection with activities under
6 the care of the Architect of the Capitol; for all necessary
7 expenses for the general and administrative support of the
8 operations under the Architect of the Capitol including the
9 Botanic Garden; electrical substations of the Capitol, Sen-
10 ate and House office buildings, and other facilities under
11 the jurisdiction of the Architect of the Capitol; including
12 furnishings and office equipment; including not more than
13 \$5,000 for official reception and representation expenses;
14 to be expended as the Architect of the Capitol may ap-
15 prove; for purchase or exchange, maintenance, and oper-
16 ation of a passenger motor vehicle, \$91,555,000 (reduced
17 by \$500,000).

18 CAPITOL BUILDING

19 For all necessary expenses for the maintenance, care
20 and operation of the Capitol, \$53,126,000, of which
21 \$28,817,000 shall remain available until September 30,
22 2019.

23 CAPITOL GROUNDS

24 For all necessary expenses for care and improvement
25 of grounds surrounding the Capitol, the Senate and House

1 office buildings, and the Capitol Power Plant,
 2 \$11,993,000, of which \$2,000,000 shall remain available
 3 until September 30, 2019.

4 HOUSE OFFICE BUILDINGS

5 For all necessary expenses for the maintenance, care
 6 and operation of the House office buildings, \$71,622,000,
 7 of which \$7,000,000 shall remain available until Sep-
 8 tember 30, 2019.

9 In addition, for a payment to the House Historic
 10 Buildings Revitalization Trust Fund, \$70,000,000, to re-
 11 main available until expended.

12 CAPITOL POWER PLANT

13 For all necessary expenses for the maintenance, care
 14 and operation of the Capitol Power Plant; lighting, heat-
 15 ing; power (including the purchase of electrical energy)
 16 and water and sewer services for the Capitol, Senate and
 17 House office buildings, Library of Congress buildings, and
 18 the grounds about the same; Botanic Garden, Senate ga-
 19 rage, and air conditioning refrigeration not supplied from
 20 plants in any of such buildings; heating the Government
 21 Printing Office and Washington City Post Office, and
 22 heating and chilled water for air conditioning for the Su-
 23 preme Court Building, the Union Station complex, the
 24 Thurgood Marshall Federal Judiciary Building and the
 25 Folger Shakespeare Library, expenses for which shall be

1 advanced or reimbursed upon request of the Architect of
 2 the Capitol and amounts so received shall be deposited
 3 into the Treasury to the credit of this appropriation,
 4 \$93,152,000, of which \$8,686,000 shall remain available
 5 until September 30, 2019: *Provided*, That not more than
 6 \$9,000,000 of the funds credited or to be reimbursed to
 7 this appropriation as herein provided shall be available for
 8 obligation during fiscal year 2015.

9 LIBRARY BUILDINGS AND GROUNDS

10 For all necessary expenses for the mechanical and
 11 structural maintenance, care and operation of the Library
 12 buildings and grounds, \$41,733,000, of which
 13 \$16,542,000 shall remain available until September 30,
 14 2019.

15 CAPITOL POLICE BUILDINGS, GROUNDS, AND SECURITY

16 For all necessary expenses for the maintenance, care
 17 and operation of buildings, grounds and security enhance-
 18 ments of the United States Capitol Police, wherever lo-
 19 cated, the Alternate Computer Facility, and AOC security
 20 operations, \$19,486,000, of which \$1,000,000 shall re-
 21 main available until September 30, 2019.

22 BOTANIC GARDEN

23 For all necessary expenses for the maintenance, care
 24 and operation of the Botanic Garden and the nurseries,
 25 buildings, grounds, and collections; and purchase and ex-

1 change, maintenance, repair, and operation of a passenger
 2 motor vehicle; all under the direction of the Joint Com-
 3 mittee on the Library, \$15,022,946 (reduced by
 4 \$3,166,946), of which \$5,122,946 shall remain available
 5 until September 30, 2019: *Provided*, That of the amount
 6 made available under this heading, the Architect of the
 7 Capitol may obligate and expend such sums as may be
 8 necessary for the maintenance, care and operation of the
 9 National Garden established under section 307E of the
 10 Legislative Branch Appropriations Act, 1989 (2 U.S.C.
 11 2146), upon vouchers approved by the Architect of the
 12 Capitol or a duly authorized designee.

13 CAPITOL VISITOR CENTER

14 For all necessary expenses for the operation of the
 15 Capitol Visitor Center, \$20,875,000.

16 ADMINISTRATIVE PROVISION

17 SCRIMS

18 SEC. 1001. None of the funds made available by this
 19 Act may be used for scrims containing photographs of
 20 building facades during restoration or construction
 21 projects performed by the Architect of the Capitol.

22 LIBRARY OF CONGRESS

23 SALARIES AND EXPENSES

24 For necessary expenses of the Library of Congress
 25 not otherwise provided for, including development and

1 maintenance of the Library's catalogs; custody and custo-
2 dial care of the Library buildings; special clothing; clean-
3 ing; laundering and repair of uniforms; preservation of
4 motion pictures in the custody of the Library; operation
5 and maintenance of the American Folklife Center in the
6 Library; activities under the Civil Rights History Project
7 Act of 2009; preparation and distribution of catalog
8 records and other publications of the Library; hire or pur-
9 chase of one passenger motor vehicle; and expenses of the
10 Library of Congress Trust Fund Board not properly
11 chargeable to the income of any trust fund held by the
12 Board, \$424,057,000, of which not more than \$6,000,000
13 shall be derived from collections credited to this appropria-
14 tion during fiscal year 2015, and shall remain available
15 until expended, under the Act of June 28, 1902 (chapter
16 1301, 32 Stat. 480, 2 U.S.C. 150) and not more than
17 \$350,000 shall be derived from collections during fiscal
18 year 2015 and shall remain available until expended for
19 the development and maintenance of an international legal
20 information database and activities related thereto: *Pro-*
21 *vided*, That the Library of Congress may not obligate or
22 expend any funds derived from collections under the Act
23 of June 28, 1902, in excess of the amount authorized for
24 obligation or expenditure in appropriations Acts: *Provided*
25 *further*, That the total amount available for obligation

1 shall be reduced by the amount by which collections are
 2 less than \$6,350,000: *Provided further*, That of the total
 3 amount appropriated, not more than \$12,000 may be ex-
 4 pended, on the certification of the Librarian of Congress,
 5 in connection with official representation and reception ex-
 6 penses for the Overseas Field Offices: *Provided further*,
 7 That of the total amount appropriated, \$8,231,000 shall
 8 remain available until expended for the digital collections
 9 and educational curricula program.

10 COPYRIGHT OFFICE

11 SALARIES AND EXPENSES

12 For all necessary expenses of the Copyright Office,
 13 \$54,303,000, of which not more than \$27,971,000, to re-
 14 main available until expended, shall be derived from collec-
 15 tions credited to this appropriation during fiscal year 2015
 16 under section 708(d) of title 17, United States Code: *Pro-*
 17 *vided*, That the Copyright Office may not obligate or ex-
 18 pend any funds derived from collections under such sec-
 19 tion, in excess of the amount authorized for obligation or
 20 expenditure in appropriations Acts: *Provided further*, That
 21 not more than \$5,611,000 shall be derived from collections
 22 during fiscal year 2015 under sections 111(d)(2),
 23 119(b)(2), 803(e), 1005, and 1316 of such title: *Provided*
 24 *further*, That the total amount available for obligation
 25 shall be reduced by the amount by which collections are

1 less than ~~\$23,582,000~~: *Provided further*, That not more
 2 than \$100,000 of the amount appropriated is available for
 3 the maintenance of an “International Copyright Institute”
 4 in the Copyright Office of the Library of Congress for the
 5 purpose of training nationals of developing countries in
 6 intellectual property laws and policies: *Provided further*,
 7 That not more than \$6,500 may be expended, on the cer-
 8 tification of the Librarian of Congress, in connection with
 9 official representation and reception expenses for activities
 10 of the International Copyright Institute and for copyright
 11 delegations, visitors, and seminars: *Provided further*, That
 12 notwithstanding any provision of chapter 8 of title 17,
 13 United States Code, any amounts made available under
 14 this heading which are attributable to royalty fees and
 15 payments received by the Copyright Office pursuant to
 16 sections 111, 119, and chapter 10 of such title may be
 17 used for the costs incurred in the administration of the
 18 Copyright Royalty Judges program, with the exception of
 19 the costs of salaries and benefits for the Copyright Royalty
 20 Judges and staff under section 802(e).

21 CONGRESSIONAL RESEARCH SERVICE

22 SALARIES AND EXPENSES

23 For necessary expenses to carry out the provisions
 24 of section 203 of the Legislative Reorganization Act of
 25 1946 (2 U.S.C. 166) and to revise and extend the Anno-

1 tated Constitution of the United States of America;
 2 \$106,095,000: *Provided*, That no part of such amount
 3 may be used to pay any salary or expense in connection
 4 with any publication, or preparation of material therefor
 5 (except the Digest of Public General Bills), to be issued
 6 by the Library of Congress unless such publication has
 7 obtained prior approval of either the Committee on House
 8 Administration of the House of Representatives or the
 9 Committee on Rules and Administration of the Senate.

10 BOOKS FOR THE BLIND AND PHYSICALLY HANDICAPPED
 11 SALARIES AND EXPENSES

12 For salaries and expenses to carry out the Act of
 13 March 3, 1931 (chapter 400; 46 Stat. 1487; 2 U.S.C.
 14 135a), \$50,429,000: *Provided*, That of the total amount
 15 appropriated, \$650,000 shall be available to contract to
 16 provide newspapers to blind and physically handicapped
 17 residents at no cost to the individual.

18 ADMINISTRATIVE PROVISION

19 REIMBURSABLE AND REVOLVING FUND ACTIVITIES

20 SEC. 1101. (a) IN GENERAL.—For fiscal year 2015,
 21 the obligational authority of the Library of Congress for
 22 the activities described in subsection (b) may not exceed
 23 \$203,058,000.

24 (b) ACTIVITIES.—The activities referred to in sub-
 25 section (a) are reimbursable and revolving fund activities

1 that are funded from sources other than appropriations
 2 to the Library in appropriations Acts for the legislative
 3 branch.

4 GOVERNMENT PRINTING OFFICE

5 CONGRESSIONAL PRINTING AND BINDING

6 (INCLUDING TRANSFER OF FUNDS)

7 For authorized printing and binding for the Congress
 8 and the distribution of Congressional information in any
 9 format; expenses necessary for preparing the semimonthly
 10 and session index to the Congressional Record, as author-
 11 ized by law (section 902 of title 44, United States Code);
 12 printing and binding of Government publications author-
 13 ized by law to be distributed to Members of Congress; and
 14 printing, binding, and distribution of Government publica-
 15 tions authorized by law to be distributed without charge
 16 to the recipient, \$79,736,000: *Provided*, That this appro-
 17 priation shall not be available for paper copies of the per-
 18 manent edition of the Congressional Record for individual
 19 Representatives, Resident Commissioners or Delegates au-
 20 thorized under section 906 of title 44, United States Code:
 21 *Provided further*, That this appropriation shall be available
 22 for the payment of obligations incurred under the appro-
 23 priations for similar purposes for preceding fiscal years:
 24 *Provided further*, That notwithstanding the 2-year limita-
 25 tion under section 718 of title 44, United States Code,

1 none of the funds appropriated or made available under
 2 this Act or any other Act for printing and binding and
 3 related services provided to Congress under chapter 7 of
 4 title 44, United States Code, may be expended to print
 5 a document, report, or publication after the 27-month pe-
 6 riod beginning on the date that such document, report,
 7 or publication is authorized by Congress to be printed, un-
 8 less Congress reauthorizes such printing in accordance
 9 with section 718 of title 44, United States Code: *Provided*
 10 *further*, That any unobligated or unexpended balances in
 11 this account or accounts for similar purposes for preceding
