Resolved, That the House agree to the amendment of the Senate to the bill (H.R. 588) entitled “An Act to provide for donor contribution acknowledgments to be displayed at the Vietnam Veterans Memorial Visitor Center, and for other purposes.”, with the following

HOUSE AMENDMENT TO SENATE AMENDMENT:

In lieu of the matter proposed to be inserted by the amendment of the Senate to the text of the bill, insert the following:

1 ***SECTION 1. SHORT TITLE.***

2 *This Act may be cited as the “Vietnam Veterans Donor*
3 *Acknowledgment Act of 2013”.*

4 ***SEC. 2. DONOR CONTRIBUTION ACKNOWLEDGMENTS AT***
5 ***THE VIETNAM VETERANS MEMORIAL VISITOR***
6 ***CENTER.***

7 *Section 6(b) of Public Law 96–297 (16 U.S.C. 431*
8 *note) is amended—*

9 *(1) in paragraph (4) by striking the “and” after*
10 *the semicolon;*

11 *(2) in paragraph (5)—*

12 *(A) by striking “2014” and inserting*
13 *“2018”; and*

1 (B) by striking the period and inserting “;
2 and”; and

3 (3) by inserting at the end the following new
4 paragraph:

5 “(6) notwithstanding section 8905(b)(7) of title
6 40, United States Code—

7 “(A) the Secretary of the Interior shall
8 allow the Vietnam Veterans Memorial Fund, Inc.
9 to acknowledge donor contributions to the visitor
10 center by displaying, inside the visitor center, an
11 appropriate statement or credit acknowledging
12 the contribution;

13 “(B) donor contribution acknowledgments
14 shall be displayed in a form approved by the
15 Secretary of the Interior and for a period of time
16 commensurate with the level of the contribution
17 and the life of the facility;

18 “(C) the Vietnam Veterans Memorial Fund
19 shall bear all expenses related to the display of
20 donor acknowledgments;

21 “(D) prior to the display of donor acknowl-
22 edgments, the Vietnam Veterans Memorial Fund,
23 Inc. shall submit to the Secretary for approval,
24 its plan for displaying donor acknowledgments;

1 “(E) such plan shall include the sample text
2 and types of the acknowledgments or credits to be
3 displayed and the form and location of all dis-
4 plays;

5 “(F) the Secretary shall approve the plan,
6 if the Secretary determines that the plan—

7 “(i) allows only short, discrete, and
8 unobtrusive acknowledgments or credits;

9 “(ii) does not permit any advertising
10 slogans or company logos; and

11 “(iii) conforms to applicable National
12 Park Service guidelines for indoor donor
13 recognition; and

14 “(G) if the Secretary of the Interior deter-
15 mines that the proposed plan submitted under
16 this paragraph, does not meet the requirements
17 of this paragraph, the Secretary shall—

18 “(i) advise the Vietnam Veterans Me-
19 morial Fund, Inc. not later than 30 days
20 after receipt of the proposed plan of the rea-
21 sons that such plan does not meet the re-
22 quirements; and

- 1 “(ii) allow the Vietnam Veterans Me-
- 2 morial Fund, Inc. to submit a revised donor
- 3 recognition plan.”.
