

In the Senate of the United States,

June 3, 2013.

Resolved, That the bill from the House of Representatives (H.R. 588) entitled “An Act to provide for donor contribution acknowledgments to be displayed at the Vietnam Veterans Memorial Visitor Center, and for other purposes.”, do pass with the following

AMENDMENT:

Strike all after the enacting clause and insert the following:

1 ***SECTION 1. DONOR CONTRIBUTIONS.***

2 *Section 8905(b) of title 40, United States Code is*
3 *amended by striking paragraph (7) and inserting the fol-*
4 *lowing:*

5 “(7) *DONOR CONTRIBUTIONS.*—

6 “(A) *IN GENERAL.*—*Except as otherwise*
7 *provided in this paragraph, the Secretary or Ad-*
8 *ministrator, as applicable, may permit a spon-*

1 *sor described in subsection (a) to acknowledge*
2 *donor contributions at the commemorative work.*

3 “(B) *REQUIREMENTS.—Acknowledgments*
4 *shall—*

5 “(i) *be displayed inside a visitor center*
6 *or other ancillary structure associated with*
7 *the commemorative work; and*

8 “(ii) *conform to applicable National*
9 *Park Service or General Services Adminis-*
10 *tration guidelines for donor recognition, as*
11 *applicable.*

12 “(C) *LIMITATIONS.—Acknowledgments*
13 *shall—*

14 “(i) *be limited to an appropriate state-*
15 *ment or credit recognizing the contribution;*

16 “(ii) *be displayed in a form approved*
17 *by the Secretary or Administrator;*

18 “(iii) *be displayed for a period of time*
19 *determined by the Secretary or Adminis-*
20 *trator to be appropriate, commensurate*
21 *with the level of the contribution;*

22 “(iv) *be limited to short, discrete, and*
23 *unobtrusive acknowledgments or credits;*
24 *and*

1 “(v) not include any advertising slo-
2 gans or company logos.

3 “(D) SUBMITTAL OF PLAN.—

4 “(i) IN GENERAL.—Prior to the dis-
5 play of donor acknowledgments, the sponsor
6 shall submit to the Secretary or Adminis-
7 trator, as applicable, for approval a plan
8 for displaying the donor acknowledgments,
9 including—

10 “(I) the sample text and types of
11 acknowledgments to be displayed; and

12 “(II) the form and location of all
13 displays.

14 “(ii) NOTIFICATION AND RESUB-
15 MITTAL.—If the Secretary or Administrator
16 does not approve the plan submitted under
17 clause (i), the Secretary or Administrator
18 shall—

19 “(I) not later than 60 days after
20 the date on which the plan is received,
21 notify the sponsor of the reasons the
22 plan is not approved; and

23 “(II) allow the sponsor to resub-
24 mit a revised donor acknowledgment
25 plan.

1 “(E) *COST.*—*The sponsor shall bear all ex-*
2 *penses related to the display of donor acknowl-*
3 *edgments.*

4 “(F) *APPLICABILITY.*—*This paragraph shall*
5 *apply to any commemorative work dedicated*
6 *after January 1, 2010.”.*

7 **SEC. 2. EXTENSION OF LEGISLATIVE AUTHORITY FOR VIET-**
8 **NAM MEMORIAL VISITOR CENTER.**

9 *Section 6(b)(5) of Public Law 96-297 (16 U.S.C. 431*
10 *note; 124 Stat. 2851) is amended by striking “2014” and*
11 *inserting “2018”.*
