## A BILL

To require State child welfare agencies to promptly report information on missing or abducted children to law enforcement authorities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Rilya Wilson Act”.

5 **SEC. 2. REQUIREMENT THAT STATE CHILD WELFARE AGEN-**  
6 **CIES REPORT INFORMATION ON MISSING OR**  
7 **ABDUCTED CHILDREN TO THE NATIONAL**  
8 **CRIME INFORMATION CENTER.**

9 (a) STATE PLAN REQUIREMENT.—Section 471(a) of  
10 the Social Security Act (42 U.S.C. 671(a)) is amended—

11 (1) in paragraph (32), by striking “and” at the  
12 end;

13 (2) in paragraph (33), by striking the period  
14 and inserting “; and”; and

15 (3) by inserting after paragraph (33) the fol-  
16 lowing:

17 “(34) provides that the State has in effect pro-  
18 cedures that require the State agency to promptly  
19 report information on missing or abducted children  
20 to law enforcement authorities for entry into the Na-  
21 tional Crime Information Center database.”.

22 (b) REGULATIONS.—The Secretary of Health and  
23 Human Services shall promulgate regulations to imple-  
24 ment section 471(a)(34) of the Social Security Act, as  
25 added by subsection (a) of this section.

1           (c) EFFECTIVE DATE.—The amendments made by  
2 subsection (a) shall take effect 1 year after the date of  
3 the enactment of this Act, without regard to whether the  
4 regulations required by subsection (b) have been promul-  
5 gated.

6 **SEC. 3. AMENDMENTS TO THE NATIONAL CHILD SEARCH**  
7 **ASSISTANCE ACT OF 1990.**

8           Paragraph (4) of section 3702 of the Crime Control  
9 Act of 1990 (42 U.S.C. 5780) is amended—

10           (1) in the matter preceding subparagraph (A),  
11           by striking “(2)” and inserting “(3)”;

12           (2) in subparagraph (A), by inserting “, and a  
13 recent photograph” after “dental records”;

14           (3) in subparagraph (B), by striking “and”  
15 after the semicolon;

16           (4) by redesignating subparagraph (C) as sub-  
17 paragraph (D); and

18           (5) by inserting after subparagraph (B) the fol-  
19 lowing:

20           “(C) notify the National Center for Miss-  
21 ing and Exploited Children of each report re-  
22 ceived relating to a child reported missing from  
23 a foster care family home or childcare institu-  
24 tion; and”.
