RESOLUTION

Providing for consideration of the bill (H.R. 1549) to amend Public Law 111-148 to transfer fiscal year 2013 through fiscal year 2016 funds from the Prevention and Public Health Fund to carry out the temporary high risk health insurance pool program for individuals with preexisting conditions, and to extend access to such program to such individuals who have had creditable coverage during the 6 months prior to application for coverage through such program.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 1549) to amend Public Law 111-
6 148 to transfer fiscal year 2013 through fiscal year 2016
7 funds from the Prevention and Public Health Fund to
8 carry out the temporary high risk health insurance pool
9 program for individuals with preexisting conditions, and
10 to extend access to such program to such individuals who
11 have had creditable coverage during the 6 months prior
12 to application for coverage through such program. The
13 first reading of the bill shall be dispensed with. All points
14 of order against consideration of the bill are waived. Gen-
15 eral debate shall be confined to the bill and shall not ex-
16 ceed one hour equally divided and controlled by the chair
17 and ranking minority member of the Committee on En-
18 ergy and Commerce. After general debate the bill shall be
19 considered for amendment under the five-minute rule. In
20 lieu of the amendment in the nature of a substitute rec-
21 ommended by the Committee on Energy and Commerce
22 now printed in the bill, it shall be in order to consider
23 as an original bill for the purpose of amendment under
24 the five-minute rule an amendment in the nature of a sub-
25 stitute consisting of the text of Rules Committee Print

1 113-8. That amendment in the nature of a substitute shall
2 be considered as read. All points of order against that
3 amendment in the nature of a substitute are waived. No
4 amendment to that amendment in the nature of a sub-
5 stitute shall be in order except those printed in the report
6 of the Committee on Rules accompanying this resolution.
7 Each such amendment may be offered only in the order
8 printed in the report, may be offered only by a Member
9 designated in the report, shall be considered as read, shall
10 be debatable for the time specified in the report equally
11 divided and controlled by the proponent and an opponent,
12 shall not be subject to amendment, and shall not be sub-
13 ject to a demand for division of the question in the House
14 or in the Committee of the Whole. All points of order
15 against such amendments are waived. At the conclusion
16 of consideration of the bill for amendment the Committee
17 shall rise and report the bill to the House with such
18 amendments as may have been adopted. Any Member may
19 demand a separate vote in the House on any amendment
20 adopted in the Committee of the Whole to the bill or to
21 the amendment in the nature of a substitute made in order
22 as original text. The previous question shall be considered
23 as ordered on the bill and amendments thereto to final
24 passage without intervening motion except one motion to
25 recommit with or without instructions.
