Mr. COLE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the joint resolution (H.J. Res. 75) making continuing appropriations for the Special Supplemental Nutrition Program for Women, Infants, and Children for fiscal year 2014, and for other purposes; providing for consideration of motions to suspend the rules; waiving a requirement of clause 6(a) of rule XIII with respect to consideration of certain resolutions reported from the Committee on Rules; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House any joint resolu-
3 tion specified in section 2 of this resolution. All points of
4 order against consideration of each such joint resolution
5 are waived. Each such joint resolution shall be considered
6 as read. All points of order against provisions in each such
7 joint resolution are waived. The previous question shall be
8 considered as ordered on each such joint resolution and
9 on any amendment thereto to final passage without inter-
10 vening motion except: (1) 40 minutes of debate equally
11 divided and controlled by the chair and ranking minority
12 member of the Committee on Appropriations; and (2) one
13 motion to recommit.

14 SEC. 2. The joint resolutions referred to in the first
15 section of this resolution are as follows:

16 (a) The joint resolution (H.J. Res. 75) making con-
17 tinuing appropriations for the Special Supplemental Nu-
18 trition Program for Women, Infants, and Children for fis-
19 cal year 2014, and for other purposes.

20 (b) The joint resolution (H.J. Res. 76) making con-
21 tinuing appropriations for the National Nuclear Security
22 Administration for fiscal year 2014, and for other pur-
23 poses.

1 (c) The joint resolution (H.J. Res. 77) making con-
2 tinuing appropriations for the Food and Drug Administra-
3 tion for fiscal year 2014, and for other purposes.

4 (d) The joint resolution (H.J. Res. 78) making con-
5 tinuing appropriations for national intelligence program
6 operations for fiscal year 2014, and for other purposes.

7 (e) The joint resolution (H.J. Res. 79) making con-
8 tinuing appropriations for certain components of the De-
9 partment of Homeland Security for fiscal year 2014, and
10 for other purposes.

11 (f) The joint resolution (H.J. Res. 80) making con-
12 tinuing appropriations for the Bureau of Indian Affairs,
13 the Bureau of Indian Education, and the Indian Health
14 Service for fiscal year 2014, and for other purposes.

15 (g) The joint resolution (H.J. Res. 82) making con-
16 tinuing appropriations for the National Weather Service
17 for fiscal year 2014, and for other purposes.

18 (h) The joint resolution (H.J. Res. 83) making con-
19 tinuing appropriations for the Impact Aid program of the
20 Department of Education for fiscal year 2014, and for
21 other purposes.

22 (i) The joint resolution (H.J. Res. 84) making con-
23 tinuing appropriations for Head Start for fiscal year 2014,
24 and for other purposes.

1 (j) The joint resolution (H.J. Res. 85) making con-
2 tinuing appropriations for the Federal Emergency Man-
3 agement Agency for fiscal year 2014, and for other pur-
4 poses.

5 SEC. 3. Upon adoption of this resolution it shall be
6 in order to consider in the House the bill (H.R. 3223)
7 to provide for the compensation of furloughed Federal em-
8 ployees. All points of order against consideration of the
9 bill are waived. The bill shall be considered as read. All
10 points of order against provisions in the bill are waived.
11 The previous question shall be considered as ordered on
12 the bill and on any amendment thereto to final passage
13 without intervening motion except: (1) 40 minutes of de-
14 bate equally divided and controlled by the chair and rank-
15 ing minority member of the Committee on Oversight and
16 Government Reform; and (2) one motion to recommit.

17 SEC. 4. The requirement of clause 6(a) of rule XIII
18 for a two-thirds vote to consider a report from the Com-
19 mittee on Rules on the same day it is presented to the
20 House is waived with respect to any resolution reported
21 through the legislative day of October 21, 2013.

22 SEC. 5. It shall be in order at any time through the
23 calendar day of October 20, 2013, for the Speaker to en-
24 tertain motions that the House suspend the rules as
25 though under clause 1 of rule XV. The Speaker or his

- 1 designee shall consult with the Minority Leader or her des-
- 2 ignee on the designation of any matter for consideration
- 3 pursuant to this section.
