Mr. WEBSTER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

# RESOLUTION

Providing for consideration of the bill (H.R. 3080) to provide for improvements to the rivers and harbors of the United States, to provide for the conservation and development of water and related resources, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 3080) to provide for improvements

1 to the rivers and harbors of the United States, to provide  
2 for the conservation and development of water and related  
3 resources, and for other purposes. The first reading of the  
4 bill shall be dispensed with. All points of order against  
5 consideration of the bill are waived. General debate shall  
6 be confined to the bill and shall not exceed one hour equal-  
7 ly divided and controlled by the chair and ranking minor-  
8 ity member of the Committee on Transportation and In-  
9 frastructure. After general debate the bill shall be consid-  
10 ered for amendment under the five-minute rule.

11 SEC. 2. (a) In lieu of the amendment in the nature  
12 of a substitute recommended by the Committee on Trans-  
13 portation and Infrastructure now printed in the bill, it  
14 shall be in order to consider as an original bill for the  
15 purpose of amendment under the five-minute rule an  
16 amendment in the nature of a substitute consisting of the  
17 text of Rules Committee Print 113-24. That amendment  
18 in the nature of a substitute shall be considered as read.  
19 All points of order against that amendment in the nature  
20 of a substitute are waived.

21 (b) No amendment to the amendment in the nature  
22 of a substitute made in order as original text shall be in  
23 order except those printed in the report of the Committee  
24 on Rules accompanying this resolution and amendments  
25 en bloc described in section 3 of this resolution.

1       (c) Each amendment printed in the report of the  
2 Committee on Rules shall be considered only in the order  
3 printed in the report, may be offered only by a Member  
4 designated in the report, shall be considered as read, shall  
5 be debatable for the time specified in the report equally  
6 divided and controlled by the proponent and an opponent,  
7 shall not be subject to amendment, and shall not be sub-  
8 ject to a demand for division of the question in the House  
9 or in the Committee of the Whole.

10       (d) All points of order against amendments printed  
11 in the report of the Committee on Rules or amendments  
12 en bloc described in section 3 of this resolution are waived.

13       SEC. 3. It shall be in order at any time for the chair  
14 of the Committee on Transportation and Infrastructure  
15 or his designee to offer amendments en bloc consisting of  
16 amendments printed in the report of the Committee on  
17 Rules accompanying this resolution not earlier disposed of.  
18 Amendments en bloc offered pursuant to this section shall  
19 be considered as read, shall be debatable for 10 minutes  
20 equally divided and controlled by the chair and ranking  
21 minority member of the Committee on Transportation and  
22 Infrastructure or their designees, shall not be subject to  
23 amendment, and shall not be subject to a demand for divi-  
24 sion of the question in the House or in the Committee  
25 of the Whole. The original proponent of an amendment

1 included in such amendments en bloc may insert a state-  
2 ment in the Congressional Record immediately before the  
3 disposition of the amendments en bloc.

4       SEC. 4. At the conclusion of consideration of the bill  
5 for amendment the Committee shall rise and report the  
6 bill to the House with such amendments as may have been  
7 adopted. Any Member may demand a separate vote in the  
8 House on any amendment adopted in the Committee of  
9 the Whole to the bill or to the amendment in the nature  
10 of a substitute made in order as original text. The previous  
11 question shall be considered as ordered on the bill and  
12 amendments thereto to final passage without intervening  
13 motion except one motion to recommit with or without in-  
14 structions.
